Quorum was met.

Wild River Shooters: 6 kids; 6-10 kids a night average.

Don: Distributed info sheet about the Masonic Lodge shoot on June 21st from 9 AM to 1 PM. Stated there would be work on the Pistol Range on Monday and work to be done on the High-Power Range and ditch work repaired. Electrical problems/septic out – work was done on them – working again.

Committees: By-Law committee are holding off work.

Old Business: Air Soft

Have \$9000 in lumber for buildings ready to go. Much discussion – portable units to be taken down so Archers can use the 15-acre range. Discussed the Poison Oak problem.

Larry Sheely made a MOTION to spend up to \$1000 to spray the Poison Oak. 2nd was made by Christine Lowe. Vote: 12 Yes/0 No/0 Abstain. PASSED.

Discussion regarding the reserving and use by Air Soft. If they reserve it and cancel at 11 AM, it's too late to arrange for others to pull together a shoot and use the range

Chris Bain made a MOTION/ 2nd by Mike Cent to refund the \$120 day use in the future. Vote: 7 Yes / 5 Abstain. PASSED.

John Pullin wanted to know if there was a set amount of ammo to be used for each shooter for the Masonic shoot. For them, 250 rounds would be 41 people. Don reported up to 8 Masonic Lodges were being invited. More discussion about how many shots to allow per person.

New Business:

Larry Sheely announced the 4H Archers, ages 9 to 18 had been out to practice. 7 of 10 qualified to go to the State competition in Albany.

A Letter from JCSA's Attorney was shown and read. No discussion.

John Pullen made a MOTION to end the Meeting. 2nd by Don Ledbetter. Vote unanimous.
