Directions and General Recommendations

AMERICAN HUMA can be applied via SOIL, DRIP & FOLIAR APPLICATION in conjunction with a balanced plant nutrition program
 Soil Application: 4-10 lbs per acre
 Foliar Application: 1-7 lbs per acre
 Drip Irrigation: 4-9 lbs per acre
 Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.
