Directions and General Recommendations

FOLIAR APPLICATIONS: Use at least 100 parts water to 1 part ELEMENTUS. Add at least 100 parts water before introducing product.

FIELD AND VEGETABLE CROPS: Apply 0.5 - 1.5 quarts per acre.

FRUIT, NUT & VINE CROPS: Apply 0.5 - 1.5 quarts per acre.

NOTE: Before applying to pome or stone fruit, consult your qualified and licensed consultant for recommendations.

GRAIN CROPS: Apply 0.5 - 1.5 quarts per acre at 3-4 leaf stage. TURF GRASSES: Apply 0.5 - 1.5 quarts per acre.

SPRINKLER IRRIGATION: Apply 1 - 3 quarts per acre with irrigation

SOIL APPLICATION RATES: Use at least 20 parts water to 1 part ELEMENTUS. Do not apply directly to seeds unless it has been determined/tested by the consultant or grower that it is not harmful or injurious to the seed.
