SOLUBLE SEAWEED EXTRACT POWDER FOR SOIL AND FOLIAR APPLICATION

GENERAL USE: Apply 2 lbs. per acre per growing season. Apply the first application when there is sufficient foliage for absorption, the second application before bloom, the third application at bloom.

Promotes plant growth and provides potassium that is readily available for plant use. Suitable for all plants grown in the greenhouse, landscape,

ROOT INJECTIONS: One (1) lb. to 100 gallons. Insert into soil to a depth of 10-12 inches and spaced three feet apart (around the drip line).

SEED TREATMENT BEFORE PLANTING: Wet thoroughly in a solution of 1:100. Allow seeds to dry before planting.

TRANSPLANTING: Apply 1/6 lb. (2.7 oz.) to 50 gallons. The same plant can also be dipped in solution of 1:100 before planting.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.

Always jar test new combinations for compatibility prior to field mixing.
