

Organization Participant Waiver, Release, Indemnification of All Claims & Covenant Not to Sue

By signing this agreement, you give up your right, and the right of any athletes in your care, to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of yours and their participation in practices or games at the Shawnee Sports Complex, now or at any time in the future.

Acknowledgment of Risk

I hereby acknowledge and agree that participation activities at the Shawnee Sports Complex comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with practices, games, and other activities at the Shawnee Sports Complex, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with activities on the Shawnee Sports Complex and that said list in no way limits the operation of this Agreement.

Initial

In consideration of my participation, and the participation of my team, in practices, games, or other activities, I, the undersigned participant, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my, and my teams, participation in activities at the Shawnee Sports Complex.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in participation in activities at the Shawnee Sports Complex and that I am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, I sustain while participating in activities at the Shawnee Sports Complex and that by signing this agreement I HEREBY RELEASE Releasees from all liability for such loss, damage, or death. I further certify that I, and my athletes, are in good health and that I, and my athletes, have no conditions or impairments which would preclude my safe participation in athletic activities.
