

Rules & regulations for Erection of Temporary Structure/Pandal for Durga Puja-2022

1. Land documents
2. No objection certificate from respective Police station.
3. Site plan of Puja Pandal as per requirement
4. Government License Holder with valid license number to be appointed for electrification of Puja Pandal.
5. Separate ENTRANCE/EXIT shall be provided.
6. Enough space for movement of Fire tender shall be maintained.
7. No open flame can be used within 600 Feet from the Pandal,
8. Fire Retardant Solution to be used for Decorative clothes.
9. Provision of sufficient water, Fire Extinguishers, Ceiling Hook, Ladder and sand Bucket to be kept ready in the Pandal.
10. Pandal height and width of the gate shall be minimum 14 ft and 12 ft respectively.

DECLARATION

We, hereby declare that we shall abide by the following rules and regulation for Social security and safety in all respect and on behalf of the Puja Committee.

1. Govt. License holder Electric Contractor with valid license number will be appointed for the electrification of Puja Pandal.
2. Separate **Entrance and Exit** for covered Puja Pandal shall be provided.
3. Enough space for movement of Fire & Emergency Service Vehicles shall be maintained.
4. Width and height of the gate shall be minimum 12 ft. and 14 ft. respectively and height of the superstructure shall not be more than 40 ft.
5. No open flame can be used within 200 yards from Pandal and No cooking arrangement would be allowed within such radius.
6. Use of highly inflammable materials for erection of the Pandal is discarded .
7. Clothes used to the Pandal to be dipped in Fire Retardant Solution.
8. Provision of sufficient water for the fighting which shall not be less than 0.75 Ltrs. per Sq. Mtrs. of floor area for each pandal/structure and I.S.I., marked appropriate Fire Extinguisher @ minimum 2(two) per 1000 sq. ft. floor area, two nos. ceiling hook, ladder and sand bucket to be kept ready in the Pandal for fighting the small fire.
8. There must be a **4 (four) feet** clear open space from the property line of any building, boundary wall or any other permanent structure as per judgement of Hon'ble High Court, Kolkata vide W.P. No. - 856 of 2009 dated 15.09.2009.
