Administrative Operations is also responsible for developing and implementing education and training for all subordinate units; most notably the Commander's, Quartermaster's, and Trustee's Guides.







## Appeals



All appeals under Section 109 of the National Bylaws must be written and adjudicated by the next higher authority.

- Post and/or Post Commander
- District Commander
- Department Commander
- Commander-in-Chief
- National Council of Administration

# Appeals



A written appeal must contain these four provisions:

- 1) Describe the act or decision from which the appeal is taken, and the manner in which the matter at issue has been handled
- 2) State all facts known to the member concerning the matter at issue.
- 3) Specify the provision or provisions of the Charter, Bylaws, Manual of Procedure, Ritual or the laws or usages of Veterans of Foreign Wars of the United States which the act or decision violates or contradicts.
- 4) State the relief requested by the member.

# Appeals



A written appeal has time constraints.

- 30 days from the act or decision from which the appeal is taken
- Mailed
  - Registered or certified mail
  - Return receipt requested
  - Postmarked no later than the due date

# Department Inspections



The mission of National Inspection Team is to mentor, educate, correct deficiencies, and bridge gaps in institutional knowledge in order to help Departments and their officers identify, address, and correct shortcomings in their operations before those shortcomings become systemic issues.

# Department Inspections



Items being reviewed will include, but not limited to the last three years of (subject to the committee's discretion):

- Post Records (Election Reports, Quarterly Audits, and additional Correspondence Files)
- Financial Reports & Committee Reports to the Council of Administration/Convention; to include all meeting minutes/proceedings (Department)
- VFW and Independent Audits
- Checkbooks
- Bank Statements
- Credit Card Statements
- Investment Statements
- Time Cards or Equivalent
- Leave Policy (past and present)
- All Standard Operating Procedures (SOP's), Bylaws, Office Policies
- 990's and 990T's
- All Ledgers
- Bank and Investments Authorizations (who can make withdraws)
