FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND EASEMENTS OF LIBERTY, A SUBDIVISION IN SARPY COUNTY, NEBRASKA

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS is made on the date hereinafter set forth by LIBERTY LAND, LLC, a Nebraska limited liability company, hereinafter referred to as "Declarant".

WHEREAS, Declarant is the owner of certain real estate hereinafter referred to as the "Properties" in the County of Sarpy, State of Nebraska, described as follows:

Lots 94 through 170, inclusive, in Liberty, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska;

and

Lot 1 and Outlot A, in Liberty Replat One, a subdivision as surveyed, platted, and recorded in Sarpy County, Nebraska;

And

WHEREAS, pursuant to the terms and conditions of Article V, Section 2 of the Declaration, Declarant is desirous of subjecting the Properties to the easements, restrictions, covenants and conditions for use set forth in the Declaration for the purpose of protecting the value and desirability of the Properties.

NOW THEREFORE, Declarant hereby declares that all of the Properties shall be held, sold and conveyed subject to the easements, restrictions, covenants and conditions set forth in the Declaration as if same had been included at the time of the execution and filing of the Declaration. The Properties now being included in the Declaration shall be subject to all of the time periods referenced in the Declaration in the same manner as if they had originally been included in the Declaration. It is the intent hereof that the Properties shall be considered to have been covered by the Declaration from the time of its filing to allow for continuity among all of the Lots covered by the Declaration.
