Description of necessary first aid measures

Eye contact

It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Skin contact

Methods and materials for containment and cleaning up

Small spill
