SECTION 4) FIRST-AID MEASURES

Inhalation

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Emergency Procedure

Skin Protection

Always seek advice from glove suppliers. Contaminated gloves should be replaced.
