

**A RESOLUTION OF THE WEST SANGAMON PUBLIC LIBRARY DISTRICT  
DETERMINING PREVAILING WAGE RATES**

WHEREAS, the "Prevailing Wage Act," approved June 26, 1941, as amended (820 ILCS 130/0.01 et seq, 2016 State Bar Edition), requires the Board of Library Trustees of the West Sangamon Public Library District to investigate and ascertain prevailing wage rates as defined in the Act for laborers, mechanics and other workers in the locality of the Library District employed in the construction of public works for the Library District.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF LIBRARY TRUSTEES OF THE WEST SANGAMON PUBLIC LIBRARY DISTRICT:

**SECTION ONE:** To the extent and as required by the "Prevailing Wage Act," the general prevailing wage rates in this locality for laborers, mechanics and other workers employed in the construction of public works coming under the jurisdiction of the West Sangamon Public Library District are hereby ascertained to be the same as the prevailing wage rates for construction work in Morgan and Sangamon Counties as determined by the Illinois Department of Labor as of September 1, 2017, a copy of those determinations being attached hereto and incorporated herein by this reference. The definitions of any terms appearing in this Resolution which are also used in the aforesaid Act shall be the same as in the Act.

**SECTION TWO:** Nothing contained herein shall be construed to apply the general prevailing wage rates as herein ascertained to any work or employment except public works construction of the Library District to the extent required by the aforesaid Act.

**SECTION THREE:** The Library District's Secretary shall:

(i) publicly post or keep available for inspection by any interested party in the main office of the Library District this determination of such prevailing wage rates;

(ii) mail a copy of this determination to any employer, any association of employers, any person, or association of employees, that has filed a name and address, requesting a copy of any determination stating the particular wage rates and the particular class of workers whose wages will be affected by such rates;

(iii) promptly file a certified copy of this Resolution with both the Secretary of State and the Department of Labor of the State of Illinois; and

(iv) cause to be published in a newspaper of general circulation within the Library District a notice of the adoption of this Resolution, and such publication shall constitute notice that the prevailing wage rates determination is effective and that this is the determination of the West Sangamon Public Library District.

**SECTION FOUR:** This Resolution shall be in full force and effect from and after the date of its adoption, by a favorable vote of the Board of Library Trustees of the Library District, and approval and publication in the manner provided by law.
