The Fiscal Year 2018 ending balance of combined amounts was \$19,823.00.

The Prevailing Wage Ordinance was presented and briefly discussed. June Atkinson made a motion to accept the ordinance as presented and Linda Orr seconded. The motion passed.

The fully-updated list of the By-Law was distributed with highlighted changes that were made at the last meeting. It was briefly discussed. It was approved at the last meeting.

The Fiscal Year 2019 tentative budget was presented and discussed. June Atkinson made a motion to accept the budget as presented and Linda Orr seconded. The motion passed by a roll call vote.

Director's Report:

An estimate for roof repairs from Henson Robinson was presented and discussed. At least one more bid is expected.

The Summer Reading program "Reading Takes You Everywhere" opened with sidewalk painting. Ninety-three participants signed up. The program ends July 20.

The New Berlin Area Community Development League (NBACDL) was thanked for cleaning up the parking lot, trimming bushes, and pulling weeks during the community clean-up day on June 9. Neighbor Greg Morris was thanked for the water to power wash the parking lot.

New Business:

June Atkinson suggested a "shower for the library" for contributions of paper products, and other consumable items. Director Benanti will make a list of items. This is a project that the Friends could undertake next spring.

Brian Bandy will register with the bank to be able to sign checks when the Treasurer or other co-signers are unavailable.

Election of officers was held. Bob Barth and Martha Darling will not be running for another term in the 2019 General Election.
