GENERAL REGULATIONS

(For the conduct of competitions at Queensland Ag Shows affiliated Queensland Agricultural Shows)

Subject to the Rules, By-Laws and Regulations of the Queensland Chamber of Agricultural Society's Inc. (Queensland Ag Shows) and the society relevant to this schedule (Fraser Coast Agriculture Show Society Inc.), the following regulations shall apply. Where there is a conflict between these regulations and the regulations and the rules of the local Agricultural Society, (Fraser Coast Agriculture Show Society Inc.), the rules of the Affiliated Agricultural Society prevail.

GENERAL REGULATIONS AND ACCEPTANCE OF ENTRIES

- The attention of Exhibitors is drawn to the fact that entries are accepted subject to the Rules, By-Laws and Regulations of the Queensland Ag Shows and the Fraser Coast Agriculture Show Society Inc. in addition to any Special Regulations which appear in this schedule. Copies of the Rules and By-Laws may be obtained the Queensland Ag Shows website <u>www.queenslandshows.com.au/competitions</u> or the show society relevant to this schedule (Fraser Coast Agriculture Show Society Inc.)
- 2. These By-Laws and Regulations, together with Special Regulations and notes as set forth in the respective sections of the Competition Schedules or Catalogues, are to be the conditions of competition. In these By-Laws, the Regulations, the Special Regulations and notes the words "entry form" shall, unless the context otherwise indicates or requires mean the form supplied by the Show to persons desiring to apply to enter an Exhibit in any of the Show's competitions or to compete in any event which those persons are required to complete and lodge with the Show in order to apply to do so.
- 3. Subject to this by-Law and to any Regulation, Special Regulation or condition of Entry in any section or class (a) An Exhibit must be the bona fide property of the person who enters the Exhibit or class.
- 4. In any class in which entries are accepted from a club or other groups of Owners, the name of the club or particulars sufficient to identify the group shall be stated on the Entry Form together with a statement of the name and address of a person who is authorised to act on behalf of the club or group in relations to all matters relating to the entry. The Show shall be entitled to deal with the person so authorised as if he were the sole Owner of the Exhibit and delivery or payment to that person or the club or group by whom such person is authorised to act of any trophy prize or moneys won by or payable in respect of the Exhibit shall be a complete discharge to the Show.
- 5. Entries entered in the wrong class by the Exhibitor/Competitor may be transferred to the proper class by the Chief Stewards.
- 6. In the case of insufficient numbers being nominated or shown in any class, the society retains the right suspend classes at any time. The section Chief Steward retains the right to reduce prize money where classes are not sufficiently patronised.
- 7. The Fraser Coast Agriculture Show Society Inc. is operating under the Queensland Ag Shows and the Maryborough Showgrounds & Equestrian Park covid safe plan. You must adhere to COVID safe key principles that apply to Maryborough Showgrounds & Equestrian Park and the Fraser Coast Agriculture Show Society Inc.

JUDGING

- 8. Judging will be performed by a Judge or panel of Judges appointed by the Fraser Coast Agriculture Show Society Inc.
- 9. In all affiliated Agricultural Show Sections, Judges should not judge the same section within a two (2) year period of the same show.
- 10. An exhibitor shall not compete in a section if the Exhibitor is a member of the Judge's immediate family.
- 11. Any person causing a nuisance by loud comments, or the decision of the judge or otherwise unseemly behaviour will, after being cautioned, be expelled from the judging area and in the case of exhibitors, be liable for disqualification.
- 12. All Judges and Stewards who accept engagements with Queensland Ag Shows and Show Societies must follow the rules set in the Code of Practice and Conduct Show Judges and Stewards document obtained from the Qld Ag Shows website <u>www.queenslandshows/competitions</u> or the show society relevant to this schedule (Fraser Coast Agriculture Show Society Inc.)

NOTICE TO INTENDING EXHIBITORS

- 13 Entries for the upcoming Fraser Coast Agriculture Show can be made as described for each section in this schedule. Entries submitted other than on the correct form or online will be returned to the Exhibitor and, unless all requirements are complied with, and the forms returned to the Fraser Coast Agriculture Show office by completion of business on the closing date, as shown in this Schedule, they will not be considered.
- 14 Notwithstanding the provisions of General Regulation 6, late entries may be accepted at the discretion of the Section Chief Steward.
- 15 Entries are accepted subject to the Rules, By-Laws and Regulations of the Society, in addition to any Special Regulations, which appear in the Schedule. All completed Entry Forms remain the property of the Fraser Coast Agriculture Show Society Inc. and are to be returned to the Fraser Coast Agriculture Show Society Inc. office after the Show for further office procedures as required.
- 16 Exhibitors whose entries have not been accepted shall be advised accordingly and entry fees refunded.
- 17 The Exhibitor must complete the Exhibitor's Declaration on the Application for Entry. Queensland Ag Shows recommends that the Exhibitor seeks professional advice before completing the Exhibitor Declaration.

18 The exhibitor irrevocably consents to the Society publishing or reproducing in any manner whatsoever any particulars or information in relation to their exhibits; the publication or reproduction may be in a printed form or visual image through electronic means and/or on the internet.

PRIVACY STATEMENT

19 The information provided by Exhibitors is used by the Queensland Ag Shows and the Fraser Coast Agriculture Show Society Inc. to organise, process and conduct competitions at the relevant agricultural show (Fraser Coast Agriculture Show), sub chamber and state finals. By entering such competitions, you consent to your personal information being used for this purpose including this information being made available to sponsors, breed Associations, the media, the public, promotional purposes, archival purposes, published in publications and could be made available to other third parties for the purpose of promoting the Queensland Agricultural Show movement, or as otherwise required by law. Queensland Ag Shows and the Fraser Coast Agriculture Show Society Inc.have the right to take or use photographs of exhibits or exhibitors (and or property) and use photos in any or all marketing and media worldwide including online, now and in the future. Exhibitors have a right of access to and alteration of personal information concerning themselves in terms of the Privacy Act. This may be done by contacting Queensland Ag Shows.

WORKPLACE HEALTH AND SAFETY

- 20 All Queensland Ag Shows affiliated Society's Showground's are designated workplaces within the meaning of the Workplace Health and Safety Act 2011 and exhibitors / competitors are required to ensure that they and all persons under their direction or control, including their contractors or subcontractors, comply with all requirements of the Act and Queensland Ag Shows holds each exhibitor responsible to discharge its obligations to provide and maintain a safe place and system of work during occupation by the exhibitor/competitor of any area of the affiliated Agricultural Society's Showground's.
- 21 Each exhibitor/competitor will assess the risk to themselves, staff, volunteers, family, other exhibitors, Agricultural Society staff, show visitors, children and any person foreseeably affected by the presentation of their exhibit.
- 22 Risks identified by exhibitors/competitors will be eliminated or controlled by the exhibitor/competitor and particular attention will be paid to ensuring public safety and safety of other exhibitors/competitors.
- 23 Exhibits will only be held and handled by competent persons whose experience is known to the Exhibitor/Competitor.
- 24 A "No Smoking Policy" will be strictly adhered to by exhibitors/competitors. Smoking areas are marked in "ORANGE MARKINGS/FLAGS" which are located near the Cane & Cattleman's Bar & far end of Working Heritage display.. No food or drink is allowed in the smoking area. The exhibitors/competitors are advised that the use of Primus stoves, any heating or lighting appliances of a like character, or any naked light, is strictly prohibited in pavilions.
- 25 Any exhibitors/competitors intending to bring electrical equipment to the Showground's will be required to ensure that such equipment is fitted with earth leakage circuit breakers/residual current protection and that all electrical leads, tools and appliances have been inspected by a licensed electrical contractor and currently tagged. The use of double adaptors is prohibited as well as all power boards must also be tested and tagged. This is essential for the safety of all exhibitors and the general public and is a requirement of the current Electrical Safety Regulations.
- 26 All exhibitors/competitors will comply with the requirements of the Act and its Regulations and Standards in every other respect. This is essential for the safety of all exhibitors/competitors and the general public. The Act imposes very severe penalties in the event of noncompliance with its provisions. Any exhibitors/competitors who do not comply will not be allowed to exhibit at QCAS affiliated Shows.

DISCLAIMER

27 The information contained in the Competitions Schedule is gathered for the purpose of providing information to Exhibitors and show patrons. The information is a compilation of information provided by third parties and the QCAS. and affiliated Agricultural Society's does not warrant its accuracy and advises that any such information may be subject to change or amendment occurring at any time and thereby making the information incorrect. Subject to the QCAS legal obligations and responsibilities if you require confirmation of any information, please contact the QCAS Office.

PRIZES AND GST

- 28 The Australian Taxation Office has deemed that GST is payable on prizes if an Exhibitor is registered for GST and enters an Exhibit as part of a business enterprise.
- 29 The information an Exhibitor provides on the Application for Entry determines whether GST is applicable.
- 30 Any prize stated in this Schedule does not include GST.
- 31 GST will not apply:
 - (a) If an Exhibitor enters an Exhibit as a hobby or private recreational pursuit; or
 - (b) If an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor has an ABN, but the Exhibitor is NOT REGISTERED for GST.
 - (c) If an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor is not entitled to an ABN as the business or enterprise is not operating in Australia.
- 32 GST will apply if an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor has an ABN, and the Exhibitor is REGISTERED for GST.
- 33 Where GST applies, the Society will pay the prize money quoted in this Schedule plus 10% GST. The Society will issue a recipient created tax invoice.
- 34. All cash prizes, sashes, cards and trophies etc. must be claimed within 4 weeks from the closing date of the show. Prizes not claimed will become a donation to the Fraser Coast Agriculture Show Society.

BIOSECURITY: ALL EXHIBITORS MUST HAVE A JBAS OF 6 OR HIGHER. PLEASE NOTE: A COPY OF THE BIOSECURITY PLAN IS LISTED IN DOCUMENTS ON FRONT PAGE OF SHOWDAY FRASER COAST AND ON THE FRASER COAST AG SHOW SOCIETY WEBSITE.

1. Online Entries for 2024 Schedules to be entered and paid online, go

https://showday.online/show/frasercoast, go to top right hand corner and create an account and password, and login. (This account can be used at any Show that uses Showdayonline - keeps an online record of all shows you attend), scroll down, on the right hand side, select Stud Cattle red arrow to enter, select entrant name (your name), create or select exhibit name (animal name) fill in details, then place entries . A number of fields will appear on the right hand side of the screen for each animal, (inc. pairs/progeny etc). All fields to be filled in for entry to be accepted. Continue to add classes and accept terms and conditions and pay by credit card. An email confirmation will be sent to you. Bring a printed or electronic copy of your entries to the Showgrounds for 24/05/2023.

2. ENTRIES close Friday 17th May 2024.

ENTRY FEES are \$11.00 (inc. GST) per entry for all Classes. The entry fee includes all bedding material (pine sawdust) supplied by the Fraser Coast Agriculture Show Society.
 PRIZE MONEY – The FCASS will pay cash in an envelope when handing out the ribbon at the time of judging.

5.Animal Health Declaration Forms MUST be handed to the Steward on arrival. This is available on the documents tab of Showday online, to be printed and taken to the Showgrounds. No electronic copies accepted.

6. The age of the cattle to be the actual age on 1st May 2024, date of birth is to be shown on entry form.

7. All cattle are to be on Maryborough Showgrounds & Equestrian Park by 8.00am Thursday 23rd May 20124. Judging commences 10.00am Thursday 24th May 2024.

8. ALL CATTLE TO BE REGISTERED IN THE HERD BOOK OR CALF REGISTER OF THE RESPECTIVE BREED SOCIETY (PROOF OF REGISTRATION TO BE SUPPLIED ON REQUEST IF REQUIRED).

9. Exhibitors are to state on their entry form, the number of Classes in which they intend to compete and full particulars of each animal i.e. Name in full, Date of Birth, Breed, Herd Book Number, Stud Name, NLIS number and Address.

10. All cattle are to be the bona fide property of the exhibitor at least three (3) months prior to Friday 17th May 2024.

11. The responsibility for the accuracy of description and pedigree, and for the eligibility of each animal, rests solely with the exhibitor.

12. Any animal, which in the opinion of the Stewards, is not in a fit state to be exhibited, may be rejected by them and banned from competing in this Section.

13. It is preferred by the Committee that all handlers presenting cattle to the Judges in the show ring wear a white dust coat or a breed approved uniform.

14. All cattle to remain on the Showgrounds until 4.00pm Friday 24th May 2024.

15. The Stewards have full control of the parade of cattle for judging and the right to limit the number of entries in a particular class. All reasonable care will be taken, but the Stewards and/or Show Society will not be responsible for any loss or injury to exhibits under control of the Stewards.

16. All animals must be free from ticks and dehorned or polled.

17. No dispute will be considered whilst the event is in progress.

18. Protests to be lodged in writing within thirty (30) minutes after the Class in dispute is completed and must be handed to the Show Office accompanied by a fee of \$50.

19. The dispute committee will consist of the following Stewards and their decision will be final. Any three (3) members to act: Francis Smith, Malcolm Beresford, Lesley Smith, Brian Carter, Greg Jacobsen, Hayden Beresford and Brian Dodd.

20. Vehicles must be removed to the gazetted parking area as directed by Stewards. Vehicles not moved when requested will be towed away to the appropriate parking area at the owner's expense.

21. The NLIS reading time will be 6.00pm on Thursday, 23rd May, 2024. All cattle are to be in their stalls at this time. All Exhibitors must hand a paper copy of their NVD to Stewards. NVD's ONLY ACCEPTABLE. **No Waybills.**

22. BARBECUE (Cattlemen's BBQ) - There will be a Barbecue held at the Stud Cattle Section, at a price of \$10.00 per burger for all Stud Cattle exhibitors on Wednesday night 22nd May, 2024 at 6.30pm. You will need to do an entry for each person wanting the BBQ Stud Cattle Class for catering purposes. This is to be booked online only at Class 4044 BBQ Stud **Cattle RIZE MONEY** – The FCASS will pay cash in an envelope when handing out sashes / ribbons at the time of judging.

24. VEHICLE PASSES – Gate 5, Showgrounds Road, will be issued for Members and Cattle Exhibitors to be collected from the Stud Cattle Steward by 22/05/24. From 23/05/24 A Gate 5 pass will be available at Gate 5 when you pick up your paid OR membership entry passes or from Cattle Steward if prior arrangements made. You must have the pass on you at Gate 5 when you enter the Showgrounds or entry will be refused.

25. TICKS – Spraying of tick free cattle is the responsibility of the owners to ensure that the cattle are sprayed before entering their property.

26. EXHIBITORS are required to pay a Bond of \$30.00 which will be refunded if their cattle stalls are left in a clean condition when they leave the stalls. Please provide name and bank details in Bond Stud Cattle Section when booking. No Cash refunds.

27. CAMPING – Camping \$11 per night, per vehicle, per site. Camping details Vehicle/Site Size/Arrival & departure date must be filled in when booked in Stud Cattle Section Camping, these fields are on the right hand side when you book at Class 4045. Camping passes will be available at Gate 5 on arrival or from Stud Cattle Steward prior to event.

28. GATE ENTRY PASSES – The FCASS has discounted Gate Entry Fees for all exhibitors being either a two (2) day pass or a single (1) day pass. These are available online at Stud Cattle Entry section. If the Gate Entry Passes are not included with your booking the full price at the Gate will apply at Gate 5 upon entry.

29. The FCASS's Honorary Vet is Dr. Clare Condos. If you require the services of the Society's Honorary Vet please contact the Show Office.

NATIONAL CATTLE HEALTH DECLARATION EXPLANATORY NOTES

OVERVIEW

The Cattle Health Declaration is a legal document. Please complete accurately before signing.

Cattle Heath Declarations are a way for producers to provide information about the health status of the cattle they are selling. Buyers should ask vendors for a Declaration and use the information provided to determine the health risks associated with the animals on offer.

Some states/territories require testing or certification additional to that outlined in this document e.g. Johne's disease (JD) in WA and for Enzootic Bovine Leucosis (EBL) in Tasmania. Please check the entry requirements for any interstate movements at:

The original of this form is to be attached to the National Vendor Declaration (NVD) form accompanying the cattle, if applicable. A duplicate remains with the vendor; it is recommended the vendor retains a copy of this declaration for seven (7) years.

TREATMENTS & VACCINATIONS

Provide details on any cattle treatments in the last six (6) months and vaccinations within the last twelve (12) months.

Some manufacturers include more than one of the categories listed in the same vaccine, known as a combination vaccine. If you use a combination vaccine, each agent(s), as appropriate, should be detailed.

For vaccinations to be current, you must have followed the manufacturer's recommendation for vaccination. Typically, young animals or first time vaccinated animals need two (2) doses, followed by annual boosters. As variations to this general rule do occur (e.g. Silirum is given once only), you must use the manufacturer's recommendations.

At the date the declaration is made and as a result of the vaccination(s) given, the animals are considered protected from the diseases marked as treated.

QUESTION 3: PESTIVIRUS TESTING

Persistently infected animals can be detected by conducting a pestivirus antigen test. This test only needs to be conducted once in an animal's life. Cattle that test positive in most cases are persistently infected animals. Pestivirus antibody testing may be done to check the pestivirus status of the herd. Contact your veterinarian for assistance.

QUESTIONS 4, 5 & 6: JOHNE'S DISEASE BEEF CATTLE

Note: JD is a notifiable disease, so it is important to answer these questions.

Occurrence of JD refers to clinical disease in the herd or on the property(s). Clinical disease is an infected animal with chronic diarrhoea and weight-loss that does not respond to treatment.

The **Johne's Beef Assurance Score** (J-BAS) is a voluntary tool developed for JD risk profiling. Details are available at <u>www.animalhealthaustralia.com.au/jd-cattle-tools</u>. The J-BAS is an initial guide and purchasers should ask for more information about JD in the origin herd (see the JD in Cattle Biosecurity Checklist on the 'JD in cattle' webpage). The National Farm Biosecurity Reference Manual - Grazing Livestock Production provides a template to use for the property biosecurity plan. All plans should include the JD in Cattle Biosecurity Plan Checklist.

Check test – testing of 50 adult animals in the herd (or all eligible animals in a herd if less than 50 adult animals) biased to increase the probability of detecting infection, tested by (pooled) faecal culture or (pooled) HT-J faecal PCR. An ELISA test is available but is not recommended and also not accepted for entry of cattle to WA.

Sample test – screening of the adult herd or a large representative sample of the adult herd by an approved test (pooled) faecal culture or (pooled) HT-J faecal PCR. See note above for ELISA test.

Grazing of non-bovine species – Buyers of cattle from this consignment may consider the grazing of other JD-susceptible species (sheep, goats, alpacas) on the source property as important to their risk-management decisions. These buyers are entitled to seek information on how you have managed disease risks for all your livestock.

BIOSECURITY FOR FRASER COAST AG SHOW

Working together for Animal Health:

In order to protect the welfare of animals attending the Fraser Coast Agriculture Show the following procedures are in place to ensure the safety of both our Competitors and their animals:

- All livestock entering the grounds should be from properties actively practicing good biosecurity
 principles to the best of their abilities.
- Animal/s demonstrating signs of disease or contamination will not be allowed to enter the grounds.
- Animal health declaration forms will be required from all livestock owners. Biosecurity Animal Health Declaration/Movement Record must be handed to the Chief Steward and signed by the owner or person in charge of delivery upon the animals arrival to the showgrounds, Biosecurity Animal Health Declaration/Movement Records must not be sent in to the Show Office with entry/nomination forms.

There are two health declaration forms for the Fraser Coast Agriculture Show available from our website or the show office.

- Horse Health Declaration Form
- Biosecurity Animal Health Declaration / Movement Record

All animals entering these showgrounds must comply with the health requirements detailed in the health declarations.

The Fraser Coast Agriculture Show Society has implemented the following:

- A veterinarian will be on call during the event
- A method of making emergency phone calls or alternative communication will be place
 Entertainers; Chief Stewards; Directors supply office with a mobile number for contact.
- Designation of an isolation area for sick animals
- A Bio Security Plan is in place for the annual Fraser Coast Agriculture Show.

The Fraser Coast Agriculture Show Society Inc. makes the following recommendations for all competitors:

Primary responsibility for biosecurity at horse events lies with the horse owners / competitors, long before the event.

Practice good biosecurity, good hygiene and decontamination of equipment

- Wash your hands with soap and water or use hand wipes and waterless hand hygiene solution immediately after handling animals.
- Competitors and animal carer/s are urged to promote the washing of hands to members of the public upon entering and leaving the livestock area.
- If an animal is unwell at an event, notify an event official (Chief Steward or Show Office) immediately
- Stop all non-essential contact with the sick horse/animal and blood or body fluids from the horse/animal until a veterinarian has advised otherwise.
