Oceanside is a beach city in the North County area of San Diego County, California, United States. The city had a population of 174,068 at the 2020 United States census, making it the most populous city in the North County region of San Diego. The city is a popular tourist destination, owing to its historic landmarks, beaches, and architecture.

According to the United States Census Bureau, the city has a total area of 42.2 square miles (109 km²), of which 41.2 square miles (107 km²) is land and 0.9 square miles (2.3 km²), comprising 2.23%, is water.

Traveling north on Interstate 5, Oceanside is the last city before Orange County. It is roughly the same distance from Aliso Viejo as it is to downtown San Diego. Oceanside is located about 35 miles (56 km) north of downtown San Diego and south of Marine Corps Base Camp Pendleton, one of the largest U.S. Marine Corps bases.

Together with Carlsbad and Vista, it forms a tri-city area.

Oceanside blends the charm of a classic California beach town with the amenities of a modern city: Beaches & Pier: Famous for its wide sandy beaches, the historic Oceanside Pier, and excellent surfing spots.

- Harbor & Marina: A New England-style harbor offering boating, fishing, sailing, jet skiing, and whale-watching opportunities.
- Climate: Mild, pleasant weather year-round, typical of Southern California coastal areas.


