EVERYTHING IS POSSIBLE: THE 2024 LE LYONNAIS DISCOVERY

Atlantic Wreck Salvage, owner and operator of D/V
Tenacious, lead the discovery of the 1856 transatlantic
passenger steamship Le Lyonnais. The liner collided with
the American sailing vessel Adriatic off the Coast of
Nantucket on November 2, 1856. One-hundred-andfourteen of Le Lyonnais' 132 passengers and crew died in
the disaster.

Le Lyonnais was one of six ships built by Laird for Franco-Americaine to be used in transatlantic passenger and mail service. Le Lyonnais was built during a time when ships were making the transition from sail to steam. She was equipped with sails and a horizontal steam engine and is an

early example of a passenger liner with two mid-Nineteenth century innovations: a screw propeller and an iron hull.

Franco-Americaine launched Le Lyonnais in January of 1856 and put her into service carrying cabin-class clientele and cargo between New York and Le Havre, France. On November 2, 1856, during her first return voyage to Le Havre from the Americas, she collided with the Maine-built barque Adriatic, which was en route from Belfast, Maine to Savannah, Georgia. Adriatic left Le Lyonnais with a small hole in her hull that eventually overwhelmed the vessel. Adriatic was injured in the collision but remained afloat. She assumed Le Lyonnais was uninjured because the steamship continued her course. Adriatic sailed to Gloucester, Massachusetts for repairs. Le Lyonnais sank days later.

Captain Joe Mazraani and Jennifer Sellitti of D/V Tenacious reignited the search to in 2016 and spent eight years working to locate Le Lyonnais' final resting place. The team side-scanned potential targets in 2022 and 2023 and, after reviewing the data, narrowed the search down to a series of potential candidates. They returned to the search area on August 20-25, 2024, to dive the targets, one of which they identified as Le Lyonnais.

DEEP AMBITION: KAREN'S WORLD RECORD DEEP DIVE

The film captures her intense preparation, mental fortitude, and the risks involved as she descends into the abyss, aiming to reach 250 meters (820 feet). As the dive intensifies, the film delves into the physical and emotional challenges Karen faces, portraying the delicate balance between ambition and the dangerous realities of extreme deep-sea exploration.

Through stunning visuals and a taut narrative, Deep Ambition not only highlights the limits of human endurance but also the drive to push beyond them in the pursuit of breaking records.





IN MEMORY OF FRANK PERSICO

As a longtime dive boat captain, instructor and engine mechanic his fellow owners relied on, Frank Persico was a decades-long mainstay of the Long Island diving community.

He was best known for running the Sea Hawk out of Freeport with partner John Lachenmeyer for 29 years — four years longer than any other dive boat on Long Island, according to Stephen Bielenda, the former Eastern Dive Boat Association president.

Persico, 82, of Little Neck, died March 13 at the Little Neck Care Center in Queens after a five-year battle with Parkinson's disease.

"Captain Frank was a true dive boat captain pioneer," said Barry Lipsky, president of the Long Island Divers Association. "He knew every shipwreck off the South Shore of Long Island. Many of those shipwrecks were first discovered by Captain Frank. His knowledge and experience of the Atlantic Ocean, scuba diving, dive boats and the repairs of boat engines of any kind opened the world of diving on Long Island for thousands of scuba divers for over six decades."

Persico was born in Astoria, Queens, and his family moved to Little Neck about 1949, his son, Robert Persico, of Little Neck, said. He attended St. Anastasia school in adjacent Douglaston and then was a member of the first graduating class at Martin Van Buren High School in Queens Village in 1961.

Persico enlisted in the Navy the next year and served for four years on amphibious landing ships and minesweepers while based at Little Creek, Virginia. The Navy sent him to its school for engine mechanics, which would set him up for his future career. He also learned to dive in his spare time.

While on leave, he would return to Long Island. On one trip he visited a bar in Rockaway Beach and met Julia Casserly. They were married in 1967.

Soon after leaving the Navy, he got a job with Detroit Diesel distributor Henry Knese in College Point, Queens, and worked there for 29 years. When the company folded in 1994, Persico formed a business, Offshore Diesel Services, with his son, who continues to run the Little Neck company.

"He was a high-end diesel mechanic," said Bielenda, former owner of the dive boat Wahoo.

After leaving the Navy, Persico also pursued his interest in diving. He was certified to dive by a local pioneer in the industry, Al Boehm, who operated one of the first dive boats that ran out of Brooklyn, the Terry Bobby. "Because he was a mechanic, Al ended up taking him under his wing," his son said. "Al Boehm pushed him to become a captain, so he became a captain." Persico got a Coast Guard captain's license to operate vessels up to 100 tons weight.

Eventually, Boehm became the head instructor at Central Skin Divers in Bellmore, which owned a dive boat named Honest Archie berthed in Freeport. Persico and Boehm ran it as co-captains while Persico also became an instructor in the 1970s.

When Central Skin Divers sold its boat, Persico met Lachenmeyer when they were both diving off a boat called the Carol Lynn in Freeport. Lachenmeyer and Persico saw a boat that had been overhauled by Henriques Yachts in New Jersey. "Frank and I decided it might be nice to form a partnership and get our own similar Henriques dive vessel, Sea Hawk, which was built and delivered in 1985," Lachenmeyer said.

The co-owners were a study in contrasts. Persico could be gruff and mercurial, although unfailingly helpful, while Lachenmeyer was laid back and unfazed.

"It was just his nature," his son said. "He was basically no-nonsense. He was hard on some people but he had his reasons for doing things, and he was usually right."

"We had an ideal working relationship from the very beginning of our many years together," Lachenmeyer said.

"After more than 20 years of great dive trips together," he said, Lachenmeyer sold his portion of the dive business to another diver, Captain Ned Witkin, who remained with Persico. The boat was sold last year to the owner of the Captain Lou fleet in Freeport.

In addition to his wife and son, he is survived by his daughter, Christina, of Park Slope, Brooklyn, and her two children, Annabel and Will.

The family is planning a memorial service in the spring and working to honor Persico's wish that his ashes be spread over the wreck of the USS San Diego off Fire Island.

POOL TIME: FARMINGDALE

Are you a certified scuba diver? If you are, you will be interested in Farmingdale Aquatic Center's Monday Night Scuba program. Every diver wants to keep their Scuba skills at their very best. Living on Long Island, with the diving season as short it is, it can be difficult to keep Scuba skills sharp. Getting into a pool for practice is a great way to keep you skills up. Certified divers can get that pool time in the brand new Farmingdale Aquatic Center.

These 1 1/2 hour pool sessions are an ideal way to keep your skills up-to-date and be ready for your next Scuba diving vacation. The facility, which is brand new, has a 15 foot deep section great for practicing skills, trying out new equipment, working with your dive buddy, the lists goes on...

If you do not own all needed equipment, you can rent what you need from your local dive shop, or through special arrangements with Tiedemann's Diving Center of Levittown. Make sure all your skills are perfect by practicing in the pool. Then your dives will be more fun and safer.

Are you a Scuba Instructor? If you are you can use this facility to teach. The rules are simple. You need to be current with your agency. Each person in your group must be registered (you, your student(s), and any assistants you may have). Farmingdale needs to be listed as an Additional Insured on your instructor liability insurance. Contact Ed at Tiedemann's Diving Center for more details. You can even work out rental equipment for your students.

The sessions take place on Monday evenings, from 7:30 PM to 9:30 PM. To participate you must have a nationally recognized scuba certification. The level of certification must be Open Water Diver or higher. Use of any highly specialized equipment, (like a dry suits, full face masks, rebreathers), requires certification in that area. If you are a student you must be with your instructor at all times in the water. Anyone under the age of 18 year must have a parent with them in the pool area.

Has it been some time since you have been diving? We can make arrangements for a Scuba Update on your first pool session. Then you have two more sessions to practice.

The cost is \$100 per diver for the three-night session. Each of the sessions includes three pool sessions. The number of participants is very limited. Make Monday Night Scuba a great way for you to enjoy your Scuba Diving year round.

Signing up could not be simpler. Contact Ed Tiedemann (516-796-6560) at Tiedemann's Diving Center and he can sign you up in person at the shop or over the phone.

- Further, I understand that diving with compressed air involves certain inherent risks; decompression sickness, embolism, or other hyperbaric injuries can occur that require treatment in a recompression chamber. I further understand that any trips of any kind (diving or non-diving), whether sponsored or not, by The Dive Club may be conducted at a site that is remote, either by time or distance or both, from such a recompression chamber. I still choose to proceed with such diving activities in spite of the absence of a recompression chamber in proximity to the dive site(s).
- I understand and agree that neither The Dive Club or any of their respective board members, officers, agents or assigns (hereinafter referred to as "Released Parties"), may be held liable or responsible in any way for any injury, death, or other damages to me or my family, heirs, or assigns that may occur as a result of my participation in any Dive Club activity, or as a result of negligence of any party, including the Released Parties, whether passive or active.
- In Consideration of being allowed to become a member of The Dive Club I hereby personally assume all risks in connection with diving or non-diving activity from any harm, injury or damage that may befall on me, including all risks connected therewith, whether foreseen or unforeseen.

- The Dive Club does not vet divers or make any determination about whether any diver is qualified to do any given dive. This decision is entirely up to the individual diver, as well as any external dive operator, such as a dive boat captain or resort operator. It is important to evaluate your current experience when making the decision to dive. If you only have experience diving in warm waters with optimal visibility, you should consider the additional challenges associated with northeast diving before making your decision. I expressly assume the risk of any injury or illness for each and every dive that I determine to make and hold harmless for the same the above listed companies and individuals.

- I acknowledge that for planned boat charters, the minimum certification and equipment requirements listed in our newsletter are the requirements of the boat captains. Please contact them directly if you have any questions about the suitability of a dive for you.
- I understand that DAN (Divers Alert Network) Insurance or other similar diving accident insurance policies are available to me if I choose to acquire this. I acknowledge that it is my own responsibility to educate myself on the available policies and choose the one, if any, that is appropriate for me. I understand that without this, I will be responsible for any medical bills or damages to my equipment that I incur.
- I recognize that I may receive false or misleading information from one or more club members or non-members pertaining to the relative difficulty of a dive or my ability to safely participate in or perform a dive. Additionally, I acknowledge that one or more club members or non-members may negligently approve of my dive plan, including preparation or intended dive plan, the condition of my equipment, my ability to use my equipment, or proper use of equipment. I understand and agree that I am responsible for determining whether I am capable of executing a dive safely, whether I have sufficient information regarding my own physical abilities and the intended dive to base this decision, as well as whether my equipment is in proper working condition and is sufficient for the intended dive. I release The Dive Club and all co-signers who by signing this waiver similarly release me from negligent acts or omissions of this nature.
