Please watch and listen to the below linked video and audio files (respectively), and consider the contents of this email before moving forward with your decision to kick me out of housing—in addition to your confirmed (active) campaign in conspiring to murder me.

The attached information (and more physical evidence) is set to go public should anything out of the ordinary occur—again.
