## **Action Items**

  - 1. Guaranteed—lifetime—full-spectrum medical coverage.
  - 2. Guaranteed—lifetime—full-spectrum academic resources, and enrollment in all classes and schools, for all of my remaining and future academic endeavors at Columbia University, both undergraduate and beyond.
  - 3. Guaranteed—lifetime—full-spectrum academic resources for all of my remaining and future academic endeavors or life-goals, regardless of the institution, program, or goal.
  - 4. Guaranteed—lifetime—full-spectrum Columbia University Housing, at and within any residence of my choice—owned/managed/occupied/associated with Columbia University, and full-spectrum housing anywhere in the world.
  - 5. Guaranteed—lifetime—full-spectrum worldwide transportation.
  - 6. Refund all housing costs, tuition, and any fees associated with attending CU in its entirety.
- (7-11) Pertains specifically to me (Javon Terell Ross).
  - 7. Remove all holds on my Columbia University accounts.
  - 8. Remove my account from all collection agencies.
  - 9. Restore my credit rating.
  - 10. Cease and desist with all retaliatory actions.
  - 11. Cut me a Good Faith offering check, in any amount you deem reasonable enough to cover the out-of-pocket expenses my friends and family, as well as myself have incurred since my arrival in May
