From Atlanta: Highway 85S exit 21 to 185S. Take exit 42, Pine Mountain exit. Left at Stop Sign. Approximately 10 miles to Pine Mountain. Turn right on Harris Street, next to Circle K gas station. Approx one mile out when you see the entrance to Callaway Gardens, veer to the right and at the next street on the right is Bethany Church Road. Turn in to first driveway and you will see a sign for parking.

From Columbus: Highway 185 North. Exit on Highway 18 exit, turn right at Stop Sign. Approximately five miles turn left on Bethany Church Road. Take an immediate left into the driveway and you will see signs for parking..

Certification of Agreement upon Registration or Entry of Dog

I (we) agree to conduct myself (ourselves) in accordance with all Barn Hunt Association, LLC Rules and Regulations and to abide by any decisions made in accord with them

Liability Waiver

I (we) agree that Champion Canine Barn Hunt has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to win prizes, ribbons, and/or trophies, I (we) agree to hold Barn Hunt Association, LLC, Champion Canine Barn Hunt, their members, directors, governors, officers, agents, or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any BHA LLC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
