 18 previously sworn by the Notary Public, was
 19 examined and testified further as follows:

 21 FURTHER DIRECT EXAMINATION BY
 22 MR. POLAK:

23 Q Good morning, Mrs. Moon.
 24 Yesterday at the beginning of the
 25 deposition you may recall that I asked you some

 2 United States, and I believe that you responded
 3 that you arrived by plane in the United States
 4 on either Friday or Saturday this last weekend.

5 Do you recall that?

6 A Yes.

7 Q Okay. I was well -- there's a
 8 website called familyfed.org. That is the
 9 official website of HSA USA, right?

10 A Okay. I don't --

11 Q Well, I was looking at familyfed.org
 12 this morning, and there's a post by Demian
 13 Dunkley. It's a president's message to, I
 14 guess, the members of HSA USA.

15 Let me read for you what it is that
 16 he wrote, and what I'd like to know from you is
 17 whether what he wrote was accurate or
 18 inaccurate. I'm going to start reading now.

19 Despite countries all over longing
 20 for True Mother to visit them, she has been in
 21 the USA for almost a month now preparing for
 22 the Peace Starts with Me blessing America rally
 23 on April 6th in Los Angeles.

24 And that's the end of the quote that
 25 I was going to read for you. This post is

2 Is Mr. Dunkley's statement on the
 3 familyfed.org website correct, that you've been
 4 in the country, in the United States, for over
 5 a month? Or is it incorrect?

6 A That's correct.

 9 that was not a true statement?

10 A I meant to say I arrived in New York

 22 it's very important that you provide accurate
 23 and truthful testimony to me when I ask you
 24 questions?

25 MR. ROSENFELD: Objection.

4 United States from Korea on this trip?
5 MR. ROSENFELD: Objection to form.

11 Hawaii?

18 process works is I'm asking you questions, and
19 you just need to answer them. I have realized
20 that my questions may not always make sense as
21 to why they're relevant, but you still need to
22 answer the question.
23 A I mean, even with the answers, if I
24 don't want to answer, then I don't have to
25 answer.

24 then I corrected myself already.
25 MR. POLAK: Okay. All right.

1 A Obviously, I know because I made that
2 proclamation.
3 MR. HYUN OOK SUH: Objection. I
4 proclaimed it. How would I not know it?
5 Q Can Cheon Il Guk be owned?
6 MR. ROSENFELD: Objection to form.

8 Q By anyone.

24 A It refers to the heaven on earth and
25 heaven in heavens.

23 she said, what thing it is (speaking
24 Korean.)

25 THE INTERPRETER: The interpreter has

22 from True Parents in his marriage to his wife?

23 A Well, he did receive blessings from
24 his True Parents. However, I kept repeating
25 this to you. What Sean had to do was to

21 was perfected by the True Mother.

22 MR. HYUN OOK SUH: For a person, they
23 would prefer to use the word "completed."

24 Q So this concept of Cheon Il Guk was
25 first created when Reverend Moon was alive; is

13 MR. HYUN OOK SUH: She didn't say it

18 THE INTERPRETER: May the interpreter
19 make a correction, please?
20 Yes, she said that -- Mrs. Moon said
21 it belonged to the True Parents, and it
22 was hers.
23 MR. POLAK: Okay.
24 Q So did you design it?
25 THE INTERPRETER: May the interpreter

1 ask for a clarification, please?
2 A It was designed by both of us,
3 Reverend Moon and myself. However, that was
4 before my son was born.
5 MR. HYUN OOK SUH: Objection. She
6 didn't say we designed. She just said, we

16 MR. ELDER: Objection.
17 MR. HYUN OOK SUH: No. She said,
18 listen carefully, Tim.
19 MR. ELDER: Objection. The witness
20 is addressing someone else in the room.
21 MR. POLAK: Would that be you?
22 MR. ELDER: That would be me.
23 BY MR. POLAK:
24 Q Okay. So does the Tongil symbol have
25 spiritual meaning in your religion?

Page 202

1 A It not only embodies the spiritual
2 aspect, it also embodies how human -- mankind
3 on earth should live according to the
4 providence, and it -- how can you know the
5 providence, the 6,000 years, even if you are
6 smart? Do you think you -- do you think you're
7 smart enough to know that? I don't know how
8 old you are but...
9 MR. HYUN OOK SUH: Objection,
10 especially about the last part.
11 However intelligent you may be, how
12 can you see -- how do you see that I can
13 answer a question about 6,000 years of a
14 providence with a "yes" or a "no."
15 MR. POLAK: No mention about how old
16 I was?
17 MR. ELDER: Yes, actually.
18 MR. HYUN OOK SUH: I don't know how
19 old you are but...
20 Q So does the Tongil symbol have
21 religious meaning in your religion?
22 MR. ROSENFELD: Objection to form.
23 A I have already told you. It doesn't
24 just embody the spiritual meaning. It embodies
25 the history of providence or providential

 2 MR. HYUN OOK SUH: Objection. She
 3 didn't say spiritual meaning. She said
 4 religious meaning, not just religious
 5 meaning.
 6 A You cannot limit -- you can confine

 9 religion.
 10 Q So is the Tongil symbol part of

 16 Reverend Moon's teachings?

 21 Q So if someone is a follower of
 22 Reverend Moon, that person would consider use
 23 of the Tongil symbol as important to following
 24 the Reverend Moon's teachings?
 25 MR. ROSENFELD: Objection. Form and

 2 A It doesn't just limit to
 3 Reverend Moon. I said, True Parents. It's
 4 really frustrating. Historically, it's the
 5 wishes of heavenly parents and the dream of
 6 mankind and hope of mankind.

 24 also have to use the Tongil symbol, wouldn't
 25 they?

1 MR. ROSENFELD: Same objections.
 2 Asked and answered.
 3 THE INTERPRETER: She's going -- I
 4 wanted to stop her, she's going on about
 5 theology. I just asked her to stop.
 6 A Why should I ask that person's
 7 conscience? If a person does not follow the
 8 teachings of the True Parents, just because
 9 Reverend Moon had given permission or had
 10 said -- had mentioned it, just because

 3 A The issue is not using the Tongil
 4 mark. It's their heart.
 5 Q Did Reverend Moon authorize those
 6 that follow him to use the Tongil symbol in

 9 asked to authorize, and the interpreter
 10 said permit. I think (speaking Korean)
 11 would be a better translation.

 17 is no written document. He did not give
 18 the authority.
 19 Q What about authority through a
 20 nonwritten document? I should take that back.
 21 There's no such thing as a nonwritten document.
 22 What about authorization given
 23 orally?
 24 A No.
 25 Q Did Reverend Moon give permission to

 3 A I already told you no. The important

 15 alive, I'm sure they have conscience. So if
 16 you heard me speak about it for this long, you
 17 should ask your own conscience.
 18 Q So before the Reverend Moon died,
 19 you'd agree with me that there were churches in
 20 the United States that were Unification
 21 churches that used the Tongil symbol?
 22 MR. ROSENFELD: Objection. Form.
 23 A Well, if you did research, I'm sure
 24 you would know the answer.
 25 Q Mrs. Moon, I'm really not here to

1 argue with you, and I'd ask you to stop arguing
 2 with me. This process works a lot better if
 3 you just answer my questions directly, and I
 4 would very much appreciate it.
 5 A Well, I did not see it, so I'm asking
 6 you to find it for yourself.

 21 him as the True Parent. Because they were
 22 following the True Parent, they were using
 23 that. That's the basic principle.
 24 Why are you separating these facts?
 25 MR. HYUN OOK SUH: She didn't say,

1 these facts. Why are you separating?
 2 Implying why are you separating us.
 3 Q Well, you recognize that there are
 4 people who claim to be Unification Church
 5 followers that do make that separation?

 24 if there was a check on that. We can take
 25 a break.

 2 have to graduate. You shouldn't stay a high
 3 school student. It was not just for one
 4 religion. It was considering the entire world.
 5 Even -- people may have different religions,
 6 though everyone around the world, even though
 7 they may have a different -- they are in
 8 different religions, they all want peace and
 9 peaceful world.

10 MR. HYUN OOK SUH: Objection. I
 11 think -- I mean, my request would be if
 12 she could interpret after she speaks
 13 because there were quite a few words that
 14 were omitted.

15 MR. POLAK: Just go ahead and give
 16 your check interpretation. Just interpret
 17 it how you think it should be interpreted,
