**COMPLIANCE ACTIONS REQUESTED**  
By Deadline June 1, 2026

The 501c3 (EIN 81-2711798) Nonprofit Corporation Natchitoches Tribe of Louisiana (NTL-NC) is moving ahead in 2026 with a current force of 93 individuals who have read the postings on the various websites and made their choice to proceed with BIA application. Some individuals have responded to the Directives of the “Cease and Desist” letter by joining the NLT Nonprofit Corporation Facebook account: <https://www.facebook.com/groups/1596442157707395>

The Board of Directors and Officers are requesting again that the following compliance actions, if applicable to that member, are taken by any vetted Tribal Registry Member who wishes to participate in the governing of the legal Nonprofit Corporation business.

**COMPLIANCE ACTIONS REQUESTED**  
By Deadline June 1, 2026

**Number One.** Transfer administrative control of FaceBook: <https://www.facebook.com/groups/402497333877971> to Board of Directors of NTL-NC.

**Number Two.** Transfer webmaster control of <https://ntl-tribe.org/> to Board of Directors of NTL-NC.

**Number Three.** Transfer control of all forward pointing domains (known and unknown) to website [www.ntl-tribe.org](http://www.ntl-tribe.org) (i.e., [natchitochestribe.org](http://natchitochestribe.org)) to Board of Directors of NTL-NC.

**Number Four.** Transfer control of all known and unknown email addresses used for administrative purposes (i.e., natchitochestribeoflouisiana@[gmail.com](mailto:natchitochestribeoflouisiana@gmail.com)) to Board of Directors of NTL-NC.

**Number Six.** Cease and Desist all activities which are identified as “for and on behalf of” the Natchitoches Tribe of Louisiana immediately upon receipt of this letter. Proof of delivery will be from various means, as permitted by the Attorney General’s guidelines: registered mail, known e-mail addresses, posting on NTL-NC websites, social media posts and re-posts, telephone notification, etc.

**Number Seven.** All assets of the IRS dissolved entity under EIN 81-2980752 have been legally transferred to Natchitoches Tribe of Louisiana Nonprofit 501c3 Corporation, EIN 81-2711798. All individuals who wish to remain engaged in legitimate activities on behalf of the legally identified Natchitoches Tribe of Louisiana, identified as such by both Louisiana Secretary of State (Charter Number 42013374N, established 1/12/2016) and IRS 501c3 established by Letter of Determination, are **required to submit Volunteer Applications** as described on website: <https://natchitochestribeoflouisiana.us>

The Volunteers will be initiated into appropriate committees under the direction of the Board of Directors of NTL-NC as legally required by the State of Louisiana Nonprofit Corporation Laws. There is no timeline on this registration.

However, if any activities are resumed by any individual outside of this legal volunteer application process, who use the name of NTL, a Trademarked Corporation Name, in accepting donations under the claim of being a representative of the NTL-NC 501c3 Nonprofit Corporation, they will be immediately reported to the Louisiana State Attorney General's office for violation of Nonprofit Corporation law and public financial fraud laws.

**Number Eight.** Any individual or groups who illegally use the EIN 81-2980752 of the dissolved entity or NTL-NC EIN 81-2711798 will be criminally charged under Louisiana laws regarding impersonation of a legal entity. These charges may come from various sources, including Attorney General, IRS Fraud Units, Civil Rights violations, and any other avenues for protecting of public and private identities. Any individual who uses private Tribal Registry data obtained while associated with any such individuals or groups will be similarly reported to legal authorities.

**Number Nine.** The Board of Directors of Natchitoches Tribe of Louisiana Nonprofit Corporation 501c3 entity hereby demand that any other individuals who are not accepted as a volunteer according to Number Seven criteria, cease and desist from all uses of the Trademark name and Logo Seal in any form including, but not limited to, the website [www.ntl-tribe.org](http://www.ntl-tribe.org) and other business operations. Any prior verbal or written inferred authority for the use of the NTL Trademark and/or Logo Design is hereby withdrawn, voided, and revoked.


