

Business Name Use License Agreement

Between

Lac Noir "Black Lake" Tribe of Native Americans of Louisiana Non-profit Corporation

And

Fred Dale Simon, owner of sole proprietorship Natchitoches Tribe of Louisiana

It is hereby acknowledged that the name of Natchitoches Tribe of Louisiana (hereinafter NTL) is a trademark name which is registered in the State of Louisiana as a Legal Business name, under the ownership of Fred Simon, President, as a non-exempt, non-corporate entity, without employees, and registered for a sales tax account. This business has an established FEIN of 81-2980752

It is hereby acknowledged that Fred Dale Simon has sole ownership of Intellectual Properties which is called Natchitoches Tribe of Louisiana Tribal Registry (hereinafter "Tribal Registry"). These Intellectual Properties consist of Genealogy Books, Tribal Registry of individuals who qualify as members of the Native American Tribe, and other copyright methods and materials as identified by Fred Dale Simon as integrated components of the Intellectual Properties.

It is hereby acknowledged that Fred Dale Simon was the Incorporator of the Louisiana State Non-Profit Corporation named Lac Noir "Black Lake" Tribe of Native Americans of Louisiana Non-profit Corporation (hereinafter called "Lac-Noir") with the mission and purpose to advance the legal standing of the Tribe to achieve Louisiana State Tribe Recognition and Federal Tribe Recognition. It is hereby acknowledged that Fred Dale Simon is a Board member of Lac-Noir.

Whereas Fred Dale Simon offers to enter into a Business Name Use License Agreement wherein portions of his rights of ownership of the trademark Legal Business name of Natchitoches Tribe of Louisiana (hereinafter NTL) and limited copyright use of his Intellectual Properties (hereinafter "Tribal Registry") are licensed to Lac-Noir, wherein the following terms as specified:

- Term 1. Without payment expected or requested, Fred Dale Simon agrees to license the name of NTL to Lac-Noir.
- Term 2. Fred Dale Simon retains the right to the name of NTL for his continued Tribal Registry development.
- Term 3. Fred Dale Simon retains the right to place a monetary value on this Business Name Use License Agreement after the IRS awards 501(c) (3) status to the renamed Lac-Noir Non-Profit Corporation. This is in recognition that such monetary value may serve a "Public Support" purpose for maintaining tax-exempt status.

Term 4. In the event that the Non-profit Corporation, either named Lac Noir "Black Lake" Tribe of Native Americans of Louisiana, Natchitoches Tribe of Louisiana, or any other future name, is dissolved for whatever reason, the name of Natchitoches Tribe of Louisiana will revert back to ownership of Fred Dale Simon. The licensure of the name will not be part of the "charitable assets" to be given to other non-profit corporations.

Statement by Fred Dale Simon:

The minutes of Board meeting of June 17, 2016, were illegally taken by a prior Board Member and have been withheld for the past 9 years. I hereby confirm that the above written statement is my true memory of the issues discussed and agreed upon in the Lac-Noir Board meeting.
