## INTRODUCTION FOR AL BADER TRADING GROUP

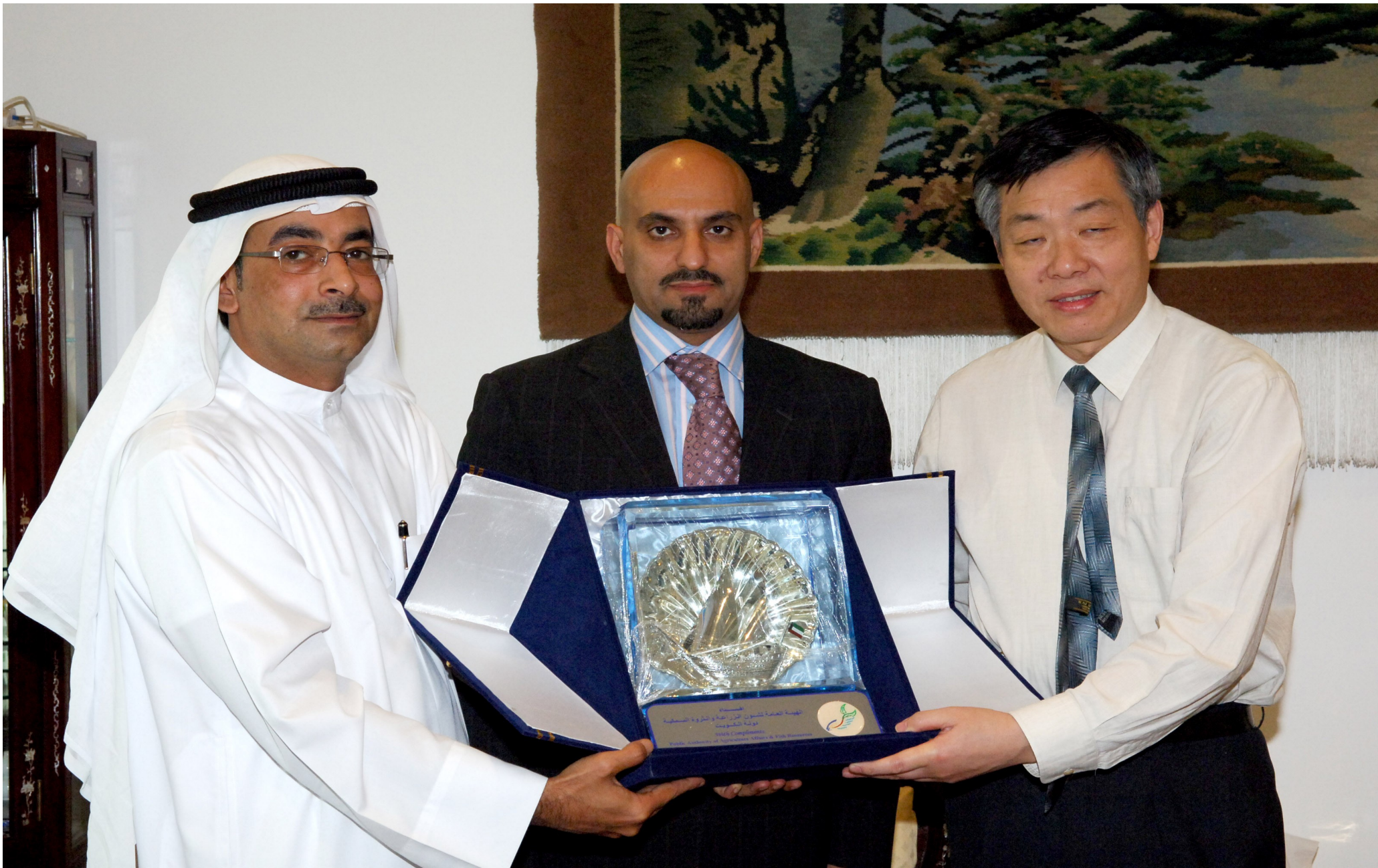

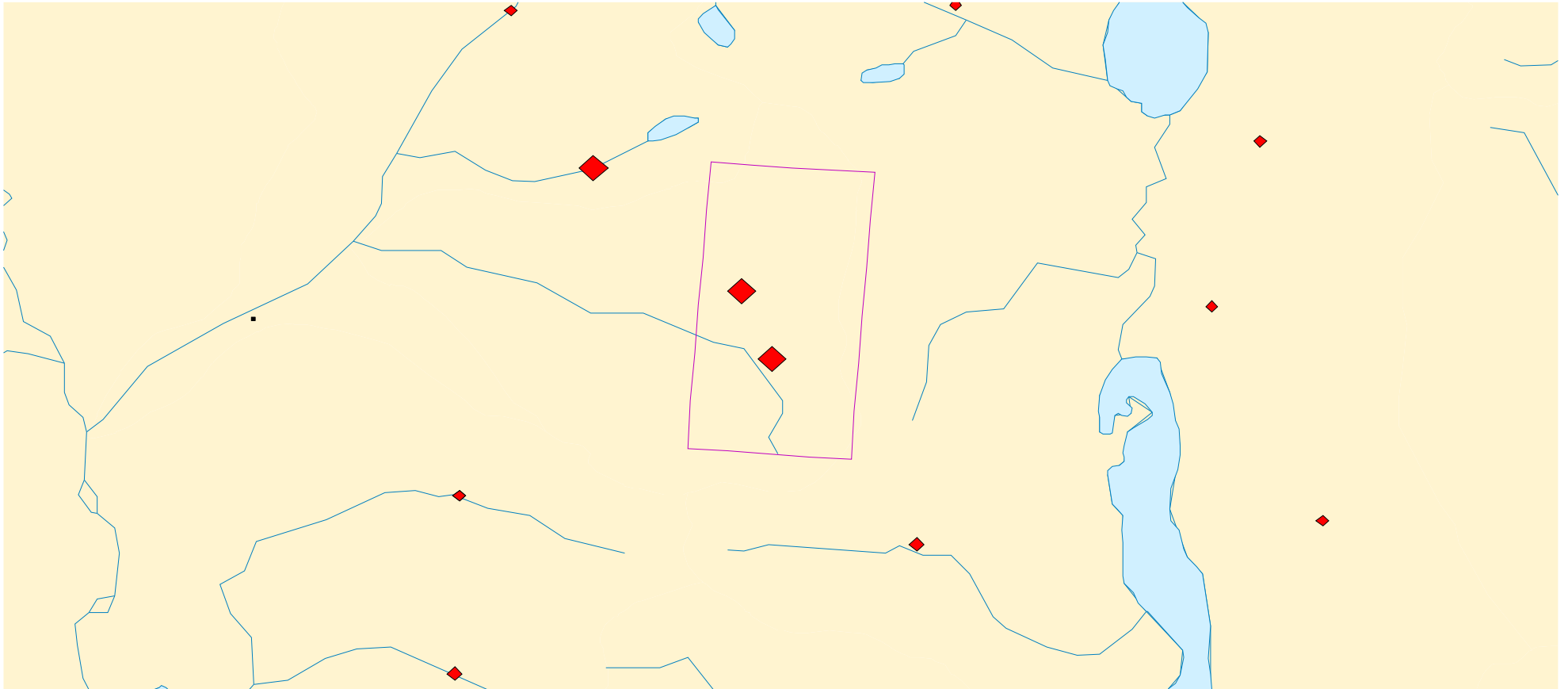

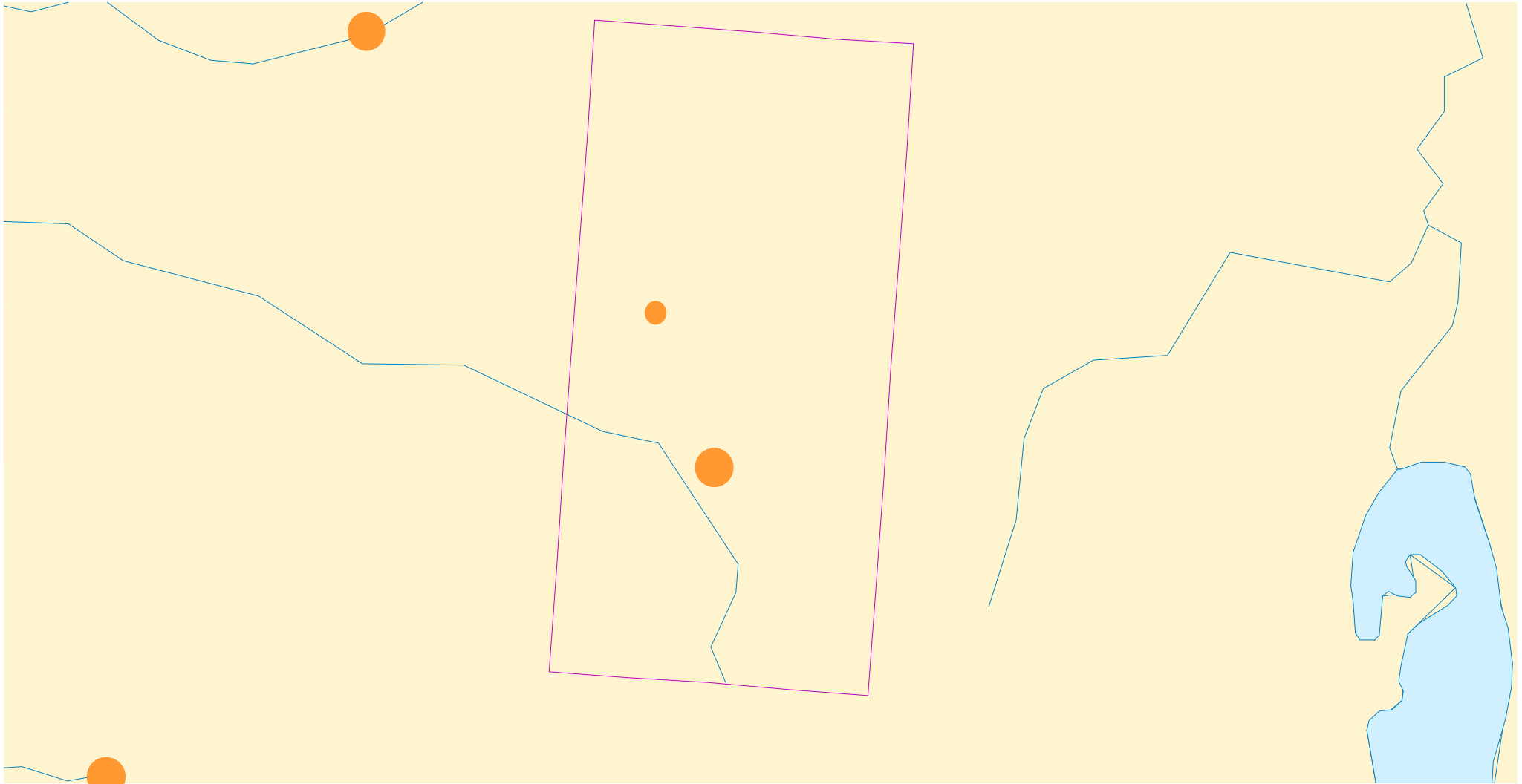
Map of ATGC mineral lands on Mount Garibaldi.

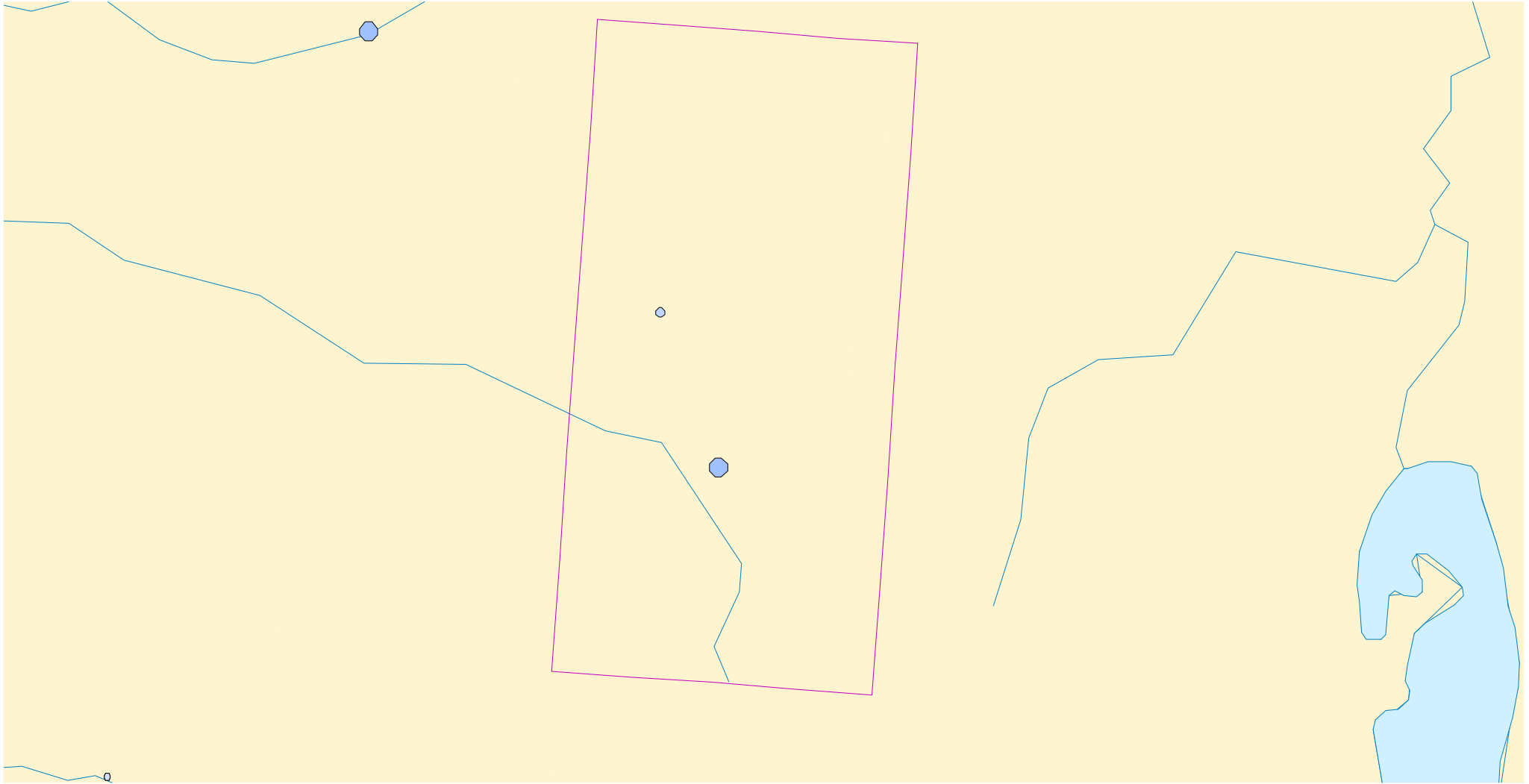

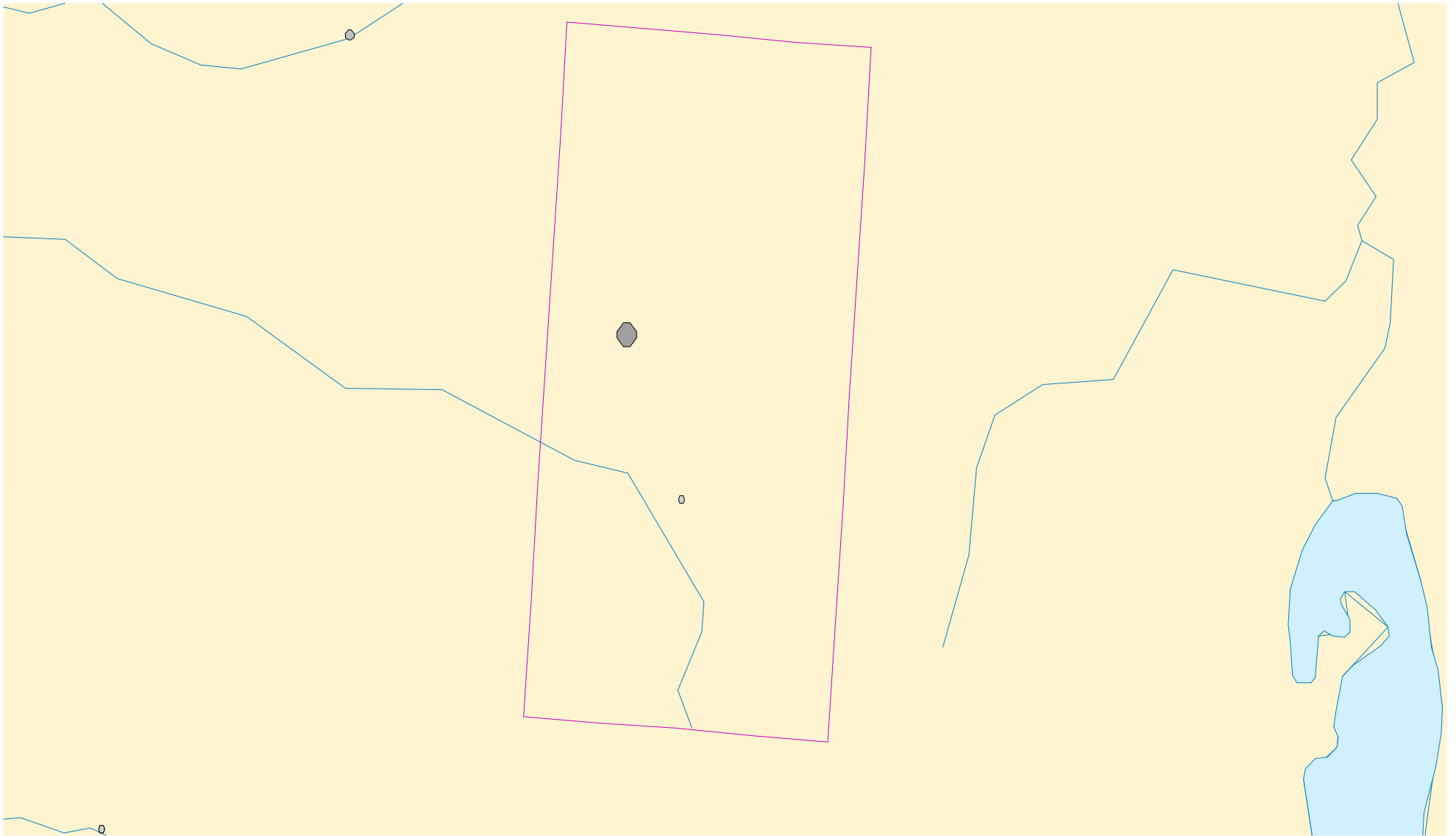
Gold Deposits greater than 95 percentile



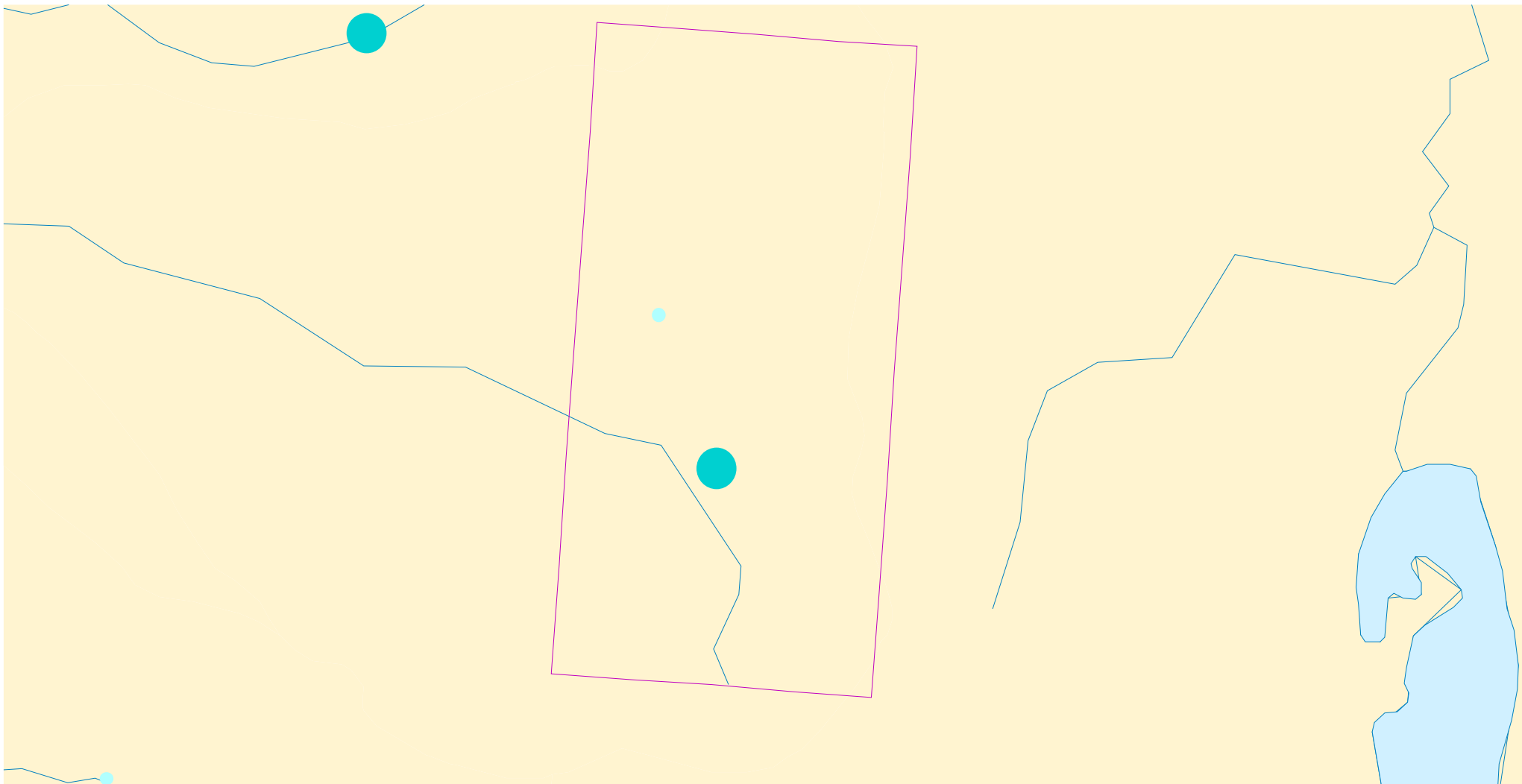
Copper deposits greater than 95 percentile



Nickel deposits greater than 95 percentile

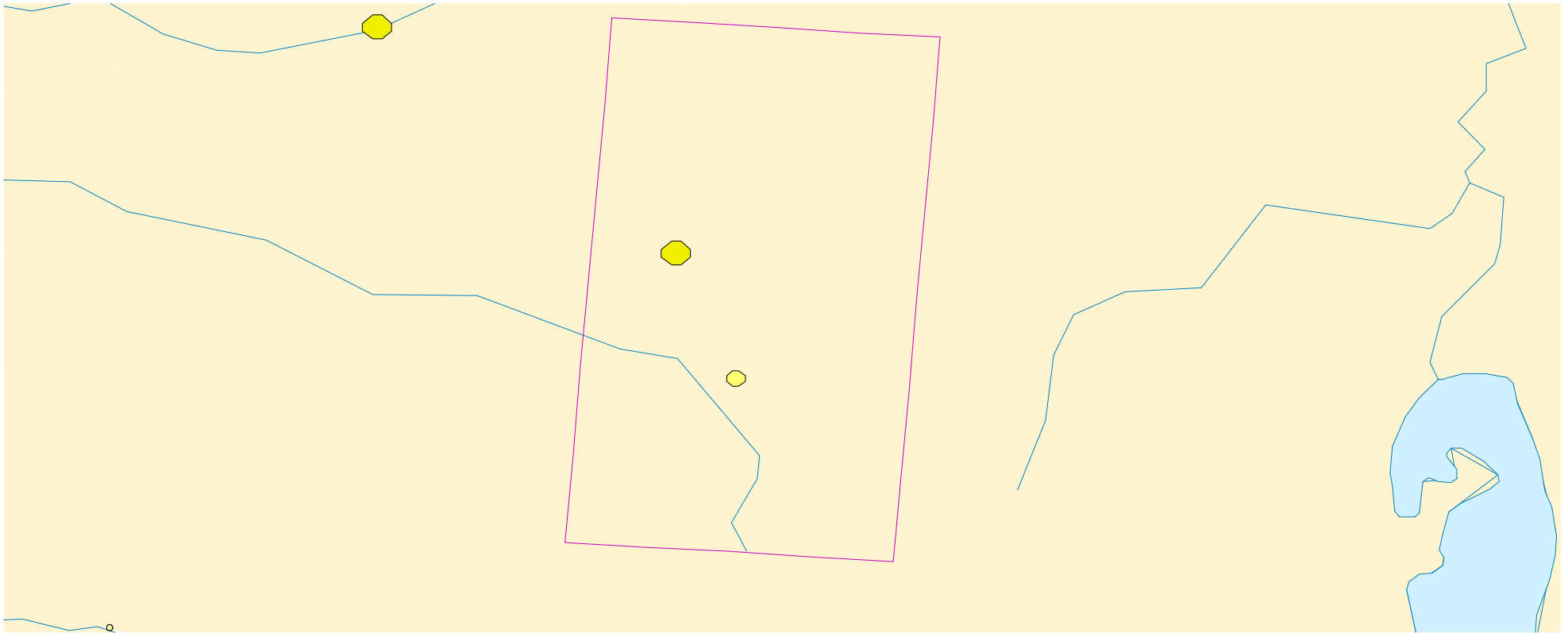


Silver deposits greater than 95 percentile
