

Instructions for Using the Declaration Toolkit

Thank you for downloading our free Declaration Toolkit! This powerful resource helps you assert your rights against surveillance, neurolaw, experimentation, and spiritual threats, including Freemason or occult practices. Follow these simple steps to use the expanded declaration, which merges the CLONE ACT of 2025 with added protections for coordinated harassment, stalking by proxy a/k/a gangstalking, directed energy weapons, and more.

- 1. **Customize:** Open the Word file and add your name in the designated space. Keep the text unchanged to maintain its legal and spiritual strength.
- 2. **Sign and Notarize**: Print the declaration, sign it with two witnesses (e.g., friends or family), and get it notarized at a bank, post office, or notary service (cost: \$5-15 USD).
- 3. **Make Copies**: Keep one signed copy safe for your records. Make 5-10 copies for mailing to agencies or companies.
- 4. **Send via Certified Mail**: Use certified mail with tracking (\$4-8 USD) to send copies to recipients listed in the Mailing List (below). Include a cover letter: "This is my official notice of non-consent, including to secret groups or organizations, occult, or surveillance practices. Please confirm receipt." Email companies, if possible, for faster delivery.
- 5. **Track and Store**: Save mail receipts and any responses in a secure folder or cloud storage (e.g., Google Drive, Dropbox) for proof of delivery and follow-up.

Next Steps After Sending the Declaration

Next Steps to Protect Your Rights

After sending your declaration, take these actions to reinforce your non-consent, seek accountability, and connect with the TI community:

- 1. **File FOIA Requests**: Request records about yourself to uncover any surveillance or targeting. Use the FOIA template: "I, [Your Name], request all records, including FISA or surveillance data, under the Freedom of Information Act (5 U.S.C. § 552)." Send to agency FOIA offices (e.g., fbi.gov/foia, dhs.gov/foia, nih.gov/foia). Find templates at www.foia.gov or in our toolkit ("TVS_FOIA_Template_EN.pdf"). Expect responses within 20 business days.
- 2. **Opt Out of Data Collection**: Email companies like Flock Safety (info@flocksafety.com) or Clearview AI (privacy@clearview.ai) to remove your data. Use the opt-out template: "Remove my data per attached declaration, including from Freemason-related or surveillance programs." Find the template in our toolkit ("TVS OptOut Template EN.pdf").
- 3. **Track Responses**: Log all replies or non-responses from agencies/companies in a secure folder. Follow up after 30 days if no response is received. Keep records for potential legal action.
- 4. **Connect with Communities**: Join Targeted Justice (targetedjustice.com) or local TI groups for support, especially for concerns about spiritual threats, gangstalking, or directed energy weapons. Share your experiences and learn from others.
- 5. **Stay Safe**: Store all documents securely (physical or cloud storage). Monitor for changes in your situation (e.g., new harassment) and document evidence for future action.

Mailing List

Send your signed and notarized declaration via certified mail (with tracking, \$4-8 USD) to assert your non-consent to surveillance, experimentation, neurolaw, and spiritual threats, including secret groups/organizations or occult practices. Please confirm receipt.

Start with 5-10 recipients. Email companies if possible. Keep copies of receipts and responses.
