## BELLE & BEAU / Tournament Rules

### RULE 1- ELIGIBILITY

Competition is open to all members of any local NEW JERSEY STATE USBC BA & WBA'S.

Bowlers who are not members of an Association of USBC may become eligible by: (a) Paying a \$13.00 USBC and \$10.00 OCBA assoc. fee.

**RULE 2- AVERAGES** (will be used in the following order)

- 1) Highest 2018-2019 average of 21 games or more in any USBC certified league verified on BOWL.COM ( EXCLUDING SUMMER)
- 2) Highest 2019-2020 as of January 01, 2020 league Verified (BOWLERS RESPONSIBLE TO SUBMIT PAPERWORK)
- 3) USBC Highest Three Year Composite
- 4) Bowler's with none of the above, will be assigned an average of 180 for Belle's & 230 for Beau's

**ALL AVERAGES WILL BE VERIFIED ON BOWL.COM & NOT LOCAL AVERAGE BOOKS**

**RULE 3- HANDICAP** - Handicap will be 100% of the difference between the TEAM'S average & 460. There will be no pin maximum.

**RULE 4- RE-ENTRIES** - Unlimited re-entries are permitted, but a bowler can only cash one time, with the same partner

**AWARDS PLACEMENT:** Position will be based on a team's net score, with a handicap for three games. Since there will be a NET prize list, in addition to the HANDICAP prize list, teams winning prizes will be placed on the list that awards the higher value.

### GENERAL RULES:

- 1) All returned checks will be assessed a fee of \$55.00.
- 2) The entry of those paying by check, that is returned, will be disqualified.
- 3) Bowlers must report 45 minutes before scheduled time with their proof of official USBC sanction.
- 4) Open to all USBC members of New Jersey & Easton Association.
- 5) Substitutes will be permitted by reporting, to the check-in desk, 30 minutes prior to bowling.
- 6) Assignment of lanes at the check-in desk is final.
- 7) Full payment must accompany all entries.
- 8) Tournament committee reserves the right to reject any entry.
- 9) Tournament committee reserves the right to re-rate any bowler before or between squads.
- 10) Any situation not covered herein will be governed by the USBC 18-19 Rule Book.
- 11) Consider time requested as confirmed, unless notified otherwise.
- 12) Rules 319(d) & 319(e) waived.
- 13) Rule 319 (a)-1, 3 & -4, in effect.
- 14) Rule 319(a)-5, waived-all averages will be Verified on BOWL.COM
- 15) Rule 319(a)-2 waived- if a bowlers average is 20 pins or more higher as of January 1st, 2020, That average will be used
- 16) Entries paid prior to February 1, 2020 saves \$10.00 ( Must be paid in full ) – Walk-ins welcome pending lane availability.
