

The Masonic Order of Athelstan in the Province of Mercia



The Order is based on the historic records of the life and legend of King Athelstan. The focus of the Order is to show how this early reference to the importance of Masonry in English History was significant for the development of speculative Freemasonry.

The Masonic Order of Athelstan portrays the story of a Master Mason being called to York in 926 AD to receive the Ancient Charges from the King. Throughout its ceremony the ritual contains a great deal of symbolism that is still to be seen in some Lodges today and a great deal that is not currently worked.

The Order, in England and Wales, is structured so that its Provinces, wherever possible, reflect and represent the original Kingdoms and Guilds (original spelling of Guilds) as they were set up by King Athelstan during his reign as "The First King of all the English". Our Provinces do not, therefore, correlate directly with the English County divisions; Our Provinces amalgamate and include areas from existing counties to provide Provinces large enough to support and sustain the required 10 Courts.

Throughout Masonic ceremonies there are many legends that are used to tell a story and portray moral values. The ceremonies within this Order are no different. The Athelstan ceremony focuses on the legend of the York Assembly of 926 AD and uses this as the framework and conduit for our own ceremony. The story is the summoning of the Master Masons to the York Assembly for further "instruction" of Masonic ritual and symbolism and in doing so follows the historic development of the Craft over the following centuries.

The aim of the Masonic Order of Athelstan is to encourage and prompt its members into actual further study and research. As such, each Candidate is carefully chosen due to their interest in Masonic history and is "instructed" into the Order.

Membership of the Order is strictly by invitation and members are expected to take a wide and committed interest in all aspects of Freemasonry, there are therefore mandatory requirements for each member to have current, active and ongoing membership of both Craft and Royal Arch Masonry. To this end the Order is fully committed to supporting the United Grand Lodge of England and expects each and every member of the Order to give full support and allegiance to the United Grand Lodge of England.

THE MASONIC HALLS IN MERCIA

FREEMASONS' HALL, 72 SALTERGATE, CHESTERFIELD S40 1JR



The Masonic Hall is a detached building virtually next door to the Town Hall. Saltergate is a main road running East to West on the top side of Chesterfield.

There is limited parking in the on-site car park. Pay and Display parking at the Rose Hill East and Soresby Street Car Parks.

FREEMASONS' HALL, 33 POTTER STREET, WORKSOP S80 2AE



The Masonic Hall, part of which dates back to the 18th Century, is situated in the South part of the town, from the A57.

The entrance to the building is at the rear – off Queen Street, which is one way only. There is ample parking on the premises - Ambassador Car Park - SatNav S80 2AN

FREEMASONS' HALL, 1 CAMPBELL STREET, BELPER DE56 1AP

Belper is situated to the West of the M1. Campbell Street is one-way. Parking at the Hall is limited to two or three spaces, although there is some free parking on the street after 6pm.

The nearest Pay and Display Car Park is on Field Lane (DE56 1DE) adjacent to the Railway Station.

Park as far down as possible and it is then a two-minute walk to the Hall.



FREEMASONS' HALL, 218 ASHBY ROAD, BURTON-ON-TRENT DE15 0LA



Ashfield House is situated on the A561 close to the junction with A444 and B5008.

Built in the Mid 1870's the house was converted into a Freemasons' Hall in 1933

There is a large Car Park on the site.



FREEMASONS' HALL, CREWE STREET, SHREWSBURY SY1 2HQ

The Masonic Hall is a converted church (St. Michael's, which was built by John Carline in 1829) located on Crewe Street, just off the A5191 to the North of the County town.

It is only single track in front of the Hall.

There is ample parking on the site.

The Railway Station is only a 10-minute walk from the Hall.



FREEMASONS' HALL, GEORGE STREET, LUTTERWORTH LE17 4ED



The Masonic Hall, the Wycliffe Rooms, is located on George Street, in the centre of the town, close to the M1, M6 and the A4304.

The Temple is located on the first floor, which used to be the balcony seating in the former Ritz Cinema opened in the 1930s and closing in the 1960s.

There is a dedicated car park at the rear of the building.

FREEMASONS' HALL, OFFMORE LANE, KIDDERMINSTER DY10 1TL

The Masonic Centre is located at the Cricket Ground on Offmore Lane, a single track road, off Chester Road North. After about 150 yards, the entrance to the car part is on the left.

From the Club Car Park, walk through to the cricket ground and you will see the entrance to the Lodge Rooms with the Doric Pillars at the end of the Club function rooms.

The Kidderminster Railway Station is only a short walk from here.

A GLOSSARY OF COURT NAMES

High Cross

High Cross in Leicestershire is the name given to the cross roads of the Roman roads of Watling Street and Fosse Way on the border between Leicestershire and Warwickshire. A naturally strategic high point, High Cross was the central crossroads of Anglo-Saxon and Roman Britain. As denoted by its name, High Cross is at the top of a hill. An account of the site in a popular magazine of 1827 claimed that, "The ground here is so high, and the surrounding country so low and flat, that it is said, fifty-seven churches may be seen from this spot by the help of a glass [telescope]."

Wychbury

Wychbury Hill is a hill situated off the Birmingham Road at Hagley, Stourbridge on the border of West Midlands and Worcestershire. It is the site of Wychbury Ring, an Iron-age hill fort and the Wychbury Obelisk. The site contains a 28-tree ancient yew grove. The name is derived from that of the Saxon sub-kingdom of the Hwicce.

Leofwyne

Leofwine is an Old-English name meaning 'dear friend'. Leofwine, Ealdorman of the Hwicce, died in or after 1023. He was appointed Ealdorman of the Hwicce by King Æthelred II of England in 994. The territory of the Hwicce was a kingdom in the Western Midlands in the early Anglo-Saxon period, which soon became a subdivision of Mercia.

Bernesedelaue

The name is indicated as a Wapentake in the County of Nottinghamshire in the Domesday Book of 1086; in earlier documents as Bernet-seatte and thereafter as Bassetlaw. A possible interpretation of this place-name is a "compound of *bærnet*, 'land cleared by burning' and *sæte*, 'settlers, inhabitants'.

Wrøcensætān

During the 7th Century, the river Severn became a boundary between the lands of two rival tribes; the Magonsætān who lived to the south of the river and the Wrøcensætān (*People of the Wrekin*) who lived to the north of the river.

Offa

Offa, who died 29 July 796, was King of Mercia from 757 until his death. He came to the throne after a period of civil war. In the early years of Offa's reign, it is likely that he consolidated his control of Midland peoples such as the Hwicce and the Magonsaete.

St Chad

Chad, who died 2 March 672, was a prominent 7th Century Anglo-Saxon churchman, who became abbot of several monasteries, Bishop of the Northumbrians and subsequently Bishop of the Mercians and Lindsey People. He was later canonised as a saint.



The Masonic Order of Athelstan in England, Wales and its Provinces Overseas

By-Laws for the Province of Mercia

1. Members of Provincial Grand Court

The members of Provincial Grand Court are the Right Worshipful Provincial Grand Master, all Officers and Past Provincial Officers and all Brethren who are subscribing members of a Court in the Province.

All other Brethren of the Order who are subscribing members of any Court under the jurisdiction of the Grand Court for England, Wales and its Provinces Overseas may, by the authority of the Right Worshipful Provincial Grand Master, be permitted to attend Provincial Grand Court but they cannot vote or speak on any resolution.

2. Assemblies of Provincial Grand Court

Provincial Grand Court shall assemble annually on a date and at a time and place to be determined by the Right Worshipful Provincial Grand Master. Additional assemblies of Provincial Grand Court may be held at the discretion of the Right Worshipful Provincial Grand Master or, in his absence, by the Deputy Provincial Grand Master, if so appointed.

Whenever it shall be deemed expedient to hold a festival in connection with any assembly of Provincial Grand Courts, no portion of the expenses thereof shall be defrayed out of the funds of Provincial Grand Court except by authority of the Right Worshipful Provincial Grand Master.

3. Notice of Assemblies of Provincial Grand Court

The Provincial Grand Secretary shall issue notice of every assembly of Provincial Grand Court at least twenty-one (21) days before the date of the meeting. The said notice shall state the place, date and hour at which such assembly is to be held, the business to be transacted and the text of written propositions to be made at such assembly.

4. Attendance at Provincial Grand Court

Provincial Grand Officers shall, during their term of office, punctually attend their duty in Provincial Grand Court unless prevented by reasonable cause to the satisfaction of the Right Worshipful Provincial Grand Master.

5. Duties of Officers

The Statutes applicable to similar offices in Grand Court shall govern the Provincial Grand Treasurer and the Provincial Grand Secretary, in the exercise of the duties of their respective offices. No Brother shall be eligible for election to the Office of Provincial Grand Treasurer unless two members of the Provincial Grand Court have nominated him.

The Provincial Grand Treasurer shall receive and pay all monies due to or from Provincial Grand Court, keep a correct record of the same and produce them for audit at such times as may be required. All monies shall be deposited in an approved Bank and/or Building Society in the name of the Provincial Grand Court.

The Provincial Grand Guard shall see that every Brother, before being permitted to enter Provincial Grand Court, has signed his name on the appropriate attendance Roll, giving his rank and the number of his Court to which he belongs, and that he is properly clothed. No Brother shall be eligible for



election to the Office of Provincial Grand Guard unless two members of Provincial Grand Court have nominated him.

6. Regalia

Each Officer shall provide the jewels, collar and apron appropriate to his rank.

7. Officers of Provincial Grand Court

The Officers of Provincial Grand Court shall take precedence in the Order prescribed in the Statutes of the Order and every Brother on his appointment to active or past rank shall pay to the funds of Provincial Grand Court a fee of honour, determined by the Right Worshipful Provincial Grand Master, pro rata to the amount payable for the corresponding appointment in Grand Court as permitted by the Statutes of the Order. The fee of honour shall be due and payable on acceptance of the appointment and no Brother shall assume the regalia of Office until such fee is paid.

8. Fees to be paid to Provincial Grand Court

The fees by the Courts shall be:

- A. An annual fee for each subscribing member;
- B. A registration fee for each new Brother instructed;
- C. A registration fee for each joining member;
- D. A registration fee for amendment to or revision of Court By-Laws;
- E. A registration fee for each new Court; plus
- F. A fee for the granting of a dispensation by the Right Worshipful Provincial Grand Master.

The amounts of such fees will be determined by resolution at Provincial Grand Court.

9. Annual Returns

The financial year of Provincial Grand Court shall end on the 30th **June** in each year.

The Secretary of every Court in the Province shall, immediately after the 30th June in each year, furnish the Provincial Grand Secretary with two copies of the Grand Court Annual Return of membership, dues etc., together with the appropriate fees under the appropriate Appendix of the Statutes of the Order.

The Provincial Grand Secretary shall, after examination of the returns, duly transmit one copy together with the appropriate fees direct to the Grand Secretary, in compliance with the Statutes of the Order.

The Secretary of every Court in the Province shall, immediately after the 30th June in each year, furnish the Provincial Grand Secretary with two copies of the Provincial Annual Return of dues and membership together with appropriate fees under By-Law 8. The Provincial Grand Secretary shall, after examination of the returns, duly transmit one copy together with the appropriate fees direct to the Provincial Grand Treasurer.

10. Examination of Accounts

The accounts of Provincial Grand Court shall be audited and certified prior to the Annual Assembly of Provincial Grand Court by two examiners, who shall be officers of and elected by Provincial Grand Court, and who shall present their report to the Annual Assembly. A copy of the audited accounts, having been duly approved and adopted, shall be transmitted by the Provincial Grand Secretary to the Grand Secretary.



11. Forming a new Court

Brethren desirous of forming a new Court shall conform to the laws prescribed in the Statutes of the Order. Every Petition shall conform to the laws prescribed in the Statutes of the Order. Every Petition for a new Court must be made on the appropriate form and sent to the Right Worshipful Provincial Grand Master whose approval must be obtained before it is sent to the Most Worshipful Grand Master.

12. Dispensations

Every application for a dispensation shall be made in writing through the Provincial Grand Secretary to the Right Worshipful Provincial Grand Master and shall state the reasons requiring the same. Where the dispensation requires the approval of the Most Worshipful Grand Master the appropriate fee shall be forwarded with the application: where the dispensation can be approved by the Right Worshipful Provincial Grand Master the appropriate fee shall be forwarded with the Provincial Annual Return in accordance with By-Law 9.

13. Communications

All communications from Courts, or others, intended for submission to Grand Court, the Right Worshipful Provincial Grand Master or to Provincial Grand Court shall be forwarded to the Provincial Grand Secretary for presentation.

14. Committees

Provincial Grand Executive Committee comprising the following members, shall advise the Right Worshipful Provincial Grand Master on matters referred to them:

Deputy Provincial Grand Master (if appointed)
Assistant Provincial Grand Master (if appointed)
Provincial Grand Treasurer
Provincial Grand Secretary
Provincial Grand Marshal

15. Amendments/Revisions to By-Laws

No addition to, or amendment of, any part of these By-Laws, or of future adopted By-Laws, shall be made unless notice thereof has been transmitted in writing to the Provincial Grand Secretary at least six (6) weeks before the Annual Assembly of Provincial Grand Court, which shall be duly inserted in the notice for that assembly, and no such alteration shall be considered approved unless affirmed by a majority of the members present and voting.

16. General

The Secretary in each Court in the Province shall send copies of each Court summons to the following:

Right Worshipful Provincial Grand Master	1 copy
Deputy Provincial Grand Master (if appointed)	1 copy
Assistant Provincial Grand Master (if appointed)	1 copy
Provincial Grand Secretary	2 copies
Other active Provincial Grand Officers	1 copy



The Secretary of each Court in the Province shall send promptly to the Provincial Grand Secretary completed copies of such forms and returns as required by the Provincial Grand Secretary for the effective administration of the Province.

In all particulars not herein specially set forth the Right Worshipful Provincial Grand Master and the Officers shall be governed and regulated by the same laws as applicable to Grand Court.

CYNINGSTUN 10–90

Cynningstun is an old Anglo-Saxon word which means ‘Kings Manor or Estate’. It relates to that place, which now forms part of modern-day Kingston, where in St Mary’s Church (later replaced by All Saints Church) the Coronation Stone originally stood. It was also the place where the boundaries of Wessex and Mercia met.

The numbers 10–90 allude to the 10th anniversary of this Order in 2015, the year in which each Court made a donation in favour of the Grand Master’s Appeal in support of All Saints Church at Kingston-upon-Thames in Surrey, being also 1090 years after the Coronation of Athelstan in 925.

The appeal fulfilled a double purpose, firstly to mark the 10th Anniversary of the Inauguration of our Order and secondly to commemorate the moving of the Coronation Stone, upon which Anglo Saxon Kings were enthroned, in close proximity to its original location in the grounds of All Saints Church, which we celebrate as the spiritual home of our Order.

The emblem, which is reproduced on the summonses of the Courts, is a representation of one of the Angels which are prominently displayed in the vaulted roof of All Saints Church. The Crown represents Athelstan’s Crown and is a reminder of his anointing and subsequent coronation in 925 AD seated upon the Coronation Stone.

An explanation of the Cynningstun 10–90 should always be given to the Worshipful Master following his Installation in those Courts which participated in the appeal.





THE ANCIENT MASONIC ORDER OF ALFRED THE GREAT



The AMOAG arose from the Order of the Scarlet Mantle in 2019, that Order being founded as a “reward” Order for meritorious service in the Masonic Order of Athelstan (MOA). The AMOAG remains an invitational Order with much enhanced and Grade based rituals. The enhancing lessons of the Ancient Order have been designed to further complement those found within the MOA Instruction Ceremony and have evolved to go much further than those of the original Scarlet Mantle. As the MOA has grown, it has become ever harder to judge meritorious service fairly across an Order which is now firmly established internationally, both as Overseas Provinces and separate daughter Constitutions. With a limited officer structure, it has also been challenging to admit candidates in the numbers nominated, especially as it is our desire that the benefits of membership be extended as widely as possible. These criteria and others have led to the proposal for sovereignty and concomitant structural reorganisation.

Presently AMOAG membership is conferred on those nominated by Athelstan Provincial Grand Masters, with numbers limited by Statute. It is proposed that a fairer system of recognition which is transparent to all and retains the special nature of the Order is now necessary. Therefore, we have determined that as the sole qualification, those invited candidates shall be Past Masters of the MOA of three years standing (either by Special progression or those who have served as Worshipful Master of a Court). Current members of AMOAG who do not hold that distinction will retain their full membership and will not be disadvantaged in any way.

The Province of Mercia is within the Western Shire and members are admitted at a Regional Council called for that purpose. The AMOAG is a strictly invitational and merit-based Order. There is no right of membership for any brother considering himself qualified
