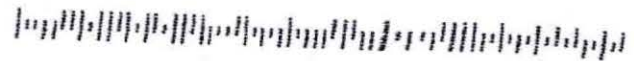

Dear Ms. Carpenter,

I represent the Parish of Tangipahoa. Due to a history of uncooperativeness and harassment of staff, public slander, and inability to effectively conduct business in a professional manner with Tangipahoa Parish Government employees located at the Florida Parishes Arena, Tanya Carpenter/High Road Productions will incur penalties as follows:

- Tonya Carpenter/High Road Productions, or any subsidiary production company or event, will be barred from service at the Florida Parishes Arena, and greater Tangipahoa Parish Government facility located at 1301 NW Central Ave, Amite, LA 70422, including those located at the Tangipahoa Parish Fairgrounds, effective immediately following the 11/25/2024 show and shall include all of 2025 and will remain in effect and continue until written permission is granted via certified letter from Tangipahoa Parish Government.
- All booked dates as of 10/8/2024 in the 2024 calendar year will be allowed to continue so as to cause minimal interruption to the participants' NBHA standings. No modification to these dates will be allowed. If it is the desire of Tonya Carpenter/High Road Productions to cancel any remaining 2024 events, a full refund of deposits in the amount of \$280/date will be granted.
