
Every year HUD requires all Continua to collect data on homelessness at a single point-intime during the last week in January. The Texas Homeless Network annually assists communities with their Point-in-Time homeless survey preparation and data analysis. This report is a compilation of data collected on the day of January 26, 2012, by members of the South Plains Homeless Consortium.


The "known location" methodology was used by volunteers who surveyed persons found at sites identified by the community to be where those suffering from homelessness are known to congregate. The resulting survey sample is represented by people in homeless situations and persons who are at risk of becoming homeless. The number of survey responses does not represent the total population suffering from homelessness, so estimates are provided in this report. This information is used by local communities in the development of short and long-term strategies to alleviate homelessness.







*People who are living in a place not meant for human habitation, in emergency shelter, in transitional housing, or are exiting an institution where they temporarily resided. People who are losing their primary nighttime residence, which may include a motel or hotel or a doubled up situation, within 14 days. Families with children or unaccompanied youth who are unstably housed and likely to continue in that state. People who are fleeing or attempting to flee domestic violence.






CAUSES OF HOMELESSNESS






CHRONIC VS. EPISODIC


- Episodic homelessness is experiencing 2-3 episodes of homelessness in the last 3 years.
- Chronic homelessness describes a person or family with at least one adult member who has a disabling condition and has been homeless for one year or longer, or has had at least four episodes of homelessness in the past three years.

EMPLOYMENT, EDUCATION, & INCOME



- **80.2%** of respondents indicated that they were able to work
- Those that work averaged 33 hours per week, and their median monthly income was \$400.00.
- The median length of unemployment is 6.5 months.
- 70.8% of respondents report attaining a high school diploma or higher degree in this sample.
- 29.2% did not graduate high school and 0.6% never attended school.





Prior to entering the institution, 42.6% of respondents were homeless.


Following release, 54.5% of those had some shelter to which to return.

MEDICAL CARE NEEDED VS. RECEIVED






COMMUNITY NEEDS


