 Intent is to find sponsors for the website in order to be revenue neutral or to generate revenue for the chapter.

- b. Authorizes Chapter to stream chapter meetings on social media. No members can vote online. The purpose is to communicate important meetings for members who cannot make the meeting.
- Authorizes Secretary to make functional email accounts for the chapter. These
 will have no cost to the chapter. These emails will be passed to future officers to
 maintain continuity.
- 3. Motion to conduct meetings in various locations to increase chapter participation. General meeting every other month with a social meeting on the off months. Amended to say that at the December meeting Chapter will reevaluate and continue or find a location centrally located in the region. (Vice Chairman, Brandon presents motion and after discussion Amends motion, passed by members present)

 - b. Amended to evaluate at the end of the year as some members expressed concern about not having our own place.
 - c. Members brought up that social meetups should not be too late for safety reasons



2. I looked at local banks online and visited Sun Trust. They have a simple Business checking for \$5 monthly fee. The first year it is waived. So that is better than the current \$14 monthly fee at Wells Fargo. The way I see the procedure for the two checking accounts: get the death certificate, take it to Wells Fargo with a letter designating the new owner, Tom?? Go to Sun Trust, get a simple business checking, Henry, Tom, Lucien approved signers?? Who will be owner? Tom holds check book, Debit card? Make a wells fargo check out for the balance of the account, deposit into Sun Trust Account. In a week or \$50, owner goes to Wells Fargo and closes account and credit card.

3. The "owner" of the Wells Fargo account is Jack Nolan, the previous treasurer. Wells Fargo will not change the account of close it unless the owner approves. Since Jack passed away in 2016, I requested from the county a death certificate. Then the Designated new owner with a letter from the chapter minutes, can take it to the bank And have the old owner taken off the account. I feel Henry or myself should be the new Owner and add Henry as a signer and take Ed Richards off as a signer. Also Lucien as a signer??

4. The Christmas meal price mix up?? Mal had an old price of \$28.95 per person. The bill came in at \$35 per person. She was going to just take off the \$170 for the 2 servers that Willie had already paid for and that would have gipped her and brought her price down to \$21.14 per person. I didn't think that was fair for her to gip herself because of our mistake using the wrong price. So we settled on \$30 per person. So the people who Gave \$35 per person are getting a refund.

I also want to say that I was the POC for the Christmas party headcount. I get to the party and there were 6 people added to the headcount that I didn't know about. They bypassed me and went to Mal. That was not right!!!! That cannot happen again. Actually, now that we have a secretary, and vice chairman, maybe they can be in charge of events?????

- 5. In past years we have given the Dunedin post \$100 donation for use of the hall for the Christmas party. May I suggest that we do that again?
- 6. We have a new board. Some rules: If I have to write a check for anything, I need written approval or a signed invoice from Henry. I also need receipts and invoices for EVERYTHING with the purpose of the expenditure and to whom and approved by Henry. If we get a donation, ask them "Is this for the general fund or R and R fund??" Donations come in, I have to know where to put it. I send out thank you cards. I cannot receive any money unless I know what it is for and who it is from, unless it is from a raffle. Also, when we have a raffle, what is it for???? I always have to know. Large expenditures need to be voted on by the membership at meetings. THEN it is spent. Please no spending without approval from members especially for big amounts. Don't do it backwards unless unforeseen reasons.
