Release of Liability: Waiver of Claims and Indemnification: In consideration of my participation and attendance at Prom/ Fall Ball, I do hereby, for myself, my heirs, executors, agents, successors and assigns, waive, release and forever discharge any and all rights and claims, whether for personal injuries or property damage, or both, which I may have or which may hereafter accrue to me, against any or all individuals who participated in planning or organizing of the dance (the "Organizers") or against Woodcrest Christian High School, or any of its administrative staff, teachers, board members, employees or agents, including those who participated in planning or organizing the dance, (the "School"), or their heirs, executors, agents, successors and assigns, arising in connection with my attendance at or participation in any activities related to the aforesaid dance, and agree, for myself, my heirs, executors, agents, successors and assigns to indemnify and hold harmless both the Organizers and the School, and their respective heirs, executors, agents, successors and assigns, from and against any and all cost, loss, expense, liability or damages, including for personal injuries or property damage, or both, which may be suffered by me, by any person I may have invited to attend the aforesaid dance or by any other third party, arising in connection with my attendance at or participation in dance or any activities related thereto.

2026 Dance Agreement**CODE OF CONDUCT**

The 2026 Fall Ball / Prom Dance is a time of celebration for Woodcrest Christian High school students. You must be a High School student to attend. We have planned this event in hopes that our students and their guests will enjoy this night and will make lasting memories. It is our desire that while each of you are having a great time, you will remember that you represent a Christian school and its policies. You will let your words, actions, and attire reflect virtues you've been taught and please Respect Yourself, Respect Your Date, and Respect Others.

Attendance to this dance is a privilege, not a right. In order to maintain this privilege as well as a safe and respectable atmosphere, we ask that you agree to the following:

- The dance begins at 7:00 pm and will end at 11:00 pm. Students will NOT be admitted into the dance after 8 pm. Students will NOT be allowed to leave prior to 10pm unless prior arrangements have been made with chaperone. Once student leaves, NO reentry will be allowed.
- Semi-Formal Attire is encouraged. Inappropriate attire may result in denied entrance to the dance and parents may be called to deliver a change of clothing. Ladies: Dresses are to be no higher than mid thigh. Tops of dresses may not be low-cut and may not show bare midriff or sides. Tops and dresses that show a low bare back are not permitted.
- Students who consume alcohol or any illegal substance before or during the dance will be removed and their parents will be called to escort them home.
- Ladies may bring a small clutch but large purses or backpacks will NOT be allowed. All clutches/purses will be searched by the on site Security Guard.
- All dancing must comply with standards of modesty and safety. Inappropriate conduct or dancing (i.e. grinding, freaking, or sexually suggestive behavior) may be cause for removal from the dance floor. The chaperone's and security in attendance will be the final judge of the appropriateness.
- Non WCHS guests are welcome but must be approved by committee prior to attending. Guest must be no younger than sophomore high school age and no older than 19 years of age. All guests and their parents will be required to sign agreement and abide by all terms of this Code of Conduct. • Once tickets have been purchased there will be no refunds. Trading or selling tickets is not allowed.
