Art. 1. The name of the Society shall: "GOA ROLL BALL ASSOCIATION"

Art. 2. The office of the Society shall be situated at: Anil Gaonkar Flat No: FF2, HM Classic Housing society Sasnamodi Cacoda quepem South Goa

Art. 3. Area of Operation of society shall be: Goa State.

Art. 4. Financial Year of the Society shall be: 1<sup>st</sup> April to 31<sup>st</sup> March.

Art. 5. MEMBERS THEIR PROVISIONS, ADMISSION AND APPOINTMENT:-

All the persons above the age of 18 years with good characters irrespective of sex, class or creed shall be eligible for the membership of the association, shall apply to the hon. Secretary. The proposal shall be made by one member and seconded by another member of the association. no member shall be appointed without permission of managing committee. Only managing committee have full right to appoint any member as & when required.

Art. 6. TYPES OF MEMBERS:

1) LIFE MEMBERS

2) ANNUAL MEMBERS

Art. 7. LIFE MEMBERS: Those who pay Rs. 10000/- in one or three installment will be considered as a

Life Members.

Art. 8. ANNUAL MEMBERS: Those who pay Rs. 1000/- in one or three installment will be considered as an Annual Members.



Art. 9. ENTRANCE FEE: Entrance fee will be Rs. 100/-

Art. 10. REMOVAL OF MEMBERS:

A member who does not pay during three consecutive months, the membership fees should forfeit the right to the respective privileges.

Art. 11. Member failing in their duties for considering under character, or for causing damage to the

Association reputation will loss this membership right and their Names will be cancelled from the Association register.

Art.12. Member names are cancelled from the association register for reason indicated in Article-12, may be readmitted to the membership upon submitting their written application for to the general assembly giving satisfactory explanation for m and apologizing for the same.

Art.13. A member shall be likewise relived and prohibited to visit the headquarter of the Association in following cases:-

- a) If the member violates the rules or private regulation of the association incurring in the following penalties warning temporary suspension and expulsion.
- b) He n be suffer from contagious disease.
- c) The penalties above- referred to are within the power of managing committee, and may be commuted or repealed only by meeting of the general assembly convinced specially for this purpose.

**Art.14. GENERAL BODY MEETING AND THEIR RIGHTS:**

The general assembly shall be composed of all members in full exercise of their right. The meeting shall be held once per year.


- a) The managing committee shall meet at least once in a month.
- b) The ruling body of the general assembly shall be composed of president, Gen.secretary & treasurer.

**Art.15. The Compliance Of The General Assembly.**

- a) To elect the managing committee
- b) To examine and approve the reports and statement of accounts.
- c) To improve of expulsion
- d) To deal with all matters pertaining to the administration of the association, when placed before it by the managing committee.

**Art.16. THE MEMBERS HAVE THE RIGHTS**

- a) To visit the headquarters of the Association
- b) To take part in the sports ad all activities organized by the association.
- c) To be present of the general bodies meeting taking part in discussion and voting and to elect for the managing committee.
- d) To examine and appreciate the annual statement of account in that meeting of the general assembly.
- e) To calling of general assembly being the petition for this signed bt at least 1/3 members and addressed to the president of managing committee.
- f) All members will have right to expose in the general assembly and illegal or irregular activities of the managing committees.

Art. 17. Members will not have right to ask for refunding the money contributed by their fee in case of their dismissal from membership for justifiable reasons or when activities of the members of this own record.

**Art. 18. QUORUM AND NOTICE:**

A quorum of 2/3 members will have to present a general assembly meeting if any decision are to be taken legally binding on all members. When the general assembly meeting cannot be constituted at the first convection as per rules it shall be considered to be constituted to the second meeting with any number of meetings after a period of one week. Notice to all the members will be sent 7 days prior to meeting.

**Art. 19. SPECIAL GENERAL BODY MEETING/EXTRA ORDINARY MEETING:**

The general assembly shall have ex-ordinary meetings when the president thinks it necessary, when the managing committee asks for it or when minimum or 1/3 members apply for it.

**Art. 20. MANAGING COMMITTEE**

- a) The managing committee shall consist of eleven members viz, the president, (1) vice-president, Gen. Secretary, jt. Secretary, treasurer, and (2) members
- b) The managing committee shall manage the affair of the association according to its rules.

**Art. 21. TENURE OF MANAGING COMMITTEE AND ITS ELECTION:**

The managing committee shall hold their posts for a period of five years.

- a) The election of the managing committee shall take place in general assembly meeting by secret ballot papers, considering as elected he members who secure majority of votes
- b) The result of the election shall be notified to the elected members, by the managing committee in the presence of members.
- c) In case of equality of votes the senior members shall be considered elected.

**Art. 22. FUNCTION OF THE MANAGING COMMITTEE**

- a) To represent and manage the association affairs smoothly with accordance to the clause set up in these rules.
- b) The managing committee will be elected from among members.

**Art. 23. MEETING OF MANAGING COMMITTEE**

The managing committee will meet once in every month of the year.

**Art. 24. CO-OPTION:**

If at any time a vacancy is created in the managing committee, the managing committee shall have power to necessary arrangement by co-opting a member from general body for the remaining period providing that if any such vacancy occurs in managing committee.

**Art. 25. CONTRIBUTION/DONATION OF THE ASSOCIATION**

The income of the association will consist of:-

- a) Membership fees, income from feast and other activities.
- b) Grants, donations and income from any other sources.

**Art. 26. BANK ACCOUNT**

The income referred in the previous article shall be deposited in a bank selected by the general assembly and its amount shall be operated by two among the president, secretary and treasurer.

**Art. 27. AMENDMENTS**

No amendments to the memorandum of the association/rules and regulations will be made, which may prove to be repugnant to the provision of section 2(), 11 12& 13 and 80G of the income tax at 196, as amended for time to time. Further no amendment will be carried out without the prior approval of the commissioner of income tax. The society shall be repealed, altered or rescinded by 3/5<sup>th</sup> majority of the members present at the annual general meeting and in confirmatory of society registration act 1860.

**Art. 28. DUTIES OF THE OFFICE BEARERS:-**

**a) The President:-**

To preside over the general body meeting and managing committee meeting and it give direction.

- I. To control the function of the secretary of the association.
- II. To give necessary orders in the interest of association and do work.

**b) The Secretary:-**

- I. To call the meeting of the management committee, general body meeting and special body meeting.
- II. To implement the decision sanction by the managing committee and the general body meeting and to look after.
- III. To keep the membership register and look after all judicial work of the association and get to the audit done. To prepare annual budget and get it sanction from president, managing committee and general body meeting.
- IV. To look after property of the association and to help at the time of the difficulties.
- V. To control the workers of staff of the association and to have a supervision and to help them.
- VI. To prepare the law in the interest of the association, implement the resolution.

c) The Treasurer:

- I. To look after the all financial matters of the association.
- II. To collect the fee, gifts donation and to submit their receipts to the secretary regularly.
- III. To look after and controlover the transaction of the finance of the association.
- IV. To help the secretary to get the audit of the association done.

Art. 29. DISSOLUTION

In the event of dissolution or winding up of the society, the assets remaining as on the date of dissolution will under no circumstances be distributed among the members of managing committee/government body. But the same will be transferred to another society whose objects are similar to those of this society and which is duly registered under 80G of the income tax act, 1861 as amended from time to time.




