- 1. Name of Society: "GOA ROLL BALL ASSOCIATION"
- 2. Address of the Society: Anil Gaonkar , Flat No: FF2, HM Classic Housing society Sasnamodi Cacoda quepem South Goa 403706

3. Object of the Society:

- 1. To control, promote, standardize and popularize the game of Roll Ball throughout the state.
- 2. To maintain and raise the standard of the game.
- 3. To obtain National status.
- 4. To affiliate and maintain affiliation with Roll Ball Federation of India.
- 5. To authorized, organize and conduct thestate/National championship for Senior, Junior and Sub Junior for both gender.
- 6. To authorize, organize, grant permission and conduct Tournament for or through its affiliation at all levels.
- 7. To organize and conduct coaching and training classes and or camp of officials and the players.
