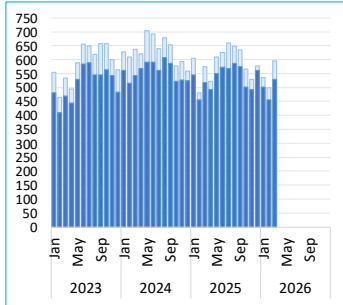

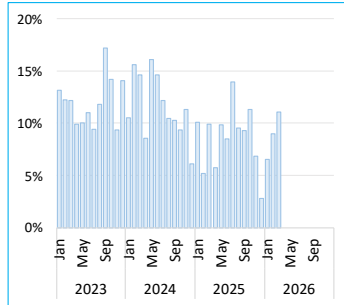

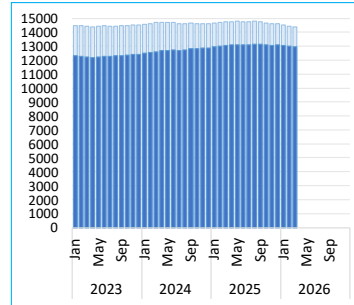

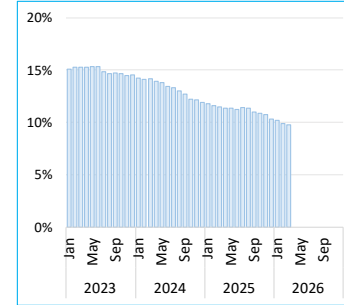

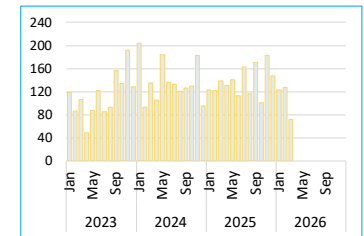

# Standard Setting Definition

- Standard: “An explicit decision rule that assigns each examinee to one of several categories of performance based on his or her test score” (Cohen, Kane & Crooks, 1999)
- It is relative to the difficulty of the test questions (not just the topic area in general) and the expected level of competence that the test is designed to assess.
- Also known as:
  - Passing point
  - Pass / Fail decision point
  - Cut score

# THE STANDARD SETTING PROCESS

- Angoff Method:
  - The cut score is based on the difficulty of the test content, relative to the expected competence of someone who passes vs. someone who fails.
  - Subject Matter Experts (SMEs) evaluate each item and estimate the proportion of minimally competent test-takers that would answer the question correctly.
    - The average of the raters' estimates becomes the item's predicted difficulty.
  - These mean difficulty values are averaged to result in the cut score.
    - If there are disagreements / discrepancies, another round of rating for some items may be necessary (Modified-Angoff).

# Subject Matter Experts

- As a Subject Matter Expert (SME), they bring:
  - Professional expertise as a pilot in Washington
  - Knowledge of the job role and the training program
  - Knowledge of the required qualifications of the candidates

*Imagine the level of competence that would be expected from someone with the required experience as a mariner, but new to the role of a BPC Pilot Trainee.*

# Standard Setting Results from Angoff Process

- Subject Matter Experts (SME) Panel:
  - $N = 5$
  - Active, licensed Washington State Pilots
- Process:
  - Each SME evaluates every item and gives an estimate of the difficulty.
  - These estimates are then averaged for each item, which results in the item's predicted difficulty.
  - These estimated difficulty ratings are then averaged to yield the estimated cut score.
  - It is the mean of the predicted difficulty values for all items.
  - It provides a conceptual reference for the “standard” of minimal competence expected.

**Meeting Minutes – Pilot Safety Committee (PSC)**

December 3, 2025 at 2:00pm

**1. Review of Minutes of previous meeting on August 12, 2025.**

The minutes were approved with one minor correction.

**2. Rest Rule Exceptions**

During 2025 Q3 in Grays Harbor there were zero (0) rest exceptions. `

During 2025 Q3 in Puget Sound there was one (1) exception to the 10 hour rest rule and one (1) exception to the 13 hour rest rule. The rest exception report showed three exceptions to the 10 hour rest rule, but Ivan Carlson explained that the 2<sup>nd</sup> and 3<sup>rd</sup> were documentation errors but not true rest exceptions. PSP will begin more frequent in-house review of rest exceptions in order to catch errors earlier. The one 10 hour rest exception that was not an error was only 2 minutes, but the committee counts all exceptions and does not use a “grace period” to screen out small exceptions. The BPC KPIs also count all rest exceptions no matter how small.

**3. Noncompliant Pilot Transfer Arrangements**

Pilots’ reports of noncompliant transfer arrangements from the 3rd quarter of 2025 were reviewed and discussed, as well as the Jotform data summary of the reports for the quarter. Attendees noted that the number of reports (15 for the entire quarter) was lower than usual and Scott Anacker described some of the improved compliance he has witnessed that is resulting in fewer reports of noncompliance.

**4. PSP Comp Days (continued from previous meetings)**

Bettina shared a chart showing de-identified individual pilot comp day balances. The median comp day balance is 17, and 60% of pilots have 0 to 24 comp days while 40% of pilots have higher comp day balances. The pilots with the highest comp day balances are age 60+. When pilots with many banked comp days retire, the total comp day balance decreases by several hundred.

Some pilots have zero comp days banked. It is usually necessary to burn 14 comp days when starting a period of Not Fit For Duty, but Ivan Carlson explained that an alternative when pilots have less than 14 comp days banked is to give up future ETO days. In no case are pilots expected to work hurt.

## **5. Adjournment/Next Meeting**

This was John Scragg's last PSC meeting as he is planning to retire and is passing the PSC baton to Kevin Riddle (the Board still needs to formally assign Capt. Riddle to the committee). Jaimie Bever thanked John for all of his work on the Board and BPC committees over many years.

The committee agreed to schedule the next meeting in early April, and review 2025 Q4 data and 2026 Q1 data at that meeting. Attendees checked their calendars in real time and decided the next meeting would be on Tuesday April 7 at 1:30pm for 1 hour.

The meeting was adjourned at 2:50pm.

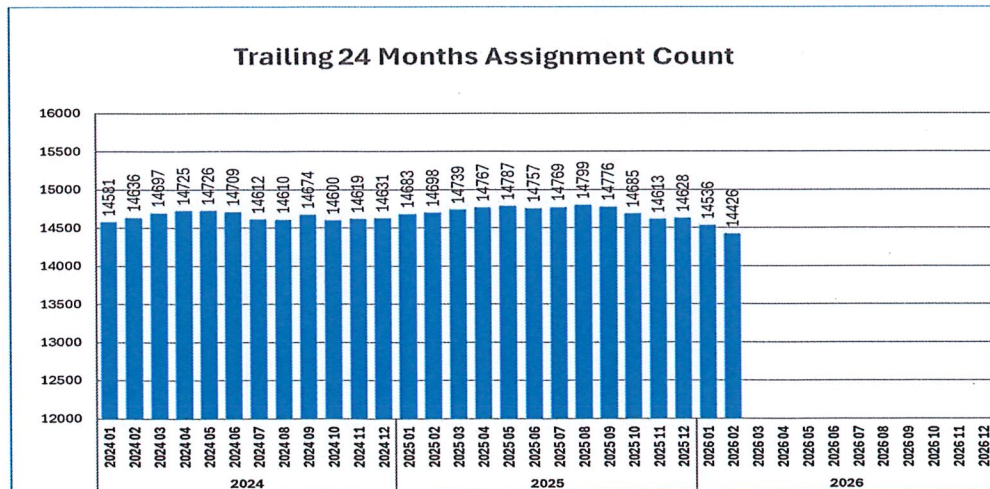
This document is provided as requested in the Instructions for Stakeholders adopted February 19, 2026. Puget Sound Pilots (PSP) provides this information to assist the Board of Pilotage Commissioners (BPC) in its deliberations to establish the authorized number of pilots for the coming two-year period.

To summarize PSP’s position, we support the BPC staff recommendation to authorize 60 licensed pilots in the Puget Sound Pilotage District. We arrived at this number by adjusting the trailing 24-month traffic through February 2026 to account for known changes, dividing by the TAL, and adding two pilots—one for the President and one for those not fit for duty.

**Background**

During the February 19, 2026, meeting, the BPC approved utilizing the trailing 24 months of assignments. Following this, the March 19 meeting included a staff presentation recommending pilot numbers based on the June 2024 unanimous vote of 123 TAL. To ensure consistency, PSP utilized the BPC-calculated 24-month average (March 1, 2024 – Feb 28, 2026) published on their website.

Below is a chart produced by the BPC showing the trailing 24 months of traffic, with the most recent 24 months at 14,426 assignments:



## Known and Verified Changes in Traffic

Pilot staffing is determined by taking the trailing 24 months of traffic, adjusted for known, verifiable changes in the coming year. TAL is applied to this projected traffic by dividing total assignments by 123, plus one position for the President and one for a pilot not fit for duty.

There is currently a high degree of uncertainty in the broader economic environment, particularly within the shipping industry. Recent policy changes, legal developments, and market fluctuations have made forward planning more challenging. Given these conditions, it is prudent to focus on changes that can be clearly supported and verified, rather than relying on assumptions about future developments.

Here is what can be verified for the coming year:

Attached is an Excel spreadsheet detailing the changes outlined in the Future Traffic table. The tabs within the spreadsheet are described below:

1. Calculator – Calculates the number of authorized pilots based on the trailing 24 months halved for a 12-month period (7213 assignments).
2. Cruise Trailing 24 - Shows the trailing 24 months of cruise traffic (1156 jobs) halved for a 12-month period (578).
3. POS 2026 Cruise Schedule – Shows the assignments for the 2026 cruise schedule (660). This represents 82 more assignments than Cruise Trailing 24 halved for 12-month period (578).
4. Seaspan LNG – Shows the number of anticipated LNG bunkering assignments (39).
5. Sun Chief – Shows the number of lost assignments with the loss of the Sun Chief Express service (52).
6. Evergreen Ad Hoc HTW Trailing 24 - Shows the trailing 24 months of the Evergreen Ad Hoc HTW service halved for a 12-month period (56).
7. ATB Sea Reliance – Shows the trailing 24 months halved for 12-month period (127).

## Calculation of Number of Pilots

The remaining steps are straightforward. The trailing 24-month traffic figure is adjusted to reflect verified changes, divided by 123, and then increased by two positions—one for the President and one for a pilot not fit for duty.

**Conclusion**

PSP agrees with staff analysis of maintaining 60 pilots. While the traffic calculation results in a lower assignment count than the trailing 24-month average, it is not a large enough reduction to change the number of authorized pilots.

Dear Chair Tonn and Commissioners:

We submit these comments for your consideration. It is important to state up front that PMSA continues to be concerned about the number of callbacks and delays incurred when the number of scheduled on-watch pilots significantly exceeds the average number of daily assignments. We note the timing of this BPC process and decision unfortunately coincides with the UTC rate case where one of the factors in the mix is the number of pilots. We fully support the separation of duties between BPC and UTC but also recognize the nexus on this issue and the potential to influence a rate decision. For the purposes of this letter, we focus on workload realities and data leading up to the August 2024 BPC analysis and decision compared to the significantly reduced workload realities at present.

I was unable to participate in the BPC meeting last month but have since reviewed meeting materials that include the staff recommendation to maintain the number of authorized licenses at 60. We appreciate the presentation of data that provides relevant insight to assignment trends. I realize the BPC chose to use the trailing 24 months data but would encourage a continuation of also tracking trailing 12 months which has more nexus to current pilotage demand.

**TAL On Watch, Off Watch – Both Matter**

PMSA has over the years provided comprehensive comments regarding the setting of the number of pilots utilizing data primarily sourced from PSP and BPC documents. Our efforts included submittals and comments leading up to and during the August 2024 BPC decision to set the on-watch TAL at 123 with off-watch or callbacks of up to 5% or 6 assignments for a total of up to 129 per pilot. The differential between 123 and 129 represents nearly 3 pilots (currently  $6 * 55$  working pilots = 330 assignments). We request that BPC avoid solely focusing on the on-watch TAL. PSP and BPC Staff have documented calculations using the formula of: Trailing 12 months assignments \* 0.95 with the result divided by 123 so this approach of considering the 5% off watch has relevancy as there will be some level of callbacks in the mix going forward.

**Current Workload Compared to Workload Prior to the August 2024 BPC TAL Decision**

- Trailing 12 months through February is 640 fewer assignments than it was in August of 2024
  - This is equivalent to 5 fewer pilots
- Trailing 24 months through February is 186 fewer assignments than it was in August of 2024
  - This is equivalent to 1.5 fewer pilots
- If consistent with the August 2024 BPC decision, these workload reduction realities would logically lead to a number of pilots reduction range of between 1.5 and 5 pilots
- But in addition to these realities there are projected further decreases based on announcements summarized in the next section.

### **Forecast Traffic by Trend Analysis and Modified by Announcements**

The vessel traffic forecast shows a reduction in ship calls and therefore assignments. Calendar year 2025 had 2,434 ship calls and 7,036 assignments. We applied a multiple year trend analysis of arrivals in addition to using a multiplier of arrivals to project assignments (arrivals, departures, shifts, second pilots, cancellations). Using this methodology, PMSA forecasted a reduction of assignments to 6,972 in 2026 – [see the attached analysis](#) to walk through these calculations.

In addition, there are announcements regarding services including cruise and container services in addition to the ATB service reduction already reported by PSP and finally some potential adjustment to the LNG refueling operation to be conducted by Seaspan. In total, these announcement would decrease assignments by 143 which is equivalent to the reduction of just over one more pilot. Here is a summary of the announcements:

- Cruise ship calls will increase – PSP forecasted 60 additional assignments
- Evergreen HTW service shifting out of PNW to Oakland and LA (loss of up to 80 assignments)
  - The most recent service in this string involved a 15K plus TEU class vessel which required two pilot inbound and two pilots outbound. If operated weekly that would generate 208 assignments annually.
  - Evergreen stated on April 7<sup>th</sup> (yesterday) that there are no plans at this time to resume service later this year
  - NWSA noted that this service operated up to 5 months each year. With the largest class vessel that was being used, that would be a loss of up to 80 assignments (2 in, 2 out, 20 weeks)
- UWL and ESL announced that the Sun Chief Express service, connecting Vietnam and South China to Seattle concluded operations on March 20, 2026. This means the loss of the fortnight service and a decrease of 52 assignments on an annualized basis.
  - Earlier announcement of transitioning from fortnight to weekly service was reversed to a total shut down of the service based on market conditions.
- Voids outpacing Ad Hoc calls by more than 3 to 1 (potential loss of 100+ assignments)
  - NWSA indicates a void to ad hoc sailings comparison of 38 to 11 or more than triple. If this volume/trend continues this would project a loss of approximately 50 port calls compared to 2025 (estimated reduction of 100 assignments unless 2 pilots required which would further decrease assignments)
- LNG Refueling (addition of 29 to 39 assignments)
  - Seaspan plans 13 refueling operations initially weekly service including a transit to anchor so 3 assignments per evolution
  - Seaspan stated they would run through the refueling operation a couple of times and then look to reduce it to bi-weekly and perhaps schedule arrival to Elliott Bay timed with the arrival of the cruise ship to avoid the stay at anchorage.

Lastly, there are container cargo volume reductions which need to stabilize or start growing if we are to avoid further loss of container calls through service changes or management via void sailings. One need only look at TEU volume reports put out by NWSA, PMSA and others to see the trend particularly in the PNW.

The reduction in pilot assignments since the August 2024 BPC decision is significant. The magnitude of reduction reasonably leads to the need to reduce the number of pilots if being consistent with the 2024 decision. Using a longer time period like trailing 24 months will produce a higher number of assignments given the peak year of 2024 but with each succeeding month, a high assignment month in 2024 will be replaced by a lower assignment month in 2026. The BPC can reduce or increase the

number of pilot licenses as frequently as it sees fit and in fact did so just 10 years ago with the number of pilots adjusted a couple of times in a few short months. There is every opportunity for the BPC to adjust to the traffic conditions to right size the pilot corps as it sees appropriate. We urge the BPC to do the logical thing and right size the number of pilot licenses to the current realities and pilotage demand.

# PMSA Vessel Projections for 2026

1       **A. PMSA Vessel Projection for 2026.**

2  
3       **Q: Did PSP provide any projections of vessel activity after 2025 for use**  
4       **in a rate year?**

5       A: No. WAC 480-07-525(4)(m) requires a work paper with “[p]rojected changes  
6       in vessel assignments.” PSP failed to provide this. Its testimony on vessel  
7       traffic was limited, outdated, inaccurate, and did not project any changes in  
8       vessel assignments beyond 2025.

9  
10      **Q: Is PMSA providing a detailed analysis of projected changes in**  
11      **vessel assignments in lieu of PSP’s missing work papers?**

12      A: Yes.

13  
14      **Q: What is PMSA providing as the source of this analysis?**

15      A: The source data is from the Marine Exchange of Puget Sound, as provided  
16      in the testimony of John Veentjer (Exhibit JV-01T). In my testimony, I  
17      analyze that data to develop vessel traffic projections, supported by  
18      worksheets submitted as exhibits.

19  
20      **Q: What data in Exhibit JV-01T does the Marine Exchange collect**  
21      **regarding vessel arrivals?**

22      A: The Marine Exchange data includes annual vessel arrivals at Puget Sound  
23      ports (excluding Grays Harbor) for each calendar year from 2005 through  
24      2024, plus the latest data for 2025. This data is presented in the  
25      attachments to Exhibit JV-01T.

26

1 **Q: What are the key observations of the Marine Exchange data over**  
2 **this 20-year period?**

3 A: The data shows vessel arrivals ranging from a low of 2,159 arrivals in 2020  
4 (the COVID-19 pandemic year) to a high of 2,994 arrivals in 2006. The 20-  
5 year average is approximately 2,612 arrivals per year. The most recent  
6 complete year, 2024, shows 2,486 arrivals, while the Marine Exchange data  
7 for 2025 indicates 2,434 arrivals.

8

9 **Q: Does the Marine Exchange data show vessel arrivals increasing or**  
10 **decreasing in recent years?**

11 A: The Marine Exchange data points to 2,434 arrivals for 2025, which  
12 represents a decline of 52 arrivals (-2.1%) from the 2024 level of 2,486  
13 arrivals.

14

15 **Q: Is there data available showing PSP pilot assignments over the**  
16 **same time period?**

17 A: Yes. PSP pilot assignment data is available from multiple sources including  
18 BPC Annual Reports, PSP Monthly Activity Reports, PSP financial reports  
19 submitted in prior rate cases, and testimony in prior proceedings. This data  
20 is compiled in Exhibit MM-27, the AAL Worksheet.

21

22 **Q: How do vessel arrivals reported by the Marine Exchange correlate**  
23 **to pilot assignments reported by PSP?**

24 A: A vessel arrival is a single event: a vessel calling at a Puget Sound port. In  
25 contrast, PSP pilot assignments include multiple events: the inbound and

26

1 outbound transits, internal movements (e.g., shifting berths), second pilot  
2 assignments, and cancellations.

3  
4 **Q: Is there a mathematical relationship between Marine Exchange**  
5 **arrivals and PSP assignments?**

6 A: Yes. Over the 20-year period from 2005 through 2025, there is a consistent  
7 correlation between the number of vessel arrivals reported by the Marine  
8 Exchange and the number of pilot assignments reported by PSP.

9 For the years 2005 through 2025 (excluding the 2020 pandemic  
10 anomaly), the ratio of PSP pilot assignments to Marine Exchange vessel  
11 arrivals ranges from a low of 2.732 in 2009 to a high of 3.138 in 2015, with  
12 an average of 2.88. This correlation is detailed in Exhibit MM-23r.

13  
14 **Q: What does a ratio of 2.88 mean?**

15 A: It means that, on average, for every vessel arrival recorded by the Marine  
16 Exchange, PSP completes approximately 2.88 pilot assignments. This  
17 accounts for both the inbound and outbound transits, plus shifts, second  
18 pilot assignments and cancellations.

19  
20 **Q: How stable is this correlation over the 20-year period?**

21 A: The correlation is quite stable. There is relatively low variance around the  
22 average ratio of 2.88. The median ratio is 2.87, very close to the average,  
23 which confirms the consistency of this relationship.

24  
25 **Q: Has the correlation changed in recent years compared to the**  
26 **historical average?**

1 A: The data shows a slight increase in recent years. The average ratio for the  
2 pre-COVID period (2005-2019) was 2.85, while the average for the post-  
3 COVID period (2021-2025) is 2.96.  
4

5 **Q: Does PSP have actual pilot assignment data for 2025?**

6 A: Yes. In response to PMSA Data Request No. 98,<sup>134</sup> PSP provided its actual  
7 pilot assignments for the trailing twelve-month period from December 2024  
8 through November 2025, which totaled 7,016 assignments.  
9

10 **Q: How does this actual 2025 data compare to what the Marine  
11 Exchange correlation would predict?**

12 A: The Marine Exchange data indicates 2,434 vessel arrivals for 2025. Using  
13 the 20-year average correlation ratio of 2.88, this would predict 7,001 pilot  
14 assignments. PSP's actual trailing twelve-month data through November  
15 shows 7,016 assignments, which is 99.789% correlated and only 15  
16 assignments (00.221%) higher than the Marine Exchange methodology  
17 would predict.  
18

19 **Q: What is the actual correlation ratio for 2025 based on PSP's  
20 reported data?**

21 A: Dividing PSP's actual 7,016 assignments by the Marine Exchange's 2,434  
22 anticipated arrivals yields a ratio of 2.882, which is essentially the same as  
23 the 20-year average of 2.88.  
24  
25

1 **Q: What does this tell us about the predictive accuracy of the vessel**  
2 **arrival to assignment correlation methodology?**

3 A: It demonstrates that the Marine Exchange vessel arrival data, combined  
4 with the historical correlation ratio, provides a highly accurate method for  
5 predicting PSP pilot assignments, with less than 1% variance from actual  
6 results.

7  
8 **Q: What methodology does PMSA propose for projecting vessel traffic**  
9 **and pilot assignments for the potential rate years 2026 and 2027?**

10 A: PMSA proposes using trend line analysis (also called “hindcasting”) based  
11 on historical Marine Exchange vessel arrival data, combined with the  
12 proven 20-year correlation ratio of 2.88.

13  
14 **Q: What is trend line analysis or “hindcasting”?**

15 A: Trend line analysis, or hindcasting, is a standard forecasting method that  
16 uses historical data to identify trends and extend them forward to make  
17 projections.

18  
19 **Q: Why is trend line analysis appropriate for projecting vessel traffic?**

20 A: Trend line analysis is particularly appropriate when there is sufficient  
21 historical data to establish reliable patterns, when the underlying factors  
22 affecting the data remain relatively consistent, and when the goal is to  
23 make conservative, data-driven projections rather than speculative  
24 forecasts.

25  
26 **Q: What historical data period does PMSA use for this analysis?**

1 A: PMSA analyzed Marine Exchange vessel arrival data from 2005 through  
2 2025, excluding calendar year 2020 as an anomaly due to the COVID-19  
3 pandemic. The 2025 data represents PSP's actual trailing twelve-month  
4 assignments from December 2024 through November 2025 (7,016  
5 assignments), converted back to vessel arrivals using the established  
6 correlation ratio.

7

8 **Q: Why is 2020 excluded from the analysis?**

9 A: Consistent with Commission precedent (Final Order 08), we exclude 2020  
10 because vessel traffic was distorted by the COVID-19 pandemic. Including  
11 this anomalous data (2,159 arrivals vs. 2,554 in 2019 and 2,340 in 2021)  
12 would produce unreliable projections, and excluding outliers is standard  
13 statistical practice.

14

15 **Q: What are the trend line forecast alternatives that you looked at?**

16 A: We analyzed three trend lines based on different historical periods: a 20-  
17 year trend, a 10-year trend, and a 5-year trend (all excluding 2020). Longer  
18 periods capture broad, structural changes, while shorter periods reflect  
19 recent market conditions. Presenting all three allows the Commission to  
20 evaluate which best projects traffic for the rate years.

21

22 **Q: Please describe the 20-year trend analysis.**

23 A: The 20-year trend analysis uses Marine Exchange data from 2005 through  
24 2025 (excluding 2020), providing 20 data points. The 2025 data point  
25 represents PSP's actual trailing twelve-month assignments (7,016)  
26 converted to vessel arrivals. This analysis is presented in Exhibit MM-24.

1 **Q: What does the 20-year vessel arrival trend show?**

2 A: The 20-year trend shows a declining pattern of vessel arrivals, with an  
3 average decline of approximately 30 arrivals per year. The 20-year trend  
4 projects 2,315 vessel arrivals in 2026 and 2,285 arrivals in 2027. Using the  
5 established correlation ratio of ~~2.8761~~ 2.8764:

- 6 • 2026: 2,315 arrivals × ~~2.8761~~ 2.8764 = ~~6,658~~ 6,659 pilot assignments
- 7 • 2027: 2,285 arrivals × ~~2.8761~~ 2.8764 = 6,573 pilot assignments

8  
9 **Q: Please describe the 10-year trend analysis.**

10 A: The 10-year trend analysis uses Marine Exchange data from 2015 through  
11 2025 (excluding 2020), providing 10 data points. This analysis is presented  
12 in Exhibit MM-25r.

13

14 **Q: What does the 10-year vessel arrival trend show?**

15 A: The 10-year trend shows a more modest declining pattern, with an average  
16 decline of approximately 10 arrivals per year. The 10-year trend projects  
17 ~~2,421~~ 2,424 vessel arrivals in 2026 and ~~2,410~~ 2,414 arrivals in 2027.

18 Applying the correlation ratio of 2.8761:

- 19 • 2026: ~~2,421~~ 2,424 arrivals × 2.8761 = ~~6,962~~ 6,972 pilot assignments
- 20 • 2027: ~~2,410~~ 2,414 arrivals × 2.8761 = ~~6,932~~ 6,944 pilot assignments

21

22 **Q: Please describe the 5-year vessel arrival trend analysis.**

23 A: The 5-year trend analysis uses Marine Exchange vessel arrival data from  
24 2019 and 2021 through 2025 (excluding 2020), providing 6 data points. This  
25 analysis is presented in Exhibit MM-26r.

26

1 **Q: What does the 5-year trend show?**

2 A: The 5-year trend shows a decline of approximately 11 arrivals per year. The  
3 5-year trend projects ~~2,413~~ 2,423 vessel arrivals in 2026 and ~~2,402~~ 2,412  
4 arrivals in 2027. Applying the correlation ratio of ~~2.8761~~ 2.8764:

- 5 • 2026: 2,413 arrivals × ~~2.8761~~ 2.8764 = ~~6,941~~ 6,970 pilot assignments
- 6 • 2027: 2,402 arrivals × ~~2.8761~~ 2.8764 = ~~6,908~~ 6,938 pilot assignments

7  
8 **Q: Do all three trend analyses point in the same direction?**

9 A: Yes. All three trend analyses show declining vessel arrivals, differing only in the  
10 rate of decline. The projections for 2026 assignments range from ~~6,658~~ 6,659  
11 (using the 20-year vessel arrival trend) to ~~6,962~~ 6,972 (using the 10-year vessel  
12 arrival trend), a span of only ~~304~~ 313 assignments or approximately ~~4.6~~ 4.7%.

13

14 **Q: How do these projections compare to current actual data?**

15 A: PSP's actual trailing twelve-month data (December 2024 through November  
16 2025) shows 7,016 assignments, which is included as the 2025 data point in  
17 all three trend analyses. All three trend projections show continued decline  
18 from this level:

- 19 • 20-year trend: ~~6,658~~ 6,659 for 2026 (5.1% below 2025 actual)
- 20 • 10-year trend: ~~6,962~~ 6,972 for 2026 (0.8 0.6% below 2025 actual)
- 21 • 5-year trend: ~~6,941~~ 6,970 for 2026 (1.1 0.7% below 2025 actual)

22

23 **Q: What are the arguments in favor of and against using the 20-year**  
24 **vessel arrival trend?**

25 A: The 20-year trend has several strengths. It captures long-term structural  
26 changes in the maritime industry, including shifts in global trade patterns,

1 changes in vessel sizes, and evolution of supply chains. It also provides the  
2 most conservative projection, which is appropriate for rate-making purposes  
3 where the goal is to avoid over-recovery. Finally, it encompasses complete  
4 business cycles, including the 2008-2009 financial crisis and recovery,  
5 providing a more complete picture of market dynamics. And, with 20 data  
6 points including actual 2025 data, it has the most robust statistical  
7 foundation.

8 The main question is whether conditions from 2005-~~2010~~ 2015 remain  
9 relevant to current and future vessel traffic patterns. Maritime trade has  
10 evolved significantly over this period, and it is my opinion that the more recent  
11 data better reflects current market realities with respect to vessel arrivals.

12  
13 **Q: What are the arguments in favor of and against using the 10-year**  
14 **vessel arrival trend?**

15 A: The 10-year trend balances historical perspective with current relevance. It  
16 reflects the post-Great Recession “new normal” and the market conditions  
17 which have been in place through at least one typical business cycle  
18 between the Great Recession and the COVID pandemic. Its more moderate  
19 declining trend may also better represent current realities, including the  
20 rise in cruise ship calls that masks steeper declines in cargo traffic. With 10  
21 data points, it has a solid statistical foundation.

22  
23 **Q: What are the arguments in favor of and against using the 5-year**  
24 **trend?**

25 A: The 5-year trend’s strength is its focus on the most recent market  
26 conditions, including the post-pandemic recovery and current trade

1 dynamics. However, its primary limitation is the small dataset, which  
2 makes the projection more susceptible to short-term fluctuations and less  
3 statistically reliable.

4  
5 **Q: Of the three trend analyses presented here, which does PMSA**  
6 **recommend the Commission use for projecting vessel traffic and**  
7 **pilot assignments for rate years 2026 and 2027?**

8 A: PMSA recommends the Commission use the 10-year trend analysis at  
9 Exhibit MM-25r, which projects ~~6,962~~ 6,972 pilot assignments for 2026 and  
10 ~~6,932~~ 6,944 assignments for 2027.

11  
12 **Q: Why does PMSA recommend the 10-year vessel arrival trend over**  
13 **the 20-year or 5-year alternatives?**

14 A: The 10-year vessel traffic trend provides the optimal balance of statistical  
15 reliability and relevance to current market conditions. It uses a robust 10-  
16 point dataset (2015-2025) that reflects the modern post-recession maritime  
17 trade environment. Most importantly, its projection is validated by actual,  
18 recent data.

19 The 10-year trend projects ~~6,962~~ 6,972 assignments for 2026, which is  
20 within ~~0.8~~ 0.6% of PSP's actual 2025 assignment total (7,016) and nearly  
21 identical to the projection derived from the 20-year assignment-to-arrival  
22 correlation (~~6,992~~ 2,434 × 2.8764 = 7,001). This tight clustering of results  
23 from independent data points provides high confidence that ~~6,962~~ 6,972  
24 assignments is the most reasonable and reliable projection for 2026.

1 **Q: Is the 10-year trend the “middle ground” among the three**  
2 **alternatives?**

3 A: Yes, the 10-year trend occupies the middle ground because it appropriately  
4 balances competing considerations. The 10-year trend projection is very  
5 close to the 5-year trend’s result (a difference of only 21 assignments) but is  
6 based on a much larger and more statistically reliable dataset. It is  
7 therefore not just a middle ground, but the most analytically sound  
8 approach available.

9

10 **Q: What vessel traffic and pilot assignment levels does PMSA**  
11 **recommend the Commission use for rate-setting purposes for the**  
12 **next rate year?**

13 A: PMSA recommends the Commission use the 10-year trend projections of:

- 14 • 2026: ~~6,962~~ 6,972 pilot assignments
- 15 • 2027: ~~6,932~~ 6,944 pilot assignments

16 These projections are based on objective vessel arrival data, proven 20-year  
17 correlation methodology with ~~99.65~~ 99.8% accuracy (7,001/7,016), standard  
18 statistical techniques, and actual 2025 trailing twelve-month experience.  
19 We provide both 2026 and 2027 as the proposed rate year is likely to  
20 straddle both.

21

22 **Q: Would it be in ratepayers’ short-term financial interest for the**  
23 **Commission to accept PSP’s higher projection of 7,446 assignments?**

24 A: Yes, actually it would. In a revenue requirement proceeding, once the  
25 Commission determines the total dollar amount of revenue PSP is entitled  
26 to collect, that amount is divided by the projected number of assignments to

1 calculate the tariff rates per vessel tonnage or per bridge hour. A higher  
2 number of assignments in the denominator results in a lower rate per  
3 customer. So, if the Commission were to accept PSP's projection of 7,446  
4 assignments, the rate per vessel would be lower than if the Commission  
5 adopts PMSA's projection of ~~6,962~~ 6,972 assignments.

6  
7 **Q: Given that accepting PSP's higher projection would result in lower**  
8 **rates for PMSA's members, why is PMSA advocating for a lower**  
9 **assignment projection?**

10 A: Because PMSA is committed to providing the Commission with the most  
11 accurate, evidence-based projections possible. While inflated projections  
12 might lower per-vessel rates in the short term, they undermine the integrity  
13 of the regulatory process. Rates should be based on the best available  
14 evidence, not unsupported guess-timates. Accurate projections ensure stable  
15 rates for ratepayers, appropriate workloads for pilots, and sound decisions  
16 by the Commission.

17 PMSA's projections are based on objective data from the Marine  
18 Exchange-an independent, non-profit organization with no stake in this  
19 proceeding whose data is widely used and trusted for operational and safety  
20 analysis in Puget Sound.

21 As demonstrated, our vessel-to-assignment correlation has ~~99.65~~ 99.8%  
22 accuracy against two decades of PSP's own data, and our recommended  
23 projection (~~6,962~~ 6,972 assignments) converges with the results of that  
24 correlation analysis (~~6,992~~ 7,001 assignments). This convergence of  
25 independent methods provides a reliable, evidence-based foundation for  
26 ratemaking.
