- Water Quality Susan Urquhart, Tom Lettieri, Tommy Bell, Steve Blaskowski Legal Victory Requires EPA to Reconsider Outdated Industrial Water Pollution Standards SAN FRANCISCO— The 9th Circuit Court of Appeals ruled today that the Environmental Protection Agency acted unlawfully in declining to update water pollution control standards for seven major industries. The industries include petroleum refineries, inorganic and organic chemical manufacturers, and factories that manufacture plastics, fertilizer, pesticides and nonferrous metals.

The court additionally determined that the EPA acted arbitrarily when it failed to consider the role that stormwater runoff plays in pollution from the plastics industry. The ruling also found that the existing standards for reducing plastic pollution are significantly less strict than the scientific information demonstrated they could be. As the plastics industry has continued to ramp up plastic pollution in this

country, an estimated 8 million tons of plastic enters our oceans every year, and it's expected to outweigh all the fish in the sea by 2050.
