

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.robinspetsquad.com](http://www.robinspetsquad.com), and Robins Pet Squad L.L.C. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Robins Pet Squad L.L.C. include [www.robinspetsquad.com](http://www.robinspetsquad.com), R.P.S. LLC, Pet Squad K9 Training L.L.C. and [www.petsquadk9training.com](http://www.petsquadk9training.com). The R.P.S. LLC website is a Dog walking, Pet Sitting, Boarding, Dog Training site. By using the R.P.S. LLC website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, R.P.S. LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. ## Use of your Personal Information

## Sharing Information with Third Parties

R.P.S. LLC does not sell, rent or lease its customer lists to third parties.

R.P.S. LLC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. ### **Tracking User Behavior**
