1. Introduction

Welcome to the official website at <https://makemoderatesmatter.com> (the “Website”) for Make Moderates Matter LLC (“we”, “us”, “our” or “MMM”).

We understand that visitors to our Website and Social Media Sites may have questions about how we collect and use information. We are committed to safeguarding the privacy of our supporters’ information. This Privacy Policy and Terms and Conditions (“Policy”) explains our privacy practices and the terms under which you may access and use the Website and Social Media Sites. The Policy includes: the type of information we may collect from you when you use the Website and Social Media Sites; how we may use that information; the third parties with whom we may share or disclose such information; and your preferences regarding our use and disclosure of such information. The Policy also includes certain other terms and conditions that apply when you use the Website and Social Media Sites such as disclaimers, limits on liability and governing law.

By accessing the Website and/or Social Media Sites, you understand and agree that your use thereof is governed by this Policy. This Policy only applies, however, to how we are handling your data. The companies that host our Social Media Sites each have their own privacy policy and/or terms and conditions that apply to how they use your data for their own purposes, and those policies include but are not limited to the following:

This Policy only applies to the information collected by us and any third parties acting with our authorization, which includes GoDaddy Operating Company, LLC and its affiliates (“GoDaddy”), which is the company we use to host the Website. This Policy applies regardless of the computer, mobile phone, tablet, or other electronic device (“Device”) you use to access the Website or Social Media Sites.

From time to time, we may update this Policy and we encourage you to periodically check this Policy for updates. Your continued use of the Website and/or Social Media Sites affirms your agreement to any changes we make to this Policy.

2. Information We Collect About You

a. Information You Choose to Provide to Us. We collect any comments, information or material of any type that you provide to us by email, through the communication tools on the Social Media Sites or any other way. For example, we collect your name and email address when you subscribe to our Website and any other information you may submit when you contact us with comments or questions or subscribe to us through Substack. All such communications are done at your own risk and without any expectation of privacy.

b. Usage Data and Technical Information. The Website and Social Media Sites include features that automatically collect certain information, which may include the unique Device identifier assigned to your Device, IP address, browser type, operating system, referring URLs, and timestamps of access. The Social Media Sites may collect audience demographics (such as age, gender, location, language of followers), content performance (likes, comments, shares, video views, clicks), page growth (new followers or subscribers, page visits), and engagement trends (when our audience is most active). The Website and Social Media Sites may use “cookies” (which are small data files containing information about you that is stored on your hard drive), “embedded scripts,” “pixel tags,” and other similar tracking technologies (collectively, “Tracking Technologies”) to collect information automatically as you interact with the Website. Such information may include behavioral data such as clicks and individual page visits and other relevant statistics. Tracking Technologies also collect aggregated, anonymized data to improve the performance of the Website or Social Media Sites, such as page loading speed. Such information may be collected by us and/or by the companies that provide the Social Media Sites.

3. How We Use Information That We Collect

We will not sell your personal information to anyone. In addition, we will not share your personal information with any third parties except GoDaddy solely for purposes of providing and supporting the Website, and with the companies that provide our Social Media Sites solely for the purposes of supporting those sites and pursuant to their own terms and conditions and privacy policies.

Except as subject to Section 4, we may use information we collect for, among other things, the following purposes:

- a. Notifying you about new posts, videos and information;
- b. Responding to your questions, comments or other requests;
- c. Preventing and detecting fraud or infringement of our or any third party’s rights;
- d. For other purposes disclosed at the time you provide us with information or which are reasonably necessary to provide the Website and/or Social Media Sites;
- e. Accumulating and reporting aggregate, statistical information in connection with user activity;
- f. Analyzing usage to help us operate, enhance and improve the Website and Social Media Sites; and
- g. Subject to applicable contractual or legal restrictions, in connection with a sale of all or substantially all of the assets of MMM.

Substack has indicated that it generally considers itself to be the data processor because it processes personal data on behalf of publishers like us to whom it has provided tools and features to control and determine our relationship with our subscribers.

4. Opting-Out of Certain Uses of Your Information

a. Marketing and Promotional Communications. The Website allows users to subscribe to receive promotional communications including email notices when a new video is posted. We also may email you if you submit a question or comment to us via the website “Contact Us” form. You may discontinue any further communications from us at any time by clicking “Unsubscribe” at the bottom of your email from us or by sending an email with “Unsubscribe” in the subject line to Doug@MakeModeratesMatter.com. Please note that “Unsubscribe” requests may not take effect immediately and may take a reasonable amount of time to receive, process, and apply.

If you contact us through one of our Social Media Sites, we may respond through the communication tools provided by the Social Media Site. In these instances, your interactions with us are governed by both this Policy and by the privacy policy and terms and conditions of the company that provides the applicable communication tool you use.

You can unsubscribe from our publication on Substack at any time by clicking the “unsubscribe” link at the bottom of any email. You may have rights to access, correct, or delete your personal information under applicable data protection laws. For requests related to data held by Substack, you may need to contact Substack directly. For data we control (e.g., if you email us directly), contact us at Doug@MakeModeratesMatter.com.

b. Privacy Preferences. You may change certain privacy preferences (e.g., choose to cease receiving communications) by sending an email to us at Doug@MakeModeratesMatter.com detailing your privacy request. If you ask us to stop using your personal information, we will honor that request, provided that we may retain a record of such information as necessary to comply with applicable law and we may continue to use your contact information to respond to your requests.

c. Opting-Out of Use of Certain Information That May be Collected by Tracking Technologies.

(i) **Tracking Technologies:** Most browsers are initially set to accept cookies (other than Flash cookies) and allow local storage, but you should be able to change your settings to notify you when a cookie is being set or updated, local storage is being used, and/or to block cookies and/or the use of local storage altogether. Please consult the “Help” section of your browser for more information. Please note that by blocking any or all cookies you may not have access to certain features or content available through the Website.

(ii) **Flash Cookies:** Users can manage the use of Flash technologies, with the Flash management tools available at Adobe’s website, see <https://www.macromedia.com/support/documentation/en/flashplayer/help/help09.html>.

(iii) **Do-Not-Track Signals:** Certain browsers transmit “do-not-track” signals to the websites with which such browsers communicate; however, this feature, and how it is used and activated, varies from browser to browser. Therefore, it is not clear whether the signals are intentionally

transmitted by a user, or whether a user is even aware of this. Despite current efforts, there is still disagreement amongst leading internet standards organizations, industry groups, technology companies and regulators, concerning what, if anything, websites should do when they receive such signals and no standard has been adopted to date. We take privacy and security very seriously. With respect to “do not track signals,” we currently do not take action in response to these signals, but if a standard is established and accepted, we may reassess how to respond to these signals.

5. Sharing and Disclosure of Information We Collect

a. Disclosure to Third Parties. We will not sell your personal information to anyone. In addition, we will not share your personal information with any third parties, except for GoDaddy solely for purposes of providing and supporting the Website, and the companies that provide the Social Media Sites solely for purposes of supporting those Sites and pursuant to their own terms and conditions and privacy policies.

b. Additional Disclosures. There may be instances when we may access or disclose information without providing you a choice in the following circumstances: (i) to protect or defend the legal rights or property of MMM; (ii) to protect the safety and security of our Website and users; (iii) to protect against fraud or for risk management purposes; (iv) if we believe your actions violate this Policy; or (v) to comply with law or legal processes.

6. Data Collection from Children

This Website and the Social Media Sites comply with the Children’s Online Privacy Protection Act of 1998. We do not knowingly contact or collect personal information from children under the age of 13 without appropriate parental notice and consent, and our Website and Social Media Sites are not intended to solicit information of any kind from children under the age of 13. If we are informed that we have unintentionally received personal information from a child under the age of 13, we will delete that information. While no data transmission over the internet is 100% secure from intrusion, we maintain reasonable physical, electronic, and procedural safeguards to protect your information. However, it is possible that third parties may unlawfully intercept or access transmissions or private communications despite our efforts to prevent this, and we, therefore, make no guarantees regarding the security of user information.

8. Your California Privacy Rights

We will not accept requests via telephone or by fax. We are not responsible for notices that are not labeled or sent properly or do not have complete information.

9. Location and Usage of The Website

We are based in the United States and the Website and Social Media Sites are operated and administered by us within the United States. The Website and Social Media Sites are also directed to users who are United States residents and this Policy is intended for them.

10. Integration of Third-Party Platforms and Website

The Website and Social Media Sites may be linked to, rely on, and/or be integrated with other websites, applications, interfaces, services, and/or platforms operated by third-party companies (“Third-Party Platforms”). For example, our Website, the descriptions in our videos on YouTube and our publications on Substack may include citations with links to magazine and newspaper articles and websites for political parties and organizations. When you click these links, you will be directed to an external website. We are not responsible for the privacy practices of any Third-Party Platforms that are linked to, rely on, and/or are integrated with our Website or Social Media Sites. Once you leave the Website or Social Media Site via such a link and access a Third-Party Platform, you are subject to the terms and privacy policy of the new site, and should check those documents to determine, among other things, how the third party will handle any personally identifiable or other information that it may collect from you. In addition, as noted above, the companies that host our Social Media Sites may collect data about your viewing habits and other information as described in their own privacy policies. 11. Policy Changes

15. User Content and Interactions

- h. that reveals private information of any third party, including without limitation, addresses, phone numbers, email addresses, social security numbers, and credit card numbers.

You are solely responsible for your use of the Communication Tools and use them at your own risk.
