- If you need to make any demographic changes or add/change members please do so once you are logged in, before checking out.
- Key fobs will not be reissued for returning members. If a member's is lost or misplaced a \$5 per fob replacement fee will be assessed.
- Please remember to join prior to May 1, 2026 to take advantage of our spring rates! After May 1st a late fee of \$40 will be incurred.
- Don't forget to purchase your guest passes in advance to get the \$7 discounted rate. Guest passes are good for (2) seasons. **Guests Passes will not be accepted on Game Day.**

MEMBERSHIP PASSES

All memberships MUST be 100% paid in full prior to activation of key fobs for the 2026 season and pool admittance. Under NO circumstances will ANY family member be admitted into the pool under a membership that has payment outstanding, including late fees. Please do not drop off your teens or other family members with a membership that is not valid. There will be NO exceptions to this rule. Also please remember to always have your membership passes, as NO members will be allowed into the pool without them.

IMPORTANT NOTICE FOR STOCKHOLDERS:

Please remember the inactive membership policy: According to our bylaws, "There shall be a \$50.00 Inactive Membership fee assessed to any member that does not become active during each season. All members shall be notified of such an assessment each year in the Splash and dues notices. Should unpaid fees meet or exceed the par value of the stock, the members stock shall be recalled." After four years of inactivity your stock value will be \$0. Please don't let your stock value depreciate!






