## 7. Damages and Liability

The Host will provide a Guest Damage Insurance Policy for any damages up to \$1500.

Guest is responsible for any damages caused to the Property or its contents which exceed \$1500 or which are not covered by the insurance policy. The Host is not liable for accidents, injuries, or loss of personal property.

## 8. Cancellation Policy
