I would like to thank you for meeting me. I know it is probably in protest but thank you, nonetheless.

I am going to read this statement verbatim and will supply you with this exact copy afterwards. I only ask that you wait until I am finished to scoff, applause, scream, cry, or anything else and then you may have your say and I will respect your time to speak with the same respect I am asking of you now.

Attached you'll find the evidence that shows Nicole now has an adrenal nodule that on April 6th, 2023, measured 23mm x9mm showing a growth rate of 6.42mm/year which is significantly above the threshold of 5/mm growth a year established in multiple studies to be indicative of a malignant adrenal growth.

This evidence draws a direct line to your hospital.

I'd like to offer you the chance to turn that into a positive thing.

The following is a list of requests that Nicole has stated will be non-negotible if there is to be any agreement reached between herself and Meritas/NKC Hospital in the matter of the intentional gaslighting of Nicole Henry to keep her from discovering she had developed an adrenal cortical carcinoma while under the direct care of Dr Robert Evangelidis by many physicians practicing under the Meritas/NKC Hospital name.

- 1. Meritas and NKC Hospital will be the first group of physicians to take a stand and expose the intentional misdiagnosis of fibromyalgia and depression in patients as a code to protect other doctors by not assisting in patient diagnosis and at times to even intentionally gaslight patients.
- 2. Dr Robert Evangelidis will be the physician to lead the charge by confessing his role in Nicole's gaslighting and care in general and vowing that with the support of the entire Meritas and NKC Hospital community to help end the archaic practice of intentionally gaslighting patients to protect colleagues and other physicians from consequences for their mistakes.
- 3. Meritas will base their new set of standards and principles on this exact premise.
- 4. We will help by acknowledging and helping fight for caps on true accidents that happen in the medical field and in turn you will help us by turning our combined attention towards The University of Kansas Hospital and the lengths they went to keep their doctor from getting in trouble. I mean they went so far as to ask for this to be covered up I am sure and if someone was smart that evidence might be able to be found.
- 5. I am sure after an internal investigation that will be brought on because of my concerns and Dr Robert Evangelidis conscience getting the best of him and coming clean and wanting to make things right you all can come up some way to take responsibility apologize, and work together with us to fix the system so this doesn't have to happen to anyone again all while coming out looking like the hero's even if that is deemed necessary. As long as our conditions are also met.
- 6. Your actual top endocrinologist needs to look at Nicoles new images and write a recommendation that ensures Nicole is seen at The University of Colorado Adrenal Center as soon as possible. It can start out with "Hey we can tell you one situation that we know can cause an adrenal cortical carcinoma to spontaneously appear are you interested?"
- 7. There is a list of physicians within your organization that turned an intentional blind eye and or purposefully attempted to deceive Nicole and our family and should not touch patients ever again. However, we understand that not all of them can retire those that can, really should consider retiring and those that still need to work maybe they can do it in more administrative

- type roles or perhaps they can earn by being witnesses and helping get laws changed that benefit both the patient as well as the provider when it comes to malpractice. Anything must be better than what they knowingly and willingly made the choice to put my family through when they gaslit Nicole time and time again to protect the reputation of doctors that made mistakes that were forgivable if they had been acknowledged at the time rather than being covered up.
- 8. There will also be a public apology and acknowledgement of what roles certain doctors had in Nicole's intentional gaslighting.
- 9. I expect a response stating that you plan to work with us or your refusal no later than 1700 on 6/30/2023.
- 10. If you do intend to work with us in bringing this kind of medical practice to light like the intentional diagnosis of fibromyalgia and severe depressive disorder to cover physician mistakes and take a stand against them while also acknowledging the issue unified one and all under the North Kansas City Hospital/Meritas banner, then we expect an initial settlement proposal no later than 1700 on July 14th, 2023.
- 11. Once we receive your offer, we request you allow us until 1700 on July 21st, 2023, to have our representative look it over before deciding and either accepting or countering your proposal.
- 12. The fact that Nicole's health is not getting better without being seen and given treatment options means time is of the essence so we must insist there be no deviation from this initial timeline.
- 13. I truly hope we can come to an agreement for selfish reasons of wanting to have Nicole the mother of my children around and as comfortable as possible for as long as possible and I know you have the ability to help if Meritas and NKC Hospital choose to do so.
- 14. The alternative to reaching a settlement and allowing this to yet again go ignored will mean the next time we see each other will most likely be in our best guess sometime in the next 1-3 years whenever Nicole passes and then I can and will be obligated to file the wrongful death suits that I will have spent who knows how long preparing and perfecting by then against everyone listed and even more people on behalf of the two children Nicole and I have together as well as my own behalf. Rest assured nobody wants that because there will not be any winners.
- 15. People associated with your hospital have gambled more than once that Nicole would not find out about things like covering up for Dr Sahar Safavi almost killing Nicole with Valproic Acid to Dr James Reddington who saw Nicole at Liberty hospital under the guise that he was in no way shape or form associated with NKC Meritas or KU and tried to convince Nicole she didn't have an adrenal adenoma by showing her a CT from 9/9/2019 rather than the MRCP from 9/10/2019 telling her she had no adenoma or adrenal problems. He who then acted offended and denied being associated with Meritas/NKC Hospital when asked if he was associated with them. We know that he was indeed and still is associated with Meritas/NKC Hospital so why would Nicole get sent to him as she had requested a provider outside of NKC/Meritas/KU at this point and why would he pretend to not be associated with them? Another question is why would Dr Rusty Bergman not say anything to the patient about her adenoma or her liver that had now enlarged? Rolling the dice that it wouldn't be malignant didn't work out too well for any of us. Least of all the woman my children love more than anything my wife Nicole Henry.
- 16. Currently, I beg you please don't roll the dice on my wife and best friend Nicole Henry's life again. Help me help her and hopefully by studying everything we know and have evidence of

- maybe it can help make some progress in adrenal cancer awareness and diagnosis or even prevention.
- 17. It doesn't seem like it took much to convince most of the doctors to either turn blind eyes to or willingly participate in Nicole's intentional gaslighting so I am sure it should not take too much to convince them that it is now time to change strategies and work together.
- 18. To ensure these issues are being taken seriously now and in a timely and efficient manner. I have Nicole's entire medical record with things like our address, her birthdate, and phone numbers all redacted and ready to be published with my full and detailed evaluation of each doctors' actions during each of their encounters with Nicole as well as all the evidence to back up my claims and if we fail to reach an agreement it will be published in full to my website.
- 19. I also want to go on record that none of my actions have been nor will be violent or cause anyone or anything physical harm and it has never been my intention to cause fear only to be heard and taken seriously to get proper medical care for my wife Nicole.
