**30% of lot/item gross sale between \$1.00 - \$499.99**

**20% of lot/item gross sale between \$500.00 - \$999.99**

**15% of lot/item gross sale over \$1,000.00**

Seller agrees not to bid on personal items unless they wish to purchase lot/item at full value of winning bid. Seller agrees to hold Lets Go Auctions, LLC, its owners, employees and associates harmless and defend from all claims, losses and damages, including reasonable attorney's fees related to personal injury or property damage of parties during exhibition, sale and removal of goods. Lets Go Auctions, LLC reserves the right to refuse all non-saleable items.

Lots/items not sold after a good-faith attempt must be picked up by Seller within 72 hours from end of said auction. If Seller's lots/items are not removed after 72 hours, Lets Go Auctions reverses the right to donate them to charity or dispose of them in any manner.

Additional Expenses may occur if Seller requires Lets Go Auctions, LLC, its owners, employees or associates to pick-up and/or drop-off merchandise/goods.
