The Alliance was launched by 43 Founding Members on 21 April 2021 and has since grown to represent over 40% of global banking assets. We welcome those banks who have joined from the UN [Principles for Responsible Banking](#) and [Collective Commitment to Climate Action](#), and from the Prince of Wales' Sustainable Markets Initiative [Financial Services Taskforce](#), as well as all other banks who have shown leadership by joining the Alliance. We encourage banks worldwide to **join the Alliance**.

The Alliance's primary catalyst for achieving the net-zero transition is the target setting and reporting process embedded within its central [Commitment Statement](#) and further outlined in its [Guidelines for Climate Target Setting for Banks](#).
