

Resolution No. 2024 - 001

A resolution to adopt the Dodge County Land Use Code in the Town of Emmet.

The Town Board of the Town of Emmet, Dodge County, Wisconsin, does ordain as follows:

WHEREAS, in accordance with Section 60.62(1)&(2), Wisconsin Statutes, the Town Board, by motion of the Board recorded in its official minutes, has voted at the meeting of the Town of Emmet on $|\phi| > 2^{\frac{1}{2}}$, to adopt by resolution the Land Use Code, Dodge County, Wisconsin.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

- That the Town Board of Emmet hereby approves and adopts the Dodge County Land Use Code, attached to and made part of this Resolution, effective upon approval by the Dodge County Board of Supervisors of the zoning map for the Town of Emmet.
- 2. That following the approval of this Resolution:
 - a. A certified copy of this Resolution shall be promptly filed with the Clerk for Dodge County, Wisconsin; and
 - A copy of this Resolution shall also be provided to the Dodge County Land Resources and Parks Department.
