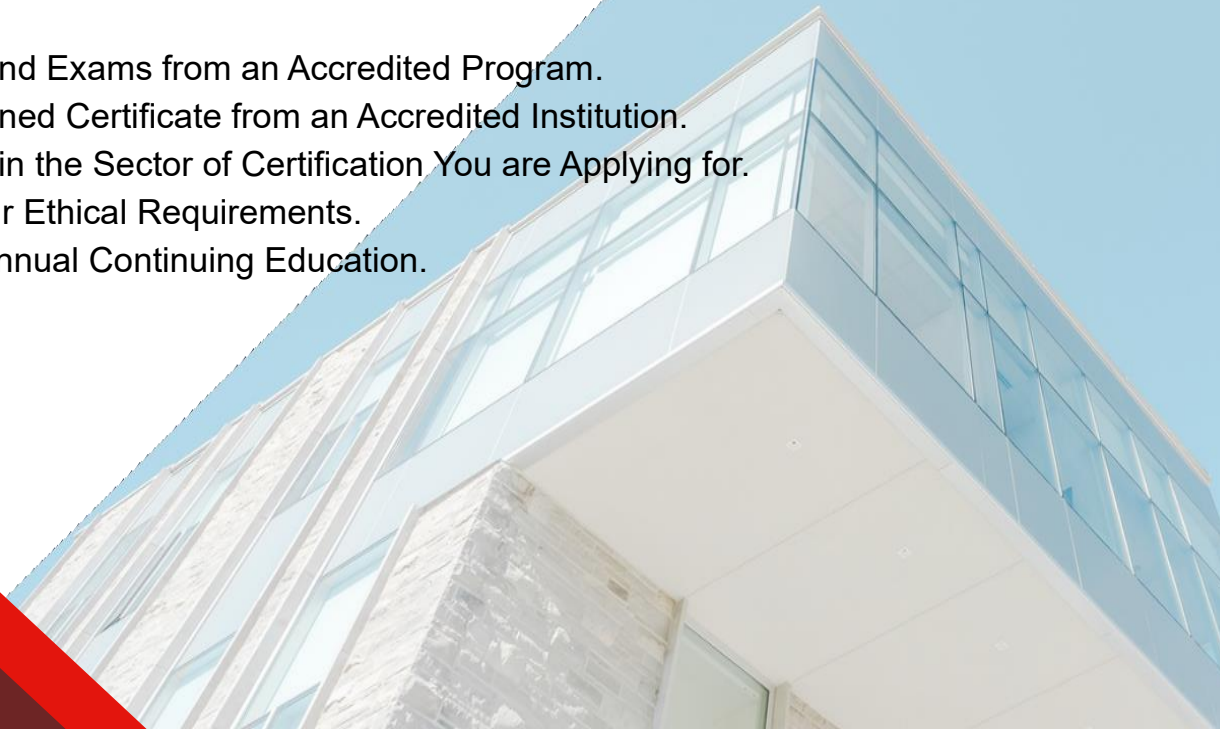

The International Certified CAATs Practitioner (ICCP) designation is a personal, professional certification to signify that you possess CAATs (Computer Assisted Audit Techniques) foundation knowledge and skills. Individuals qualifying for this designation must satisfy and substantiate the extensive skills and knowledge requirements established by the International Computer Auditing Education Association (ICAEA).

The Certifications are available to those who meet our Accredited Graduate Requirements.

- Education and Exams from an Accredited Program.
- Hold an Earned Certificate from an Accredited Institution.
- Experience in the Sector of Certification You are Applying for.
- Agree to Our Ethical Requirements.
- Complete Annual Continuing Education.



Objectives and Benefits of Certification

➤ Objective

The Professional Certified program is intended to establish standards for initial qualification; then provide direction for the computer auditing activities through an aggressive education program and specification of an improving standard of professional competence.

This certification program helps to:

1. Define the tasks (job dimensions) associated with the computer auditing activities in order to evaluate mastery of the internal control and internal audit activities.
2. Motivate personnel having computer auditing responsibilities to maintain their professional competency.
3. Acknowledge attainment of an acceptable standard of professional competency.
4. Assist individuals in improving and enhancing their organization's computer auditing programs (i.e., provide a mechanism to lead a professional).

Code Of Ethics

The code summarizes aspirations at a practical level to enable all Computer Auditing Professionals and Practitioners can be easy to understand, remember and practice. It is so called "Ten Commandments for Computer Auditing". All of them shall commit themselves to adhere the following Ten Principles:

1. Accept full responsibility for their own computer auditing work.
2. Keep private any confidential information gained in their professional work.
3. Ensure that they are qualified for any project on which they work or propose to work.
4. Ensure an appropriate method is used for any computer auditing project on which they work or propose to work.
5. Ensure that their computer auditing scripts, and related modifications meet the highest professional standards possible.
6. Maintain integrity and independence in their professional judgment.
7. Not engage in deceptive financial practices such as bribery, double billing, or other improper financial practices.
8. Participate in lifelong learning regarding the practice of their profession.
9. Assist audit team members in professional development and become more audit efficient.
10. Promote public knowledge of computer auditing.

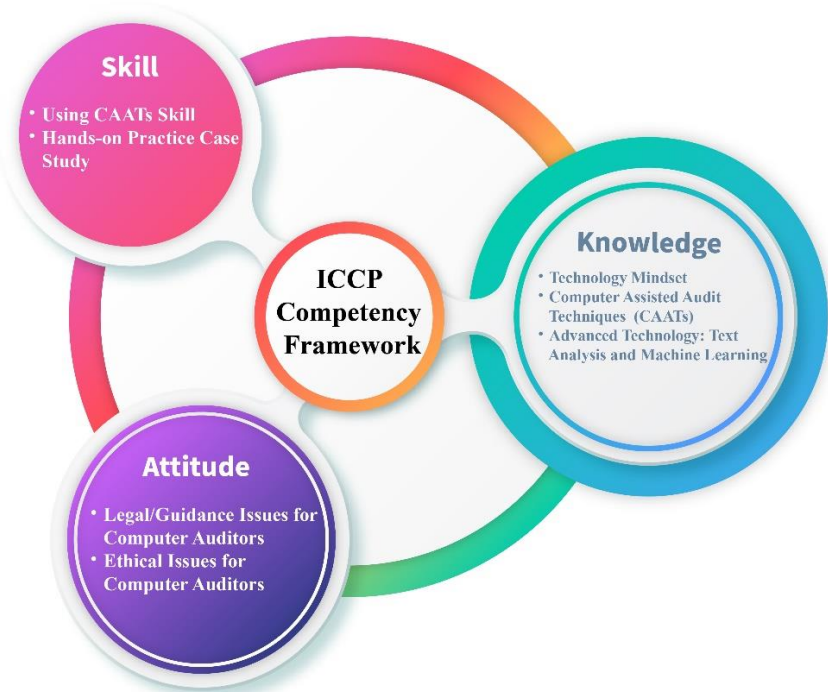

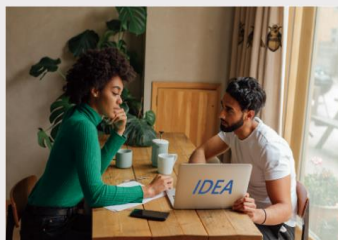

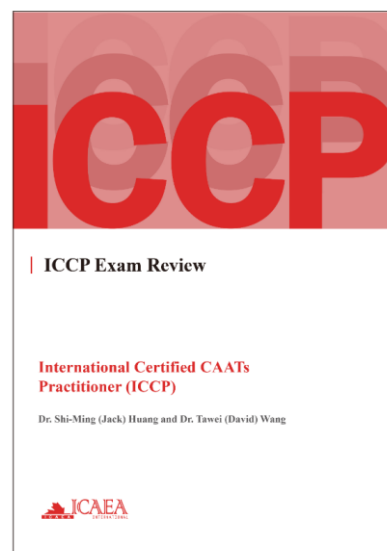

Verify a Certification

▶ International Certified CAATs Practitioner(ICCP) Examination

Knowledge Inventory

The Knowledge Inventory component of the exam counts for 60 percent of the final grade. It is meant to test your familiarity with professional knowledge and analysis of practical application. The exam consists of multiple choice covering seven topics:

- Computer Auditing Overview and Understanding CAATs
- Legal and Ethical Issues for Computer Auditors
- Computer Auditing Project Planning
- Data Access Skill and Knowledge
- Data Verify Skill and Knowledge
- Data Analysis Skill and Knowledge
- Audit Finding Report Skill and Knowledge

Case Study

The Case Study component of the exam counts for 40 percent of the final grade. It is meant to test your familiarity with CAATs and auditing skills. The exam consists of fill in the blank, and short answer questions covering three topics:

- Data Import Implementation
- Data Verification Implementation
- Data Analysis Implementation

Designation

To attain certification, you must have a minimum passing score is 70 out of 100.

Exam

This closed-book, 120 minutes-long certification exams is divided into two components: a Knowledge Inventory and two short computer auditing case studies. The case study is CAATs free independent. You can use any CAATs, such as ACL, IDEA, JCAATs, Picalo, etc., to attend the exam.

Examination Fee

The ICCP certification exam fee is US \$370. All registrations are final, and no refunds are possible. You will receive your ICCP certificate within one month after passing the comprehensive exam.



A practitioner who is performing computer auditing functions must complete a total of 12 hours of acceptable CPE biennial period.
