# NEXT\_NORCAL EVENT

Due to the COVID-19 virus, everything in the San Francisco Bay Area is shut down until further notice. Your NorCal Board of Directors will keep you posted as to the next NorCal event via both our website and the next issue of the Windsheet.

Due to the pandemic, NorCal Theatre Organ Society will not have access to any venues for the foreseeable future. Therefore, the NorCal Board has decided to extend all current memberships for one year.

# BERKELEY COMMUNITY THEATRE CONSTRUCTION

As previously reported in the Windsheet, construction work started Monday, June 15 and is scheduled to finish in August 2022. Your editor, a recently retired structural engineer, has had the opportunity to look over the plans for the construction work. Working downward from the pipe chambers, here is what the drawings show:

<u>Pipe Chambers and Tone Chute</u>: Neither is shown anywhere on the plans. In addition, there is a note reading: "Existing organ pipes and equipment to remain. Protect and seal pipe rooms during construction."

32-Foot Diaphones: As reported in the April and June Windsheets, NorCal's organ crew has removed them from the building and placed them in temporary storage. They had been installed on the steel balcony along the back of the stage house at 34 feet above stage level. This balcony will be replaced with a wider reinforced concrete balcony. As requested, we provided weight and dimensional information to the architect. The construction drawings show them as installed in their new location on the new balcony. A note on the drawings reads, "Relocated organ pipes, blower and fan. To be reinstalled by organ society." The drawings call for the contractor to cut a hole in the steel grid over the tallest of the six pipes; and direct the contractor to coordinate with NorCal when they cut the hole.

<u>Speaker Shelf</u>: The work there will not affect our pipes and percussions.

<u>Blower Room</u>: Two of the walls will be thickened by 10 inches and a new foundation will be added beneath one of them. This is part of the seismic strengthening. The NorCal crew was permitted to move the contents of the blower room to the back row of the house for storage until completion of construction.

<u>Auditorium</u>: There will be little work in the auditorium itself except that the handicap elevator and its protrusion into the house (AKA "The Wart") will be removed. Instead, handicap access to the auditorium will be from the east lobby through the auditorium entrance nearest the stage. This will be an allnew new ADA-compliant ramp into the auditorium which will then split into two paths: one down into the house and the other directly to the side of the stage. This will restore the stage sight lines that had been blocked by the wart.

As reported in the April and June Windsheets, both consoles and the 32-foot diaphones along with their blower

and regulators have been removed from the building and are in secure off-site storage.

# **CHAIRMAN'S WIND LINE**

January greetings in the new year, 2021. This would normally be the month in which we hold our Annual NorCal Membership Meeting, as we did last January 12<sup>th</sup>. We are experiencing a double handicap this year due to meeting restrictions because of the pandemic, and the lack of accessibility to the Berkeley Community Theatre due to its reconstruction along with the reconstruction of the adjacent Berkeley High School building. Removal of hazardous material from the buildings was begun last June and heavy reconstruction is now well under way. It is scheduled to be completed in time for classes to resume in August 2022. So, we hope to be able to regain access to the theatre in another year and a half in order to get the organ back into operation and up to concert standards of maintenance. Because of the pandemic, by mutual agreement, we were forced to cancel Justin LaVoie's concert last May 24<sup>th</sup>.

Your NorCal Board of Directors has been continuing to conduct normally scheduled bi-monthly meetings via Zoom, thanks to Internet help from Kevin King. In view of our inability to have concerts, the Board has agreed to extend memberships (suspend dues payments) for 12 months.

Fortunately this year, 2021, we have no directors with expiring terms of office, so we didn't have to call for nominations last fall. I have asked Windsheet Editor Art Woodworth to publish in this issue the information we would have presented to you had we have been able to hold our Annual Membership Meeting this month.

I talked recently with Sierra Chapter President, Randy Warwick. He mentioned that the Fair Oaks Community Clubhouse, where their chapter organ is installed, is scheduled for renovation in October, which will make the venue temporarily unavailable for concerts. Perhaps by next fall we'll all be able to attend Sierra Chapter's "George Wright Memorial Concert" at Grant Union High in Sacramento. We continue to look forward to the re-installation of the original console and new Uniflex relay at the Oakland Paramount.

## RIP BOB HARTZELL

Robert Pollock Hartzell (86) passed away peacefully at home surrounded by his loved ones on November 21, 2020. Bob began his university studies at UC Berkeley. He was one of the original "Twinkling Tubas" in the Cal Marching Band. He was co-owner of the Murphy's Historic Hotel in the foothills of California where he led the restoration efforts for the historic property. For 18 years,

Bob served as Executive Director of the California Association of Wine Grape Growers (CAWG) working tirelessly to promote the wines of California, receiving recognition from the United States House of Representatives for his contributions to the wine industry. One of Bob's personal passions was music, and he was an accomplished pianist and organist. In addition to these instruments, he also played the bass fiddle in the Stockton Symphony Orchestra. He was instrumental in the restoration and installation of the theater pipe organ in the Bob Hope Theater in Stockton as well as the theater pipe organ at Ironstone Vineyards. Bob fulfilled his dream of combining agriculture, wine, and pipe organ music.

In 1987 Bob, Dale Mendenhall, Ray Anderson, and Dave Moreno went to see Charlie Davis in Concord, who had a 2/11 Robert Morton theatre organ from the Castro Theatre in San Francisco in his backyard music room. Davis made several changes to the organ including replacement of the original two-manual console with a three-manual console from a theatre in Provo, Utah. Bob purchased the organ, followed by the vineyard property on which he built the complex which would house the organ. Mark Hartzell (Bob's son) drew up the plans for the barn. After it was built, Dave Moreno did the layout and specifications for the organ and was soon installing it with Bob. Tim Rickman did all the wiring and computer installation. Tom Delay worked on the tonal work and extra additions. The culmination of this dream was co-founding Harmony Wynelands with his wife Linda.

The NorCal crew returned it to the theatre on October 30. The restored original Oakland Paramount console, as restored by Crome Organ Company, was also delivered to the theatre that day. Berkeley Community Theatre: NorCal has been advised that the last day of access before start of construction will be Friday, June 12. Some portions of the NorCal Wurlitzer will have to be temporarily removed to allow access to the seismic strengthen-ing work, particularly the 32-foot diaphones and their blower, winding, and regulators.
