## HOA FEES

You should be getting an envelope from association containing your HOA assessment bill. If you do not receive your statement by January 1, 2023 please contact Wellington HOA at [ourwellingtonhoa@outlook.com](mailto:ourwellingtonhoa@outlook.com) or 863-259-8606. Assessments must be received and posted to your account by February 28, 2023, to avoid penalties. Please remit promptly and allow enough time for your payment to be mailed, processed and posted to individual accounts. Payments received after February 28th are subject to a late fees and possible lawyer costs. For 2023, dues are increasing \$4 per home over 2022, driven primarily by macro-economic drivers including year over year CPI-U increase (measure of inflation) and labor cost increases. These factors drive our lawn and grounds maintenance costs, pool operation contract, and county costs contract which are our three largest budget line items.

### YEAR ROUND

Any modifications to your home or landscaping need prior ARC approval. Major additions must be staked for visual reference to assess impact to adjoining properties. Wellington homeowners must apply ONLY to ARC. The HOA has 30 days to review submissions to ARC.
