




ITEMS OF INTEREST


Chief McConnell...

- Participated in the annual 9-1-1 remembrance ceremony held at the ESD#2 fire station.
- Attended a 9-1-1 remembrance ceremony at Ricardo Estrada School.
- Attended the regular El Paso County 911 District Board of Managers meeting where Chief McConnell serves as the Chairperson.
- Acting as the Chairperson of the 9-1-1 Board of Managers, Chief McConnell was honored to be the ribbon cutter for the new 911 regional Communications Center.
- Attended and gave some remarks at the graduation ceremony for the El Paso Sector Honor Guard graduation ceremony. Five of our police officers graduated their training program.









COMMUNICATIONS DIVISION

Together as One



The Communication's division welcomed a new dispatcher on board. The Police Chief, Communications Manager and two dispatchers attended the 911 District Board meeting. After the board meeting, the Communications Manager and the two dispatchers were given a tour of the new 911 District building located on Threadgill.

Socorro, Clint and Horizon Fire responded to a structure fire in Socorro involving a mobile home. The El Paso Electric Company and a Fire Marshal were requested to this location for further investigation. The fire was extinguished within an hour and the scene was turned over to the Fire Marshal.

In addition, Fabens, Clint and San Elizario Fire responded to a structure fire in Tornillo involving a water heater. The caller advised of smoke and flames emitting from the residence. Upon arrival, the San Elizario Fire Chief requested a tanker from Socorro Fire. The fire was extinguished within minutes and there was no structure damage.

The Communications Supervisor attended the Regional Agency meeting. Two important issues were discussed. CAD (Computer Aided Dispatch) will go down so that all the equipment at the 911 District Building located on Kansas can be installed at the new 911 District Building. In addition, a presentation was given regarding changes in the Net Viewer for Police Officers.


Horizon, Clint, and Montana Vista Fire responded to a structure fire on Desert Sage. Once on scene, fire fighters were able to prevent the fire from spreading to the adjacent properties. In addition, to the previously mentioned departments, the following organizations also assisted: Horizon City Police Department, Life Ambulance, El Paso Electric, Texas Gas, and the Red Cross.


Dona Ana Fire Department requested mutual aid from West Valley Fire Department reference to a fully engulfed mobile home. West Valley Fire Department were on scene for three hours.

San Elizario, Clint, and Socorro Fire responded to a structure fire regarding a male burning clothes inside the residence. The call was cloned to El Paso Sheriff's Office requesting a unit to respond as a result of the male being intoxicated. Socorro Fire were the first on scene and advised they did not have visual of any smoke or flames. The scene was investigated by firefighters and it was determined there was no fire or medical emergency. The scene was turned over to EPSO units.

Dispatch received multiple calls in reference to a structure fire in Fabens. Fabens, Clint, and San Elizario fire responded. The reporting parties advised they had visual from a distance on smoke and flames. Upon arrival, the Fire Department advised the fire was in the basement area of a two story residence. The fire was extinguished. Texas Gas, El Paso Electric, Life Ambulance and a fire investigator were requested to respond. Life obtained three patient refusals for smoke inhalation. The fire investigator conducted an investigation and determined there were no hazards for the homeowner.







WARRANTS DIVISION & FLEET OPERATIONS

The Warrants Sergeant received 70 summons for service. All summons were executed. During the month of September, 32 people were arrested for traffic warrants. Collections were made for some warrants. The people who were unable to post bond were booked into the El Paso County Jail.

The Warrants Sergeant reviewed 35 cases that were received from CPS. All cases were reviewed and either closed out or filed with the case that was opened due to the allegations of neglect. The Warrants Sergeant took 10 vehicles to the shop for oil changes and repairs. Bailiff duties were conducted during court proceedings.

CRIMINAL INVESTIGATIONS

Detective Labrado continues to investigate and gather the information required for a runaway case. This case lead to charges in Harboring a Runaway and Child Endangerment. The case on Child Endangerment was for exposing the children to methamphetamines. In addition, Detective Labrado assisted Telecommunications in monitoring and correcting TCIC/NCIC entries.

Detective Nunez was called out to a burglary of business at a local Pharmacy. The subjects took several eye glasses, cash and other electronic equipment. Detective Nunez also investigated a theft of a vehicle. A Bobcat was stolen from a construction site. The Bobcat was recovered outside the city limits. The case was closed and charges were filed with the DA's office.

Other cases received during the month of September were deceptive business practice, burglary of business, burglary of vehicle, runaway, child endangerment, and a theft

CRIME PREVENTION ACTIVITIES

Crime Prevention

Crime prevention activities included:

- Career Day Presentation at Ricardo Estrada Junior High which was attended by Sergeant Camilla's on behalf of Sgt. Mitre who was out of the office. This particular career Day presentation was unique in the sense that the activity consisted of a 45 minute presentation to a gym full of students. The school requested that the officer present on whichever topics the officer wished to share with students.
- Fingerprinting activity with "LIARS" club at Oz Glaze Senior Center on September 30th. The event was attended by Officer Crespo and HCPD Explorers who were available to provide parents a child safety booklet which consists of

activity pages and a pull out center in which a parent can fill out their child's identifying information, a small ink pad, and a place to record the child's fingerprints. Explorer cadets were available to conduct the fingerprint record for the parents.

HCPD Police Explorer Program

The major undertaking for the month was preparation for our National Night Out event where explorers assisted with helping participants and vendors to their designated display areas as well as helping HCPD officers with traffic control during set up and at the end of the event.
