Items of Interest

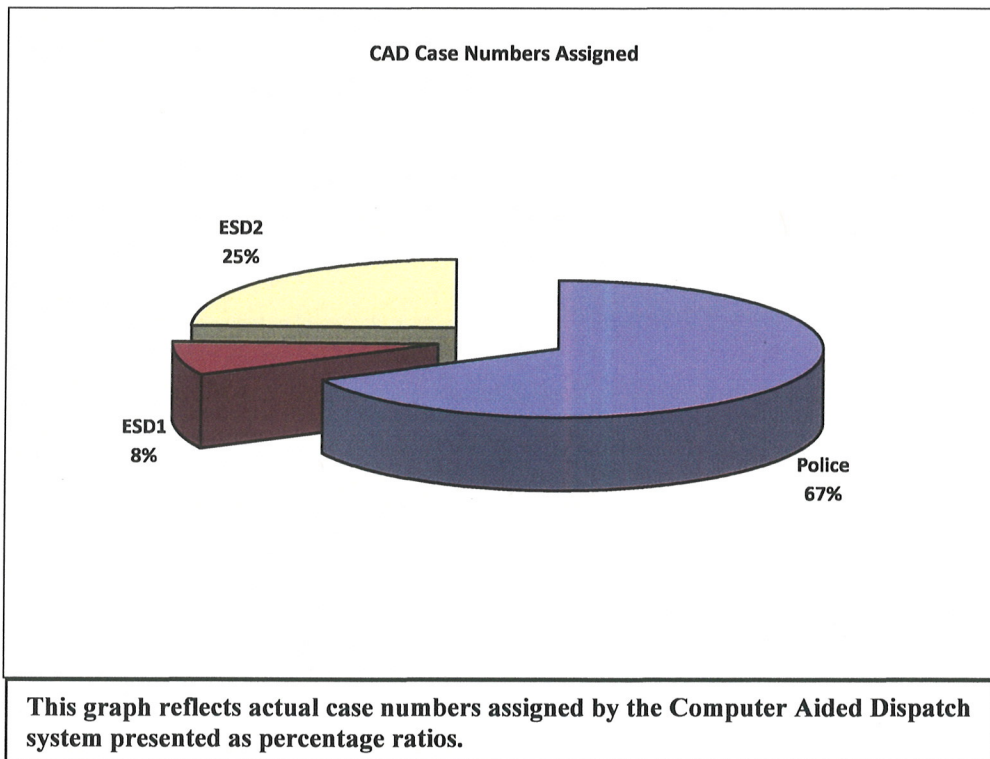
- Chief McConnell attended the following meetings:

 - ✓ Attended an executive Homeland security briefing concerning asset forfeiture sharing.

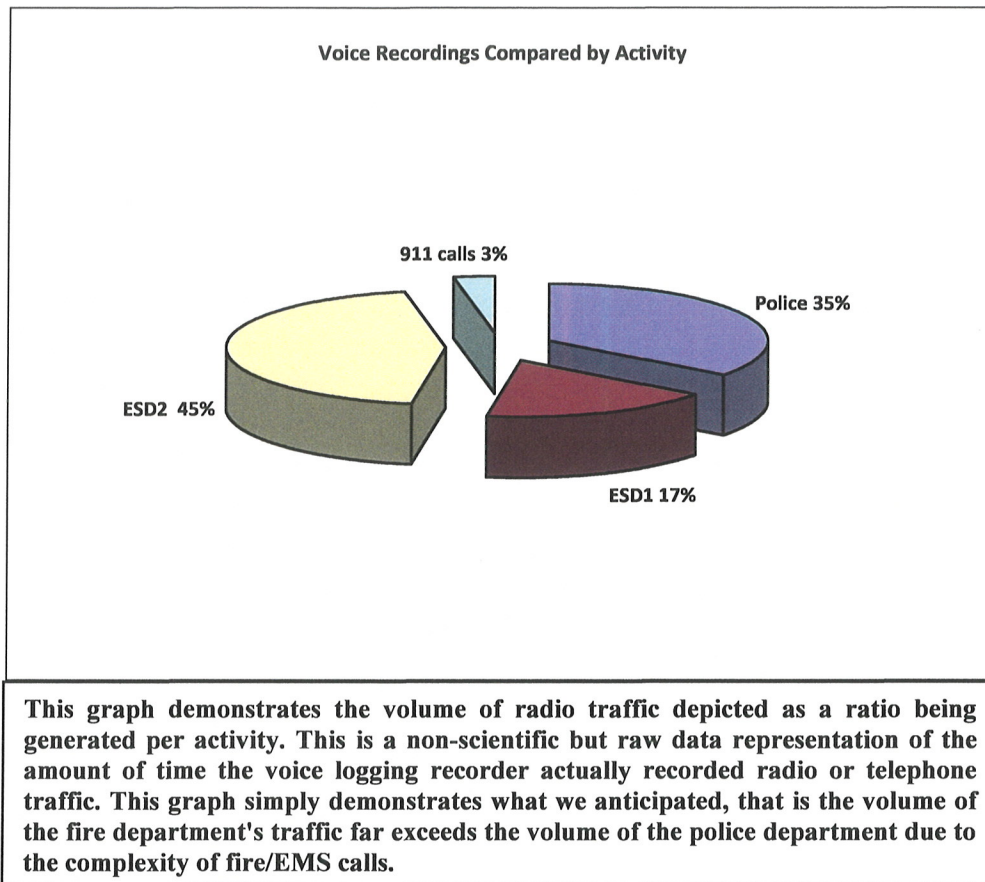


Communications Division



During the month of August, our communications division has continued to participate in required and recommended training courses. The communications coordinator and morning shift supervisor attended the Texas Commission on Law Enforcement Basic Instructor Course. This course taught necessary fundamental teaching skills for an adult training environment. All dispatchers took continuing education courses online through the International Academy of Emergency Dispatch. The newest dispatcher received certification for NCIC/TCIC full access. This training was hosted by Officer Moncivaiz. The newest dispatcher is also currently attending the Basic Telecommunicator Course provided by the 911 District. For the month of August, we changed phone services. Dispatch will now be able to answer emergency and non emergency calls through our VESTA 911-phone system.





Community Policing

Community policing activities during the month of August included participating in the El Paso County Sheriff's National Night Out event which took place on August 4th. Our participation in the event consisted of presenting a vehicle display and making teen-young adult alcohol abuse awareness material available to the public. Four HCPD Explorer Program cadets assisted with passing out the material to the public in attendance. The El Paso County Sheriff's Office observes National Night Out in August, like much of the nation. Texas agencies can opt to celebrate National Night Out in October, which is why our agency has spent much of August preparing for our National Night Out event which will be held on October 6th from 5pm - 9pm. Preparation has included arrangements for amusement rides, activities, promotional material, and gathering sponsors for the event.

Criminal Investigations Division (CID)

On the week of August 22, Detective Labrado conducted a child safety seat seminar for the public. Civilians were instructed in the proper installation of child safety seats and advised of potential repercussions of not having the safety seat not installed properly.

Detectives conducted an investigation into a theft at the Wal-Mart where a Hispanic male attempted to steal \$460.00 worth of meat. Detectives identified the male subject who was located at a family member's residence in San Elizario and taken into custody by Detectives. The suspect has an extensive criminal history of theft, assaults on public servant and evading arrest. He was booked into the El Paso County Jail for theft over \$50.00 but under \$500.00. The theft charge has been enhanced from a class "B" misdemeanor to a third degree felony due to his previous theft charges.

Cases received during the month of August were thefts, sexual assaults, burglary of vehicles, and arson. Detective B. Campbell and Detective Labrado attended the JOIC and HIDTA meetings on a weekly basis.

Employee Training

State and Federal Updates (4hrs) : Required course that covers the legislative updates from the 83rd legislature which have significant applications of state law and supreme court decisions to help guide the officer in the field. Attended by : L. Acevedo

Combined Racial Profiling\ Asset Forfeiture (6hrs) : TCOLE requirement for intermediate PO Certification, student will be able to identify legal aspects and legislative requirements of law enforcement agencies regarding racial profiling. Intro to Intelligence for Law Enforcement (24hrs) : The training focuses on a disciplined, systematic process for transforming raw information into useful and timely intelligence, known as the intelligence cycle. The training explores each component of the intelligence cycle, from target identification and selection, data collection, evaluation, collation, analysis, to proper documentation and dissemination. TCOLE Instructor Course (40 hrs) : The course will certify student as a TCOLE instructor and cover the basics on how to create lesson plans, exams, how to use instructional media, teaching methods and identify what documents need to be filed. Attended by: A. Chairez , E. Ramos

Active Shooter (8hrs) : The purpose of this course is to aid peace officers as a true first responder in their ability to safely and effectively respond to an Active Shooter threat situation by improving officers initial actions and increasing the level of


effectiveness of the overall operations. Officers in Attendance: G. Rosas, A. Labrado, D. Ramirez, G. Rodriguez, L. Medina
