Communications Division

During the month of January two of our dispatchers attended TERT training. TERT stands for Telecommunicator Emergency Response Taskforce. These two dispatchers are now trained to assist other agencies that are going through manmade or natural disasters. The TERT dispatchers would travel to any agency needing assistance and take the place of dispatchers that may not have left their positions since the beginning of a disaster or those that may be suffering losses of their own.

This month the division's Communications Coordinator attended various meetings to begin preparations to become the regional County Fire dispatch center. The meetings included the Horizon City Council meeting, the ESD2 Commissioners meeting, and various other meetings with Chief Menendez of ESD1 and Chief Adler of ESD2. The plans to incorporate the dispatching of the other county fire departments are currently ongoing. The division will be looking to hire additional dispatchers to prepare for the radio traffic that those agencies will bring once the agreement is in place.

<u>Crime Prevention – Community Outreach</u>

Community Policing

Through the use of Facebook, HCPD was able to learn that an unknown individual has continued to approach high school students in the neighboring area of the Emeralds neighborhood. Extra patrol is being provided and cooperation with other agencies is underway.

Sergeant Mitre conducted several Career Day presentations in area schools during which he had the opportunity to speak to groups of children in 5th grade. Sergeant Mitre was pleased to see that many young minds are interested in law enforcement as well as technology and was surprised by the intricate line of questions from the children in that grade level. Many children had questions regarding the processing of crime scenes, and the crime laboratory evidence analysis process.

Evidence

Sergeant Mitre is continuing the production of a new evidence manual which will include an evidence submission preparation photographic guide. Local prosecutors have become increasingly stringent on the quality of packaging and evidence submission integrity. Having this manual will benefit the department by allowing officers to prepare their submissions properly which will potentially lead to consistent case dispositions.

Police Explorer Program

The HCPD Jr. Explorers post has dropped to a single member, but this is great news because the other members have actually transitioned into the primary HCPD Explorer Program. The transition is due to the members of the Jr. Explorers program reaching the ages of 14 and also getting into 9th grade. The Jr. Explorer program will be seeking to recruit new members very soon!

<u>Criminal Investigations Division (CID)</u>

In January 2015, the Criminal Investigations Division acquired a new equipment storage cabinet for storing investigative tools in the CID office. The new storage cabinet makes the office look more professional and helps make inventory control more manageable. It also provides better protection for many tools, such as cameras and other environmentally sensitive items, from being damaged by improper storage.

Detectives are now presenting all the Departments cases electronically to the District Attorney's Office. The project started last year in September and was implemented January 1 of this year. This new process has been beneficial to the Department as it saves time and Department resources. As of this report there have not been any issues with cases being submitted from the Department to the District Attorney's Office.

Detectives attended regular training during the month of January. TDY Detective Zeiger attended courses in Computer Crime Investigations and use of force. Detective Labrado attended the rifle instructor's course and is now certified to qualify and train Department personnel in the use and handling of the M4 patrol rifle.

Detective's continued the investigation of the burglary that occurred at the Benny's Pawn Shop on Horizon Blvd. A suspect was identified with cooperation with El Paso Police Department. Property belonging to Benny's was located in the suspect's possession. The subject has been arrested and the case has been submitted to the District Attorney's Office for final disposition.

Cases received during the month of January were thefts, identity thefts, unauthorized use of vehicle and runaway.

For the month of January, 8 cases were closed out, 13 cases were assigned and 12 cases remain actively open.

Detective B. Campbell and Detective Labrado attended the JOIC and HIDTA meetings on a weekly basis.
