




Chief McConnell attended the following meetings:


- Chief McConnell continued to work on the new telephone replacement project.

- Met with Assistant Fire Chief Menendez several times regarding fire paging procedures.

The second movie was Frozen and we estimate there were around 4,000 - 5,000 participants. This was a great turnout and provided a very positive exposure for the Town of Horizon City.

Communications Division

We were busy in communications during the month of May. Not only were we training new employees, we also began dispatching the Horizon Fire Department beginning May 1st. It has been a learning experience for all involved. We can already tell that it has improved the responses from HCFD now that they have a dispatcher to gather information for them, update them as they are on their way to calls, and keep track of their units.

The new dispatchers that were hired will all be starting on their respective shifts on June 1, 2014. This will increase the staffing during the busy shifts to two dispatchers at all times. This month also brought more training. One of our dispatchers attended training involving the upgrade we'll be getting to our I/Cad. The El Paso County 911 District provided training to the area agencies based on the 7 Habits of Highly Effective People. We were able to send three dispatchers to the 16 hour TCOLE accredited training.

Criminal Investigations Division (CID)

Detective Bruce Campbell is the new detective for the Horizon City Police Department Criminal Investigations Division. His duties will consist of conducting investigations, attending inter-agency meetings, processing crime scenes, interviews, interrogations, and reviewing cases forwarded from the patrol division. Detective L. Medina attended a two week long training and obtained The Basic Instructor's Certification.

Detectives were called regarding a reported theft that escalated into a robbery at the Vista-Mart. Three subjects arrived at the store and two of the three subjects entered the business and attempted to take items without paying for them. The subjects were approached by the loss prevention employee and a verbal confrontation ensued. The subjects left the business and while the loss prevention employee was obtaining the vehicle registration, the driver struck the employee with the vehicle causing minor injuries. A warrant was obtained for the subjects and apprehension is pending upon locating them.

Other cases received during the month of May were credit card abuse, duty on striking unattended vehicle, endangerment of a child, and terroristic threat.

Detective L. Medina and Detective B. Campbell attended the JOIC and HIDTA meetings on a weekly basis.

Employee Training

Intox Operator(40 hrs): One of the requirements of the Texas Breath Alcohol Testing Regulations approved by DPS in assisting Officers how to properly operate and obtain a breath specimen on a intoxicated subject for alcohol content.
