#### Items of Interest

#### Chief McConnell

#### Dispatching

The communication's coordinator, Jenny Moncivaiz, has attended MPS (Mobile Public Safety) training in order to assist the officers with questions regarding the use of the system. MPS is the program that officers use to run subjects and vehicles and to see what calls they've been dispatched to or still have pending. She has also attended CAD DBM training. CAD DBM allows the Horizon Police Department to enter vital information, such as emergency contacts and numbers, for locations within Horizon into the ICAD system. This information is crucial when an incident has occurred at a location after hours and a representative for the business needs to be reached.

Mrs. Julie Bonilla has been handling almost all of the radio and window traffic on her own and will be working independently starting in September. This means that the HCPD officers will have their own dispatcher and won't have to fight for air time. This will also allow the public to request reports, background checks, and other police services until late in the evening.

#### **Warrants Division**

Warrants officers assisted the Horizon Municipal Court by serving fifty summonses. All fifty of them were executed and none were returned back to the court. Warrants officers made approximately 106 contacts either executing warrants or leaving red tags advising people that they had outstanding traffic warrants with the Horizon Municipal Court.

On August 27, Warrants officers coordinated a warrants roundup operation that began at 4:00 am, and finished at approximately 11:30 am. There was one person who was not able to post bond and was booked into the El Paso County Detention Center that cleared a total of \$465.00 in outstanding warrants. Horizon Municipal Court warrants round up revenue was \$13,691.10 received through cash and credit card payments.

The Horizon Municipal Court cleared 61 traffic warrants totaling \$27,224.00. The warrants division will continue to collect on traffic warrants. The next warrants round up will be scheduled for the first week of November.

Total overtime expense was approximately \$2,286.20. Some officers worked from 0400 hours until 1130 hours and some finished at 1400 hours, except for one warrants officer who finished at 1500 hours and the other at 1700 hours.

Total revenue for the month of August was \$44,000 dollars ranging from red tags that were left from the warrants officers, arrestees that posted bonds, phone calls that were made by court (Valarie) and the warrants round up.

#### Code Enforcement Division

Code enforcements' focus this month was on all "parkway nuisances" in residential and commercial areas. These parkways were cleared of all trash, weeds, and grass that exceed 12 inches and were obstructing public right-of-way for all returning students walking to and from school.

Last month, Code Enforcement worked on stored vehicles and enforcing the abatement of such nuisances. This month after following up on 19 stored vehicle red tags, 4 vehicles were towed and 15 vehicles removed by voluntary compliance.

Additionally, code enforcement also addressed code violations on illegal signs, construction, permits, graffiti, and alarms.

#### Criminal Investigations Division (CID)

Detectives received information on possible suspects on a burglary of habitation. Detectives made contact with one of the suspects and obtained an arrest warrant for him. The arrest warrant was executed and the suspect provided additional information for the case. Detectives then made contact with a second suspect and recovered many of the stolen items such as jewelry and electronics. Detectives obtained an arrest warrant for suspect which was executed by El Paso Police Department a few days after.

Detectives received a call in reference to assisting Maricopa County, Arizona in locating a material witness in a serial murder case. Although the witness absconded from the area, Detectives provided leads to her location out of state.

Detectives met with DPS agents Gang Intel Unit and coordinated to exchange information on gang activity in the Clint Independent School District schools located in Horizon City and

attended weekly scheduled meetings with surrounding agencies. Detectives met with NIBIN tech, a division of DPS which investigate forensic evidence on firearms and tool marks who provided invaluable information for investigative purposes.

Detective Mitro was called out on a Theft of copper. Detective Mitro obtained a statement from the offender who admitted to taking the copper on this case and on a previous case (which had been closed due to no workable leads). Victims included Sprint, AT& T, Verizon and T-Mobile and amount to repair was estimated to be at approximately \$10.640.00.

Other cases received during the month were burglary of habitation, theft, credit card abuse, and Deceptive Business Practice.




