Items of Interest

- A Police Officer applicant testing process was held on March 12. Seven applicants
 participated and only one officer passed the physical and POST tests. Another testing
 process is scheduled for April in an attempt to create a hiring list. We still have one open
 police officer position unfilled.
- Officer Fraire was awarded his Intermediate Peace Officer TCLEOSE certificate.
- Chief McConnell was awarded his Master Peace Officer TCLEOSE certificate.

Warrants Division

The two warrants officers assisted the municipal court in conducting a roundup for active warrants. All Horizon City Police personnel participated in the warrants roundup that began at 4:00 am on April 2nd, 2011 concluding at approximately noon. The warrants officers and the officers scheduled for regular duty continued to assist with court proceedings and detainees that could not post their bonds.

The warrant officers finished at 5:00 pm by booking six persons that were not able to post bond, clearing a total of \$9,599.00 in outstanding warrants. Horizon Municipal Court warrants roundup revenue was \$8,498.00.00 received through cash, and credit card payments.

The Horizon Municipal Court cleared numerous traffic warrants totaling \$27,002.00. The warrants division will continue to collect on traffic warrants. The next warrants round up will be scheduled for the end of August or first part of September.

Total overtime expense was \$2,286.20. Some officers worked from 0400 hours until 1100 hours and some finished at 1130 hours, except for the two warrants officers that finished at 1700 hours booking arrestees.

Code Enforcement Division

For the month of March, the majority of the time was spent enforcing tall grass and weed nuisances. The Desert Breeze 1 & 2 subdivision was the area focused on being that the majority of weeds and trash complaints come from this particular area at this time of year. Some developers and lot owners had neglected and abandoned their properties and some were a complete nuisance.

Rear property parkways had become a safety and fire hazard to this subdivision as well. Notices were issued, flyers were passed out, and letters were mailed in an effort to get voluntary compliance from the entire subdivision. The majority did comply and the community in this subdivision was not only very pleased but excited to finally have the developers take control of these abandoned lots. Developers brought in large garbage roll off containers for the home owners to use while in the process of this subdivision clean up. A total of 174 properties developed and undeveloped received notices, flyers, and letters for vacant lot or parkway clean-up. Ninety-four (94) property owners voluntarily complied, Twenty-four (24) parkways were contracted out for clean-up, fifteen (15) vacant lots were contracted out for clean-up, and forty-one (41) lots are still pending completion of clean-up.

Although tumbleweeds are a never ending problem in Horizon City, we have brought the subdivision to a state of compliance by abating health and fire hazards in regards to weeds, trash, and illegal dumping nuisances. The Code Enforcement department will continue to monitor this subdivision in order to maintain code compliance.

A total of thirty-two (32) property liens will be filed with the County of El Paso on vacant lot and parkway clean ups. All costs of clean up must be paid by property owners.

Additionally code enforcement department also worked on:

- Removing illegal signs
- Checking construction permits
- Checking contractor permits
- Business Registrations

Criminal Investigations Division (CID)

- A stolen vehicle from the 14000 block of Bryce was recovered in Socorro, TX. HCPD Detectives obtained latent prints from the vehicle which matched the suspected offender and a warrant was issued. Detectives made several attempts to locate the offender, a 20 year old male from Horizon City with negative results. Offender was featured on the El Paso County Sheriff's Manhunt Monday on February 28th 2011 and is currently at large. ***UPDATE*** using information received from a crime stoppers tip, the offender in this case was located in Horizon City by HCPD Detectives and arrested without incident on 03/02/11.
- A Horizon City resident reported fraudulent activity on her bank account shortly after misplacing her bank card. Detectives investigated the fraudulent charges which were made at several local businesses. While reviewing security video at one of the businesses, Detectives observed a male subject making purchases with the victims bank card and believed they recognized him from a previous encounter. A photo lineup was conducted with the store clerk who then positively identified the man and confirmed the Detectives' suspicions. The 21 year old subject was later located and arrested in Horizon City for debit card abuse.
- A juvenile subject was found in possession of a pocket knife while on school grounds and it was later discovered that this subject had threatened another student with the knife during school hours. The subject was picked up and transported to the Juvenile Probation Dept. by HCPD Detectives and charged with aggravated assault.
- Officers checked a vehicle parked in the area of Desierto Bonito and Maravillas. Two
 individuals were found inside the vehicle engaged in sexual activity. Officers checked the
 subjects who were found to be a 19 year old male and a 14 year old female. Detectives
 arrived and met with the subjects who stated they had entered into the activity
 consensually but due to the age of the female subject, the male subject was charged
 with sexual assault of a child.
- Detectives responded to several vehicle burglaries in the area of S. Kenazo. A witness was located who provided information on a single male subject seen in the area. Detectives and Officers speaking with the witness recognized the description of the subject as a known offender in the area. Detectives then conducted a follow up at the suspect's residence where they were granted entry and allowed to conduct a search. Detectives then located items taken from several of the vehicle burglaries inside the residence and the male suspect was ultimately arrested.
